AN ACT

- 1 Establishing the Pennsylvania International Trade Council and conferring powers and duties upon it.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Pennsylvania
- 7 International Trade Council Act.
- 8 Section 2. Declaration of policy.
- 9 The General Assembly finds and declares as follows:
- 10 (1) The development of international trade is vital to
- the maintenance and continued growth of a healthy economy for
- 12 this Commonwealth.
- 13 (2) An increase in exports from this Commonwealth would
- 14 benefit this Commonwealth and, ultimately, this Nation by
- improving the United States' balance of trade.
- 16 (3) Various states have utilized, or are preparing to
- 17 utilize, the resources of state governments to stimulate,

- 1 facilitate and promote international exports.
- 2 (4) Competition among businesses and countries will
- 3 endure and intensify as more countries seek to expand their
- 4 international export capacities.
- 5 (5) Financial assistance offered by the Federal
- 6 Government to small-size and medium-size exporters is
- 7 insufficient to meet the competition offered by foreign
- 8 countries.
- 9 (6) Small-size and medium-size companies seeking to
- 10 enter foreign markets face severe problems in obtaining
- 11 financing for their transactions.
- 12 (7) The Commonwealth has a responsibility to create
- employment opportunities by encouraging and stimulating the
- development of international export sales and markets by
- 15 Pennsylvania companies.
- 16 (8) This Commonwealth has a skilled labor force whose
- members produce manufactured and agricultural goods, high
- 18 technology services and other services. These services are
- 19 marketable in foreign countries.
- 20 Section 3. Definitions.
- 21 The following words and phrases when used in this act shall
- 22 have the meanings given to them in this section unless the
- 23 context clearly indicates otherwise:
- 24 "Council." The Pennsylvania International Trade Council
- 25 established under this act.
- 26 "Department." The Department of Commerce of the
- 27 Commonwealth.
- "Secretary." The Secretary of Commerce of the Commonwealth.
- 29 Section 4. Council.
- 30 (a) Establishment.--The Pennsylvania International Trade

Council is hereby established. 1 2 (b) Membership. -- The council shall consist of 15 members: 3 (1) Seven government members: 4 (i) Three executive members: 5 (A) The secretary. (B) The Secretary of Banking. 6 7 (C) The Secretary of Agriculture. 8 (ii) Four legislative members: 9 Two members of the House of Representatives. 10 One member shall be appointed by the Speaker of the 11 House of Representatives, and one member shall be 12 appointed by the Minority Leader. 13 Two members of the Senate. One member shall 14 be appointed by the President pro tempore, and one 15 member shall be appointed by the Minority Leader. 16 (2) Eight public members appointed by the Governor 17 subject to the consent of a majority of the members elected 18 to the Senate. At least one public member must be a 19 representative of a small-size to medium-size manufacturing 20 company. The remaining public members must be professionals in any of the following fields: 21 22 (i) Agriculture. 23 (ii) International banking and financial services. 24 (iii) Foreign trade zones. International trade associations. 25 (iv) (v) Industrial labor relations. 26 27 (vi) Export-related services. 28 (vii) Large corporate enterprise. 29 (viii) International transportation. 30 (ix) Private international law.

- 1 (x) International business education.
- 2 (c) Terms.--
- 3 (1) Executive members under subsection (b)(1)(i) shall
- 4 serve ex officio.
- 5 (2) Legislative members under subsection (b)(1)(ii)
- 6 shall serve terms of two years.
- 7 (3) The following apply to public members under
- 8 subsection (b)(2):
- 9 (i) For initial appointments:
- 10 (A) Two members shall serve terms of one year.
- 11 (B) Two members shall serve terms of two years.
- 12 (C) Two members shall serve terms of three
- 13 years.
- 14 (D) Two members shall serve terms of four years.
- 15 (ii) For subsequent appointments, each member shall
- serve a term of four years.
- 17 (iii) A member appointed to fill a vacancy shall be
- appointed in the same manner as the member being replaced
- 19 and shall serve the unexpired portion of the term of the
- 20 member being replaced.
- 21 (iv) A member may not serve more than two terms.
- 22 (d) Removal.--A public member who fails to attend three
- 23 consecutive meetings, unless excused for illness or a death in
- 24 the family, shall be removed from the council.
- 25 (e) Quorum.--Eight members of the council shall constitute a
- 26 quorum.
- 27 (f) Meetings and procedure. -- The council shall meet at least
- 28 every three months. The council may elect a chairperson and
- 29 other officers as necessary. The council may establish rules of
- 30 procedure.

- 1 (g) Compensation. -- Public members of the council shall serve
- 2 without compensation but shall be reimbursed for necessary
- 3 expenses incurred in the performance of their duties.
- 4 (h) Support. -- The department shall provide the council with
- 5 necessary staff and support services.
- 6 Section 5. Functions.
- 7 The council has the following powers and duties:
- 8 (1) Advise and consult with elected Commonwealth
- 9 officials in proposing initiatives aimed at enhancing the
- 10 Commonwealth's participation in international trade.
- 11 (2) Advise the Governor and the General Assembly on
- 12 policies concerning the Commonwealth's role in international
- 13 trade.
- 14 (3) Foster coordination and communication between the
- public sector and the private sector on the subject of
- 16 international trade.
- 17 (4) Evaluate the effectiveness of State and local
- 18 programs designed primarily to promote or assist
- 19 international trade and make recommendations for the
- 20 continued improvement of these programs.
- 21 (5) Make recommendations to the Governor concerning
- 22 pending Federal and State legislation likely to affect
- 23 Pennsylvania's participation in international trade.
- 24 (6) Publicize and promote, in cooperation and
- 25 consultation with the department, the importance of
- 26 international trade among the members of the business and
- 27 labor communities of this Commonwealth and among the general
- 28 public.
- 29 Section 6. Report.
- No later than June 30 of each year, the council shall report

- 1 to the Governor and to the General Assembly. The report shall
- 2 summarize the council's activities during the prior calendar
- 3 year and shall make recommendations for future action.
- 4 Section 7. Effective date.
- 5 This act shall take effect in 60 days.
