## AN ACT

1 2 3	Amending Title 24 (Education) of the Pennsylvania Consolidated Statutes, further providing for credited school service and for termination of annuities.

6	Section 1. Section 8302 of Title 24 of the Pennsylvania	
7	Consolidated Statutes is amended by adding a subsection to read:	
8	§ 8302. Credited school service.

10	(b.2) Credited service as retirement incentive	
11	Notwithstanding any provisions of this title to the contrary,	
12	for the period of July 1, <del>1992</del> 1993, to August 31, 1993, a	<
13	<u>member who is not an annuitant on July 1, <del>1992</del> 1993, who</u>	<
14	terminates school service between July 1, <del>1992</del> 1993, and August	<
15	<u>31, 1993, inclusive, who will be 55 years of age or older on</u>	
16	<u>August 31, 1993, with ten or more eligibility points, who files</u>	

<u>declares his intent to retire prior to April 1, 1993, PRIOR TO</u>
 <u>APRIL 1, 1993, DECLARES HIS INTENT TO RETIRE BETWEEN JULY 1,</u>
 <u>1993, AND AUGUST 31, 1993, shall be credited with an additional</u>
 <u>10% of their credited service.</u>

6 Section 2. Section 8346(a) of Title 24 is amended to read:
7 § 8346. Termination of annuities.

8 (a) General rule.--If an annuitant returns to school service 9 or enters State service and elects multiple service membership, 10 any annuity payable to him under this part shall cease and in 11 the case of an annuity other than a disability annuity the present value of such annuity, adjusted for full coverage in the 12 13 case of a joint coverage member who makes the appropriate back contributions for full coverage, shall be frozen as of the date 14 15 such annuity ceases. An annuitant who is credited with an additional 10% of membership service as provided in section 16 8302(b.1) (relating to credited school service) and who returns 17 18 to school service, except as provided in subsection (b) shall forfeit such credited service and shall have his frozen present 19 20 value adjusted as if his 10% retirement incentive had not been applied to his account. In the event that the cost-of-living 21 increase enacted December 18, 1979 occurred during the period of 22 23 such State or school employment, the frozen present value shall be increased, on or after the member attains superannuation age, 24 25 by the percent applicable had he not returned to service. \* \* \* 26

27 Section 3. This act shall take effect immediately.
