## AN ACT

- 1 Establishing within the Department of Health a commission for
- 2 the review of drug policy; imposing upon the commission
- 3 certain powers and duties; and making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Prescription
- 8 Drug Policy Review Commission Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Commission." The Prescription Drug Policy Review Commission
- 14 established in section 3.
- 15 "Department." The Department of Health of the Commonwealth.
- 16 Section 3. Commission.

- 1 (a) Establishment.--There is hereby established within the
- 2 department an advisory commission to be know as the Prescription
- 3 Drug Policy Review Commission.
- 4 (b) Members.--The commission shall be composed of the
- 5 following eleven members:
- 6 (1) The Secretary of Aging or his designee.
- 7 (2) The Secretary of Health or his designee.
- 8 (3) The Secretary of Public Welfare or his designee.
- 9 (4) A representative of the Pennsylvania Pharmaceutical
- 10 Association.
- 11 (5) A representative of the Pennsylvania Medical
- 12 Society.
- 13 (6) A representative of the Pennsylvania Association of
- 14 Retired Persons.
- 15 (7) One member appointed by the Governor.
- 16 (8) One member appointed by the President pro tempore of
- 17 the Senate.
- 18 (9) One member appointed by the Minority Leader of the
- 19 Senate.
- 20 (10) One member appointed by the Speaker of the House of
- 21 Representatives.
- 22 (11) One member appointed by the Minority Leader of the
- 23 House of Representatives.
- 24 (c) Appointees.--Members who are appointed under subsection
- 25 (b)(7) through (11), shall each be recognized experts in the
- 26 fields of health care economics and quality assurance, medicine,
- 27 pharmacology, pharmacy or prescription drug reimbursement and
- 28 shall serve a term of two years.
- 29 (d) Chairman.--Annually, at its first meeting, the
- 30 commission shall select a chairman from among its members.

- 1 (e) Vacancies. -- Vacancies shall be filled by the original
- 2 appointing authority for the remainder of the unexpired term.
- 3 (f) Meetings.--The commission shall meet a minimum of four
- 4 times a year.
- 5 (g) Expenses.--Members shall receive no compensation but
- 6 shall be entitled to reimbursement for all necessary and
- 7 reasonable expenses.
- 8 Section 4. Powers and duties.
- 9 The commission shall have the following powers and duties to:
- 10 (1) Note trends and changes in prices for prescription
- and nonprescription drugs in this Commonwealth and the
- 12 nation.
- 13 (2) Note the availability and affordability of
- 14 prescription drugs for various population groups in this
- 15 Commonwealth and the nation.
- 16 (3) Examine the accessibility and affordability of
- 17 public and private insurance programs for prescription drugs.
- 18 (4) Outline options which other states have explored to
- 19 contain the cost of pharmaceuticals for its residents.
- 20 (5) Outline options this Commonwealth should consider to
- 21 contain pharmaceutical costs for its residents.
- 22 (6) Note the effect of any Federal legislation passed
- 23 and how it would impact the cost of pharmaceuticals and the
- 24 pharmaceutical industry.
- 25 Section 5. Annual report.
- 26 The commission shall annually submit a report to the Governor
- 27 and the General Assembly. The report shall summarize the
- 28 commission's actions and findings conducted under section 4.
- 29 Section 6. Appropriation.
- The sum of \$25,000, or as much thereof as may be necessary,

- is hereby appropriated to the Department of Health for the 1
- 2 purposes of carrying out and implementing this act.
- 3 Section 7. Effective date.
- This act shall take effect in 60 days. 4
