9	Section 1. The Department of General Services, with the

L 4	THE CONSIDERATION OF \$1 the following land situate in the City	
L5	of Shamokin, Northumberland County, Pennsylvania, more	
L6	particularly described as follows, to wit:	
L7	Lots numbered two hundred fifty-nine (259) to two hundred	
L8	sixty-three (263), inclusively, in Block R, further identified	
9	as a part of T.M.#3-4-160, and Lots numbered two hundred eighty-

- 2 Block T, further identified as T.M.#3-4-165, all in the Fourth
- 3 Ward of Shamokin City, Pennsylvania.
- 4 Section 2. In addition, the Commonwealth quitclaims any
- 5 interest in Lots numbered two hundred seventy-seven (277) to two
- 6 hundred eighty-two (282), inclusively, in Block T, further
- 7 identified as T.M.#3-4-164, to the Housing Authority of the City
- 8 of Shamokin.
- 9 Section 3. The conveyance shall be made under and subject to
- 10 all easements, servitudes and rights of others, including, but
- 11 not confined to, rights of telephone, telegraph, water,
- 12 electric, sewer, gas or pipeline companies, as well as under and
- 13 subject to any interest, estates or tenancies vested in third
- 14 persons, whether or not appearing of record, for any portion of
- 15 the land.
- 16 Section 4. The deed of conveyance shall contain a clause
- 17 that the property conveyed shall be used for public purposes by
- 18 the Housing Authority of the City of Shamokin, COUNTY OF
- 19 NORTHUMBERLAND, and if at any time the Housing Authority COUNTY <-

- 20 OF NORTHUMBERLAND or its successor conveys the property or
- 21 permits the property to be used for any purpose other than those
- 22 specified in this section, the title to the property shall
- 23 immediately revert to and revest in the Commonwealth of
- 24 Pennsylvania.
- 25 Section 5. The deed of conveyance shall be approved as
- 26 provided by law and shall be executed by the Secretary of
- 27 General Services in the name of the Commonwealth of
- 28 Pennsylvania.
- 29 Section 6. Costs and fees incidental to the conveyance shall
- 30 be borne by the grantee.

1 Section 7. This act shall take effect immediately.
