AN ACT

- 1 Amending the act of March 1, 1974 (P.L.90, No.24), entitled "An act relating to the labeling, distribution, storage,
- transportation, use, application and disposal of pesticides
- 4 and devices; providing for registration and examination of
- such materials; the licensing of pesticide dealers and pest
- 6 management consultants and imposing penalties, " regulating
- 7 the application of pesticides by the Department of
- 8 Transportation; and further providing for prohibited acts.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Section 8 of the act of March 1, 1974 (P.L.90,
- 12 No.24), known as the Pennsylvania Pesticide Control Act of 1973,
- 13 is amended by adding a subsection to read:
- 14 Section 8. Prohibited Acts.--* * *
- 15 (u) No person shall remove, alter or deface, or conspire
- 16 with another person to remove, alter or deface, a sign posted
- 17 under section 18.1.
- 18 Section 2. The act is amended by adding a section to read:
- 19 Section 18.1. Application of Pesticides by Department of
- 20 Transportation. -- (a) The Department of Transportation or its

- 1 contracted pesticide applicators shall inform all roadside
- 2 property owners, both resident and nonresident, of a proposed
- 3 application of a pesticide along their property at least thirty
- 4 days prior to the proposed application.
- 5 (1) The notification shall include the date and time of the
- 6 spraying, the names of the pesticides to be used and the
- 7 <u>telephone number of the district roadside management specialist.</u>
- 8 (2) The notification shall be either by certified mail or by
- 9 personal notification. If personal notification is used, the
- 10 Department of Transportation must secure a signature from the
- 11 property owner, indicating that the property owner was informed.
- 12 (3) A property owner shall have the right to prohibit the
- 13 application of pesticides within one thousand feet of his
- 14 property, and a resident shall have the right to prohibit the
- 15 <u>application of pesticides within one thousand feet of his</u>
- 16 residence.
- 17 (i) Prohibition of the application of pesticides under this
- 18 clause shall be effected by notice to the Department of
- 19 Transportation's district roadside management specialist not
- 20 <u>less than ten days prior to the scheduled application.</u>
- 21 <u>(ii) The department's notification to owners and residents</u>
- 22 shall explain their right to prohibit pesticide application
- 23 under this clause.
- 24 (iii) The district roadside management specialist shall
- 25 <u>maintain a registry of all owners and residents who have</u>
- 26 prohibited application of pesticides under this clause. Prior to
- 27 applying pesticides, personnel of the Department of
- 28 Transportation or its contracted applicators shall consult the
- 29 registry to determine where pesticide application is prohibited.
- 30 (iv) Roadside maintenance along areas where the use of

- 1 pesticides has been prohibited under this clause shall make use
- 2 of nonchemical management methods.
- 3 (4) Any change in the date and time of a proposed
- 4 application of pesticides by the Department of Transportation or
- 5 its contracted applicators must conform to the notification
- 6 requirements of this subsection.
- 7 (b) The Department of Transportation shall post signs along
- 8 roadways that are scheduled to be sprayed no later than forty-
- 9 eight hours prior to the proposed spraying application.
- 10 (1) The signs shall be not less than eighteen inches by
- 11 twenty-four inches in size and shall contain the words "PennDOT
- 12 <u>Chemical Pesticide Spray Area."</u>
- 13 (2) Signs shall be placed at one-half-mile intervals along
- 14 the roadside which is scheduled for pesticide spraying.
- 15 (3) The first and last sign sites along the roadway to be
- 16 <u>sprayed shall include an additional sign, listing a telephone</u>
- 17 <u>number for public information, the names of the pesticides to be</u>
- 18 used and the date and time of the proposed spraying.
- 19 (4) Each sign will remain in place for no less than ten days
- 20 <u>following a chemical pesticide application.</u>
- 21 (c) (1) The Department of Transportation and its contracted
- 22 applicators shall have their spray vehicles posted with signs
- 23 containing the words "Chemical Pesticide Spraying Vehicle" in
- 24 <u>letters no less than two inches in height. The signs shall be</u>
- 25 posted on both sides of the vehicle.
- 26 (2) Each chemical pesticide spray vehicle and vehicles
- 27 transporting pesticides shall have the name of the chemicals
- 28 being used or transported clearly displayed on the dashboard of
- 29 the vehicle in order to enable emergency personnel to take
- 30 proper action in the event of an accident or leakage.

- 1 (d) No pesticide shall be applied unless it has a clearly
- 2 perceptible odor. The odor may either be from the pesticide
- 3 <u>itself or from one of the inert ingredients.</u>
- 4 (e) (1) No pesticide shall be applied within one thousand
- 5 feet of a lake, creek, stream, river or wetlands.
- 6 (2) No pesticide shall be applied within one thousand feet
- 7 of a household, school, institution, commercial business or
- 8 <u>publicly owned property.</u>
- 9 (3) No pesticide shall be applied within one thousand feet
- 10 of a domestic animal pasture, hayfield or crop field.
- 11 (4) Pesticides shall not be applied on days when wind
- 12 <u>conditions cause drift from the boundaries of the target</u>
- 13 roadside property or whenever wind speed is in excess of three
- 14 miles per hour.
- 15 (5) Pesticide spray vehicles shall not travel more than five
- 16 miles per hour to prevent wind drift from the motion of the
- 17 <u>vehicle or its possible combination with natural wind drift.</u>
- 18 (6) Pesticides shall not be mixed or combined for spraying.
- 19 A minimum ten-day period must elapse before application of a
- 20 <u>second pesticide in an area where a pesticide has been applied.</u>
- 21 (f) (1) Pesticide manufacturers shall provide the secretary
- 22 with a list of the active and inactive, or inert, ingredients of
- 23 <u>all pesticides used by the Department of Transportation and its</u>
- 24 <u>contracted applicators</u>.
- 25 (2) All information filed with the secretary relating to the
- 26 registration of pesticides, as provided for in this act, shall
- 27 be made available to the public to the extent that, in the
- 28 judgment of the secretary, the information will not reveal a
- 29 trade secret, as protected under this act. In addition, any
- 30 person shall have the right to receive the material safety data

- 1 sheet, as defined in section 2 of the act of October 5, 1984
- 2 (P.L.734, No.159), known as the Worker and Community Right-to-
- 3 Know Act, or a copy of the label for any chemical to which he
- 4 <u>may have been exposed</u>.
- 5 (3) A physician shall be able to obtain from the secretary a
- 6 list of the active and inactive, or inert, ingredients when
- 7 pesticide poisoning has occurred. The list will be provided to
- 8 <u>facilitate treatment and not to violate trade secret</u>
- 9 <u>information</u>.
- 10 (4) A Department of Transportation district roadside
- 11 management specialist shall not expend funds for roadside
- 12 spraying of pesticides without first providing a detailed cost
- 13 <u>analysis of all of the various alternatives to pesticide</u>
- 14 spraying for roadside management pertinent to his district which
- 15 <u>clearly indicates that roadside pesticide spraying is more cost</u>
- 16 <u>effective than any of the various alternatives for roadside</u>
- 17 management. The cost analysis shall include all of the
- 18 alternatives--organic, biological and mechanical--and shall
- 19 include a copy of the "Integrated Pest Management Plan"
- 20 pertinent to his district.
- 21 Section 3. This act shall take effect in 60 days.
