AN ACT

Amending the act of August 9, 1955 (P.L.323, No.130), entitled "An act relating to counties of the third, fourth, fifth, 3 sixth, seventh and eighth classes; amending, revising, consolidating and changing the laws relating thereto," 4 PROVIDING FOR THE ABOLITION OF JURY COMMISSIONERS; AND 5 6 further providing for contract procedures. The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. The introductory paragraph of subsection (h) of section 1802 of the act of August 9, 1955 (P.L.323, No.130), 10 11 known as The County Code, amended July 10, 1990 (P.L.379, 12 No.89), is amended to read: 13 SECTION 1. SECTION 401 OF THE ACT OF AUGUST 9, 1955 (P.L.323, NO.130), KNOWN AS THE COUNTY CODE, IS AMENDED BY 14 15 ADDING SUBSECTIONS TO READ: 16 SECTION 401. ENUMERATION OF ELECTED OFFICERS.--* * * 17 (D) THE OFFICE OF JURY COMMISSIONER MAY BE ABOLISHED AT THE 18 OPTION OF EACH COUNTY BY REFERENDUM, WHENEVER ELECTORS EQUAL TO

- 1 AT LEAST FIVE PER CENTUM OF THE HIGHEST VOTE CAST FOR ANY OFFICE
- 2 IN THE COUNTY AT THE LAST PRECEDING GENERAL ELECTION SHALL FILE
- 3 A PETITION WITH THE COUNTY BOARD OF ELECTIONS OF THE COUNTY, OR
- 4 THE GOVERNING BODY OF THE COUNTY ADOPTS, BY A MAJORITY VOTE, A
- 5 RESOLUTION TO PLACE SUCH A QUESTION ON THE BALLOT AND A COPY OF
- 6 THE RESOLUTION IS FILED WITH THE BOARD OF ELECTIONS OF THE
- 7 COUNTY FOR A REFERENDUM ON THE QUESTION OF ABOLISHING THE OFFICE
- 8 OF JURY COMMISSIONER.
- 9 (E) PROCEEDINGS UNDER THIS SECTION SHALL BE IN ACCORDANCE
- 10 WITH THE PROVISIONS OF THE ACT OF JUNE 3, 1937 (P.L.1333,
- 11 NO.320), KNOWN AS THE "PENNSYLVANIA ELECTION CODE."
- 12 SECTION 2. THE INTRODUCTORY PARAGRAPH OF SECTION 1802(H) OF
- 13 THE ACT, AMENDED JULY 10, 1990 (P.L.379, NO.89), IS AMENDED TO
- 14 READ:
- 15 Section 1802. Contract Procedures; Terms and Bonds;
- 16 Advertising for Bids.--* * *
- 17 (h) The contracts or purchases made by the commissioners
- 18 [involving an expenditure of over ten thousand dollars
- 19 (\$10,000)] which shall not require advertising [or], bidding or

- 22 SECTION 3. (A) THE OFFICE OF JURY COMMISSIONER SHALL
- 23 EXPIRE AT THE COMPLETION OF THE CURRENT JURY COMMISSIONERS'

- 25 (B) THE REFERENDUM PROVIDED IN SECTION 401(D) OF THE ACT
- 26 SHALL TAKE PLACE IN ANY YEAR IN WHICH THE OFFICE OF JURY
