## AN ACT

1 Providing for the observance of April 28 of each year as  
2 Workers' Memorial Day.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. Workers' Memorial Day.

6 (A) ESTABLISHMENT.--In recognition of the courage and <—  
7 integrity of Pennsylvania's labor force and calling for  
8 vigilance in workplace safety, the Governor shall annually issue  
9 a proclamation designating April 28 as Workers' Memorial Day and  
10 recommending that this day be observed in an appropriate manner  
11 by the citizens of Pennsylvania.

12 (B) RESTRICTIONS.-- <—

13 (1) NO COSTS MAY BE INCURRED WITH REGARD TO THE

1 OBSERVANCE OF WORKERS' MEMORIAL DAY BY THE COMMONWEALTH, A  
2 POLITICAL SUBDIVISION OR AN AGENCY OR INSTRUMENTALITY OF  
3 EITHER.

4 (2) WORKERS' MEMORIAL DAY SHALL BE REGARDED AS A SECULAR  
5 OR BUSINESS DAY. THE OBSERVANCE OF THIS DAY MAY NOT BE THE  
6 SUBJECT OF A COLLECTIVE BARGAINING AGREEMENT TO WHICH THE  
7 COMMONWEALTH, A POLITICAL SUBDIVISION OR AN AGENCY OR  
8 INSTRUMENTALITY OF EITHER IS A PARTY.

9 Section 2. Effective date.

10 This act shall take effect immediately.
