AN ACT

- 1 Providing for a voluntary contribution system to fund a homeless
- 2 prevention activities program; establishing a special fund;
- 3 imposing powers and duties on the Department of Public
- 4 Welfare and the Department of Revenue; and making a repeal.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Legislative declaration.
- 8 The General Assembly hereby finds that there is a growing
- 9 number of persons in this Commonwealth who lack the resources
- 10 and the community ties necessary to provide for their own
- 11 adequate shelter and who are likely to become homeless without
- 12 community assistance. The General Assembly recognizes that women
- 13 and children are the fastest growing group of the homeless and
- 14 that a large percentage of the total homeless population
- 15 consists of families. The General Assembly therefore finds that
- 16 it is beneficial to the Commonwealth to fund prevention
- 17 activities programs to assist families and other persons who are
- 18 likely to become homeless without some community assistance;

- 1 that this act is enacted to provide a means by which such
- 2 programs may be financed through a voluntary contribution
- 3 designation on State income tax return forms; and that it is
- 4 desirable to encourage residents of this Commonwealth to
- 5 designate the amount of such contribution to help fund such
- 6 prevention activities programs on their State income tax return
- 7 forms.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Public Welfare of the
- 13 Commonwealth.
- 14 "Homeless prevention activities program." A community-based
- 15 or community-oriented program which is operated by a
- 16 nongovernmental agency and established pursuant to the criteria
- 17 set forth in section 3 to assist in preventing families and
- 18 other persons from becoming homeless.
- 19 "Nongovernmental agency." Any private nonprofit agency or
- 20 nonprofit corporation.
- "Unit of local government." A county, city, borough,
- 22 incorporated town or township, or a home rule municipality
- 23 formerly classified as a county, city, borough, incorporated
- 24 town or township.
- 25 Section 3. Homeless prevention activities programs.
- 26 (a) Criteria. -- A homeless prevention activities program
- 27 established pursuant to this act shall provide, but need not be
- 28 limited to:
- 29 (1) Assistance in avoiding eviction and foreclosure from
- 30 an apartment or home.

- 1 (2) Counseling for families and persons to prevent them 2 from becoming homeless.
- 3 (3) Mediation services to assist persons in avoiding eviction and foreclosures.
- 5 (4) Programs that assist persons who are in danger of 6 becoming homeless in obtaining services and information.
- 7 (5) Referrals to and assistance in obtaining job 8 training, job counseling or information about job openings.
- 9 (b) Requirements.--At least one-half of all voluntary
- 10 contributions made to the Homeless Prevention Activities Program
- 11 Fund pursuant to section 6 shall be used for direct or financial
- 12 benefit to individuals in this Commonwealth who are homeless or
- 13 in danger of becoming homeless; except that no funds shall be
- 14 expended for direct cash payment to homeless persons or persons
- 15 who are in danger of becoming homeless.
- 16 (c) Evaluation and report. -- The department shall evaluate
- 17 the homeless prevention activities programs which are funded
- 18 pursuant to this act and shall report and make recommendations
- 19 to the General Assembly within 180 days of the effective date of
- 20 this act.
- 21 Section 4. Contracts with department; rules and regulations.
- 22 (a) Authorization.--The department may enter into contracts
- 23 or agreements for services with any nongovernmental agency which
- 24 has established and which operates a homeless prevention
- 25 activities program or with a unit of local government or
- 26 nongovernmental agency which has subcontracted with a
- 27 nongovernmental agency for homeless prevention activities
- 28 services.
- 29 (b) Priorities.--In making contracts or agreements, the
- 30 department shall give priority to those homeless prevention

- 1 activities programs which provide services to or design their
- 2 programs for assistance to families with children and other
- 3 persons who, without assistance, are in danger of becoming
- 4 homeless. The department shall also distribute funds by the use
- 5 of an allocation formula based on the number of homeless per
- 6 capita, the number of unemployed persons and the unemployment
- 7 rate in a particular community or region.
- 8 (c) Standards.--The department shall promulgate rules and
- 9 regulations establishing and enforcing standards for all
- 10 homeless prevention activities programs established pursuant to
- 11 this act, including the allocation formula specified in
- 12 subsection (b), and shall require that each homeless prevention
- 13 activities program meets approved minimum standards.
- 14 (d) Coordination and oversight. -- The department shall
- 15 promulgate rules and regulations governing this program which
- 16 assure that the funds collected pursuant to section 6 are
- 17 allocated to nongovernmental agencies, either directly or
- 18 through the coordination and oversight of units of local
- 19 government, for use for direct client services and assistance.
- 20 Section 5. Funding of homeless prevention activities programs.
- 21 (a) Reimbursement. -- Any nongovernmental agency operating a
- 22 homeless prevention activities program pursuant to this act
- 23 shall, subject to available appropriations, be reimbursed by the
- 24 department from moneys which may be appropriated for that
- 25 purpose by the General Assembly, but in no event shall the
- 26 Commonwealth reimbursements or disbursements exceed 100% of the
- 27 revenue provided by local contributions or sources other than
- 28 Commonwealth funds.
- 29 (b) Administrative expenses. -- The department may use that
- 30 portion of the Homeless Prevention Activities Program Fund as

- 1 may be necessary for staffing and administrative expenses of the
- 2 department in carrying out the provisions of this act.
- 3 (c) Matching funds.--It is the intent of the General
- 4 Assembly that any funds generated by the contribution of cash
- 5 funds to the Homeless Prevention Activities Program Fund may be
- 6 used to match funds available, if any, from the Federal
- 7 Government, local governments, the private sector and nonprofit
- 8 organizations for the purpose of assisting homeless persons.
- 9 Section 6. Voluntary contribution system.
- 10 (a) Space on tax form. -- The Department of Revenue shall
- 11 provide a space on the face of the Pennsylvania individual
- 12 income tax return form whereby an individual may voluntarily
- 13 designate a contribution of any amount desired to the Homeless
- 14 Prevention Activities Program Fund established in section 7.
- 15 (b) Deduction from refund. -- The amount designated by an
- 16 individual on the income tax return form shall be deducted from
- 17 the tax refund to which the individual is entitled and shall not
- 18 constitute a charge against the income tax revenues due the
- 19 Commonwealth.
- 20 (c) Annual transfer.--The Department of Revenue shall
- 21 determine annually the total amount designated pursuant to this
- 22 section and shall report such amount to the State Treasurer, who
- 23 shall transfer such amount from the General Fund to the Homeless
- 24 Prevention Activities Program Fund. The Department of Revenue
- 25 shall be reimbursed from the Homeless Prevention Activities
- 26 Program Fund for any administrative costs incurred above and
- 27 beyond the cost savings it realizes as a result of individual
- 28 total refund designations.
- 29 (d) Information. -- The Department of Revenue shall provide
- 30 adequate information concerning the Homeless Prevention

- 1 Activities Program Fund in its instructions which accompany
- 2 State income tax return forms, which shall include the listing
- 3 of an address to which contributions may be sent by those
- 4 taxpayers wishing to contribute to the fund but who do not
- 5 receive refunds.
- 6 (e) Applicability. -- This section shall apply to taxable
- 7 years beginning on or after the effective date of this act.
- 8 Section 7. Homeless Prevention Activities Program Fund.
- 9 (a) Creation.--In order to carry out the purposes of this
- 10 act, there is hereby created a special fund, which shall be
- 11 known as the Homeless Prevention Activities Program Fund.
- 12 (b) Deposit into fund.--All moneys received from the
- 13 voluntary contribution system established in section 6 shall be
- 14 deposited in the fund.
- 15 (c) Additional appropriations. -- The General Assembly may,
- 16 from time to time, appropriate funds into the special fund for
- 17 the purposes of this act.
- 18 (d) Continuing appropriation. -- The moneys contained in the
- 19 fund are continuously appropriated to the Department of Public
- 20 Welfare for the purpose of carrying out the purposes of this
- 21 act.
- 22 Section 8. Repeal.
- 23 Section 12 of the act of June 23, 1982 (P.L.597, No.170),
- 24 known as the Wild Resource Conservation Act, is repealed insofar
- 25 as it is inconsistent with this act.
- 26 Section 9. Effective date.
- 27 This act shall take effect July 1 of the year immediately
- 28 succeeding the year of enactment.
