- 11 (B) HELMET TO BE LABELED. -- ANY HELMET SOLD OR OFFERED FOR
- 12 SALE FOR USE BY OPERATORS AND PASSENGERS OF PEDALCYCLES SHALL BE
- 13 CONSPICUOUSLY LABELED IN ACCORDANCE WITH THE STANDARD DESCRIBED
- 14 <u>IN SUBSECTION (A), WHICH SHALL CONSTITUTE THE MANUFACTURER'S</u>
- 15 CERTIFICATION THAT THE HELMET CONFORMS TO THE APPLICABLE SAFETY
- 16 STANDARDS.
- 17 (B.1) SALE OF HELMET.--NO PERSON SHALL SELL OR OFFER FOR
- 18 SALE FOR USE BY AN OPERATOR OR PASSENGER OF A PEDALCYCLE A
- 19 HELMET WHICH IS NOT OF A TYPE MEETING THE REQUIREMENTS
- 20 ESTABLISHED BY THIS SECTION.
- 21 (B.2) WAIVER OF FINE. -- IF A PERSON RECEIVES A CITATION
- 22 ISSUED BY THE PROPER AUTHORITY FOR VIOLATION OF SUBSECTION (A),
- 23 A DISTRICT JUSTICE, MAGISTRATE OR JUDGE SHALL DISMISS THE
- 24 CHARGES IF THE PERSON PRIOR TO OR AT HIS HEARING DISPLAYS
- 25 EVIDENCE OF ACQUISITION OF A HELMET MEETING THE STANDARDS
- 26 PRESCRIBED IN SUBSECTION (A) TO SUCH DISTRICT JUSTICE,
- 27 MAGISTRATE OR JUDGE. SUFFICIENT EVIDENCE SHALL INCLUDE A RECEIPT
- 28 MAILED TO THE APPROPRIATE COURT OFFICER WHICH EVIDENCES PURCHASE
- 29 OR TRANSFER OF SUCH A HELMET FROM ANOTHER HELMET OWNER,
- 30 EVIDENCED BY A NOTARIZED LETTER.

- 1 (c) Civil actions. -- In no event shall a violation or alleged
- 2 violation of subsection (a) be used as evidence in a trial of
- 3 any civil action; nor shall any jury in a civil action be
- 4 instructed that any conduct did constitute or could be
- 5 interpreted by them to constitute a violation of subsection (a);
- 6 nor shall failure to use a pedalcycle helmet be considered as
- 7 contributory negligence nor shall failure to use a pedalcycle
- 8 helmet be admissible as evidence in the trial of any civil
- 9 action.
- 10 (d) Penalty. -- Notwithstanding any other provisions of law,
- 11 any violation of subsection (a) is punishable by a fine,
- 12 including all penalties, assessments and court costs imposed on
- 13 the convicted person not to exceed \$25. [Persons age 17 and
- 14 under shall not be subject to the penalty provisions of this
- 15 subsection on the first offense.] THE COURT IMPOSING AND
- 16 <u>COLLECTING ANY SUCH FINES SHALL TRANSFER THE FINES THUS</u>
- 17 COLLECTED TO THE STATE TREASURER FOR DEPOSIT IN THE PEDALCYCLE
- 18 HELMET FUND, PURSUANT TO SECTION 3512 (RELATING TO PEDALCYCLE
- 19 HELMET FUND). THE PARENT OR LEGAL GUARDIAN HAVING CONTROL OR
- 20 CUSTODY OF A PERSON UNDER 12 YEARS OF AGE WHOSE CONDUCT VIOLATES
- 21 THIS SECTION SHALL BE JOINTLY AND SEVERALLY LIABLE WITH THE
- 22 PERSON FOR THE AMOUNT OF THE FINE IMPOSED.
- 23 (e) Definitions.--As used in this section, the term "wearing
- 24 a <u>PEDALCYCLE</u> helmet" means having a <u>PEDALCYCLE</u> helmet of good
- 25 fit fastened securely upon the head with the helmet straps.
- 26 SECTION 2. TITLE 75 IS AMENDED BY ADDING SECTIONS TO READ: <-

- 27 § 3512. PEDALCYCLE HELMET FUND.
- 28 THE PEDALCYCLE HELMET FUND IS ESTABLISHED IN THE GENERAL FUND
- 29 AS A SPECIAL RESTRICTED RECEIPTS ACCOUNT EARMARKED FOR AND
- 30 APPROPRIATED TO THE DEPARTMENT OF TRANSPORTATION. THIS FUND

- 1 SHALL CONSIST OF ALL FINES DEPOSITED PURSUANT TO SECTION 3510
- 2 (RELATING TO PEDALCYCLE HELMETS FOR CERTAIN PERSONS), ALL
- 3 FEDERAL FUNDS GRANTED FOR SUCH USE AND ANY MONEY DONATED TO THE
- 4 FUND. ALL MONEY IN THE PEDALCYCLE HELMET FUND SHALL BE USED
- 5 SOLELY FOR THE PURPOSE OF PURCHASING PEDALCYCLE HELMETS MEETING
- 6 THE STANDARDS OF THE AMERICAN NATIONAL STANDARDS INSTITUTE OR OF
- 7 THE SNELL MEMORIAL FOUNDATION'S STANDARDS FOR PROTECTIVE
- 8 HEADGEAR FOR USE IN BICYCLING AND MAKING SUCH HELMETS AVAILABLE
- 9 TO QUALIFIED LOANER PROGRAMS WITHIN THIS COMMONWEALTH. A
- 10 QUALIFIED LOANER PROGRAM SHALL BE ONE DETERMINED BY THE
- 11 <u>DEPARTMENT TO LEND APPROVED PEDALCYCLE HELMETS TO PARENTS OR</u>
- 12 LEGAL GUARDIANS OF CHILDREN UNDER 12 YEARS OF AGE WHO, DUE TO
- 13 FINANCIAL OR ECONOMIC HARDSHIP, ARE UNABLE TO COMPLY WITH THE
- 14 PROVISIONS OF SECTION 3510. THE DEPARTMENT SHALL ADOPT SUCH
- 15 REGULATIONS AS ARE NECESSARY TO EFFECTUATE THE PURPOSE OF THIS
- 16 SECTION.
- 17 § 3513. CIVIL IMMUNITY FOR LENDERS OF PEDALCYCLE HELMETS.
- 18 NO PERSON OR ORGANIZATION WHO OR WHICH LENDS TO ANOTHER
- 19 PERSON OR ORGANIZATION A PEDALCYCLE HELMET, AS DESCRIBED IN
- 20 <u>SECTION 3510 (RELATING TO PEDALCYCLE HELMETS FOR CERTAIN</u>
- 21 PERSONS), SHALL BE LIABLE FOR ANY CIVIL DAMAGES RESULTING FROM
- 22 ANY ACT OR OMISSION, EXCEPT ANY ACT OR OMISSION INTENTIONALLY
- 23 DESIGNED TO HARM OR ANY GROSSLY NEGLIGENT ACT OR OMISSION
- 24 RESULTING IN HARM TO ANOTHER.
- 25 Section  $\frac{2}{3}$ . This act shall take effect in 60 days.
