A JOINT RESOLUTION

- 1 Proposing amendments to the Constitution of the Commonwealth of
- 2 Pennsylvania, limiting terms of members; and providing for a
- 3 referendum on reelection of members.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendments to the Constitution of
- 7 Pennsylvania are proposed in accordance with Article XI:
- 8 (1) That section 3 of Article II be amended to read:
- 9 § 3. Terms of members.
- 10 Senators shall be elected for the term of four years and
- 11 Representatives for the term of two years. Consecutive terms of
- 12 office for each Senator or Representative shall not exceed eight
- 13 years unless authorized by referendum.
- 14 (2) That Article II be amended by adding a section to read:
- 15 § 18. Referendum on reelection of members.
- 16 A member of the Senate or House of Representatives who has
- 17 completed eight years of legislative service may be a candidate

- 1 for reelection to the same political office if a majority of
- 2 voters in their legislative or senatorial district by referendum
- 3 permit the member to be a candidate for that office. The
- 4 referendum that shall be placed on the ballot during the general
- 5 election of the year preceding the year when the member will
- 6 <u>complete eight years of service shall read:</u>
- 7 Senator or Representative (fill in name) will have
- 8 <u>completed eight years of legislative service as your</u>
- 9 <u>Senator or Representative for the (fill in number)</u>
- district at the completion of next year's general
- 11 <u>election on (fill in date). Under Pennsylvania law,</u>
- 12 Senator or Representative (fill in name) may not be a
- candidate for the office of State Senator or
- Representative unless a majority of voters in this
- senatorial or legislative district permit him or her to
- be a candidate for reelection to this office. If a
- 17 majority of voters of this senatorial or legislative
- district vote to allow him or her to run for this office
- in next year's election, then he or she will be permitted
- to place his or her name on the ballot as a candidate for
- 21 reelection to this office for additional four two-year
- 22 terms or two four-year terms. Based on this law, please
- answer the following question:
- 24 <u>Should Senator or Representative (fill in name) be</u>
- 25 <u>permitted to be a candidate for reelection to the</u>
- office of Senator or Representative in next year's
- 27 election if he or she chooses?
- 28 Section 2. Service in the General Assembly, whether the
- 29 service constitutes a full term of office or a partial term of
- 30 office, performed prior to the effective date of the amendment

- 1 proposed in section 1 shall not be considered in determining the
- 2 maximum number of consecutive full terms a senator or
- 3 representative may serve or in determining eligibility of a
- 4 senator or representative for election.
