AN ACT

- 1 Providing for a jobs impact statement on all legislation and
- 2 regulations; and imposing duties on the Attorney General and
- 3 the Department of Commerce.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Jobs Impact
- 8 Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Department." The Department of Commerce of the
- 14 Commonwealth.
- 15 Section 3. Responsibility of department.
- 16 (a) Bills.--The department shall prepare a jobs impact
- 17 statement on all proposed legislation introduced in either house

- 1 of the General Assembly. The jobs impact statement shall be
- 2 forwarded to the committee of the Senate or House of
- 3 Representatives which has jurisdiction of the bill within 60
- 4 days of its introduction.
- 5 (b) Regulations.--
- 6 (1) The department shall prepare a jobs impact statement
- on all regulations proposed in the Pennsylvania Bulletin on
- 8 all regulations for which proposed rulemaking is omitted
- 9 under section 204 of the act of July 31, 1968 (P.L.769,
- 10 No.240), referred to as the Commonwealth Documents Law.
- 11 (2) The jobs impact statement shall be forwarded to the
- designated standing committees reviewing the regulation under
- 13 section 5 of the act of June 25, 1982 (P.L.633, No.181),
- 14 known as the Regulatory Review Act:
- 15 (i) for proposed regulations, by the end of the
- 16 public comment period; and
- 17 (ii) for regulations for which notice of proposed
- 18 rulemaking is omitted under section 204 of the
- 19 Commonwealth Documents Law, within 15 calendar days of
- 20 submission of the regulation to the Attorney General
- 21 under section 204(b) of the act of October 15, 1980
- 22 (P.L.950, No.164), known as the Commonwealth Attorneys
- 23 Act.
- 24 Section 4. Content of jobs impact statement.
- 25 The jobs impact statement shall contain the following
- 26 information:
- 27 (1) An estimate of the number of jobs in this
- 28 Commonwealth which the department believes would be affected
- if the bill were enacted into law.
- 30 (2) An analysis of the effect of the proposed

- 1 legislation on jobs in this Commonwealth, including
- 2 suggestions for ameliorating any negative effect.
- 3 Section 5. Public information.
- 4 The jobs impact statement shall be public information and
- 5 shall be made available to the public and the press.
- 6 Section 6. Attorney General.
- When the Attorney General receives, under section 204(b) of
- 8 the act of October 15, 1980 (P.L.950, No.164), known as the
- 9 Commonwealth Attorneys Act, a regulation for which proposed
- 10 rulemaking is omitted pursuant to the act of July 31, 1968
- 11 (P.L.769, No.240), referred to as the Commonwealth Documents
- 12 Law, the Attorney General shall forward a copy of the regulation
- 13 to the department.
- 14 Section 7. Effective date.
- 15 This act shall take effect in 60 days.
