AN ACT

- 1 Providing for time frames for clearance actions affecting
- 2 environmental permits.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Environmental
- 7 Permit Clearance Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Clearance." A determination by a clearing agency that a
- 13 proposed action will not adversely impact upon a resource
- 14 protected by the clearing agency.
- 15 "Clearing agency." Any of the following:
- 16 (1) The Pennsylvania Fish and Boat Commission.
- 17 (2) The Pennsylvania Game Commission.

- 1 (3) The Pennsylvania Historical and Museum Commission.
- 2 "Department." The Department of Environmental Resources of
- 3 the Commonwealth.
- 4 Section 3. Clearance.
- If a permit under a statute for the protection of the
- 6 environment is dependent upon a clearance, the following shall
- 7 apply:
- 8 (1) Within 30 days of receipt of a request for
- 9 clearance, the clearing agency must make a determination of
- 10 whether a study is required to issue the clearance. Failure
- 11 to act within the time specified in this paragraph shall be
- deemed a determination that no study is necessary.
- 13 (2) If a study is required under paragraph (1), the
- 14 clearing agency:
- (i) shall pay for the study; and
- 16 (ii) must complete the study within 60 days.
- 17 (3) Regardless of whether a study is required under
- paragraph (1), within 90 days of a receipt of a request for
- 19 clearance, the clearing agency must issue a clearance or a
- 20 statement that there is no clearance. Failure to act within
- 21 the time specified in this paragraph shall be deemed the
- 22 issuance of a clearance.
- 23 Section 4. Repeals.
- 24 All acts and parts of acts are repealed insofar as they are
- 25 inconsistent with this act.
- 26 Section 5. Applicability.
- 27 For purposes of section 3, clearances pending on the
- 28 effective date of this act shall be deemed requested on the
- 29 effective date of this act.
- 30 Section 6. Effective date.

1 This act shall take effect in 60 days.
