-		carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated AND FOR CERTAIN FISCAL INFORMATION DISCLOSURE.

20 The General Assembly of the Commonwealth of Pennsylvania

21 hereby enacts as follows:

22 Section 1. The following sums, or as much thereof as may be 23 necessary, are hereby appropriated to the Trustees of the 24 University of Pittsburgh for the fiscal year July 1, 1994, to 25 June 30, 1995, for the purposes and in the amounts as shown:

1 (1) For educational and general expenses..... \$123,511,000 (2) For instruction - Doctor of Medicine only. 6,239,000 2 3 (3) For operation of dental clinics in the 4 school of dentistry..... 1,030,000 5 (4) To enhance the recruitment and retention of disadvantaged students..... 321,000 6 7 (5) For general maintenance and operation of 8 the Western Psychiatric Institute and Clinic..... 7,693,000 9 (6) For the teen suicide center at the Western Psychiatric Institute and Clinic..... 497,000 10 FOR THE GRADUATE SCHOOL OF PUBLIC HEALTH.. 11 250,000 (7) <-----300,000 (8) FOR RURAL EDUCATION OUTREACH..... 12 13 Section 2. Payments to the University of Pittsburgh on 14 account of the appropriations for all items as provided in 15 section 1 shall be made on the basis of costs during the fiscal 16 year.

17 Section 3. If necessary, the University of Pittsburgh may 18 transfer funds between the appropriations listed in section 1(1) 19 and (2), provided that the aggregate amount transferred into or 20 out of each appropriation during the fiscal year shall not 21 exceed 5% of the amount specifically appropriated for that 22 purpose.

23 Section 4. (a) Payments to the University of Pittsburgh of 24 the appropriations provided in section 1 shall be made monthly 25 during the fiscal year.

(b) Such monthly payments shall be made in accordance with
the provisions of section 2 on the basis of estimated costs. The
estimate of costs shall be submitted by the University of
Pittsburgh to the Secretary of Education, the General Assembly
and the State Treasurer not later than 30 days prior to the date

1 on which such payment is to be made.

Section 5. (a) The University of Pittsburgh shall apply the 2 3 moneys appropriated by this act only for such purposes as are 4 permitted in this act and shall at all times maintain proper 5 records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act 6 7 relates, the University of Pittsburgh shall file, with the Secretary of Education, the General Assembly, the Auditor 8 General of the Commonwealth and the chief administrator of each 9 10 branch campus, a statement setting forth the amounts and 11 purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, 12 13 as provided in section 2, used as a basis for receipt of any 14 appropriation during said fiscal year.

15 (b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he 16 17 shall have the right, in respect to the moneys appropriated by 18 this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered 19 20 and paid by the University of Pittsburgh to the State Treasurer. 21 In respect to expenditures made by the university from moneys 22 other than those appropriated by this act, the Auditor General 23 shall have the right to review only, and he shall file annually 24 with the General Assembly such information concerning such 25 expenditures as the General Assembly or any of its committees 26 may require.

27 Section 6. A report shall be submitted to the Governor and 28 the Appropriations and Education Committees of the Senate and 29 House of Representatives and shall include data for all 30 programs, except for the Doctor of Medicine program. The report, 19940H2792B3948 - 3 - 1 to be submitted prior to September 1, 1995, shall cover the 12-2 month period beginning with the summer term 1994 and shall 3 include:

4 (1) The following counts and distributions for each term5 during the period:

6 (i) The definitions and numbers of faculty members employed 7 full time, of faculty members employed part time, of full-time 8 students enrolled in graduate courses, of full-time students 9 enrolled in undergraduate courses, of part-time students 10 enrolled in graduate courses and of part-time students enrolled 11 in undergraduate courses.

12 (ii) The total numbers of undergraduate student credit 13 hours, divided into lower division and upper division course 14 levels, and of graduate student credit hours, divided into three 15 course levels--master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of
instruction and the number of sections of individual instruction
scheduled by level of instruction, each further subdivided by
two-digit Classification of Instructional Program (CIP)
categories of instructional programs of higher education as
defined by the National Center for Education Statistics, United
States Department of Education.

23 The number of terms scheduled and the dates thereof. (iv) 24 (2) For the summer term and the following academic year in 25 total and for each two-digit CIP program category, a classification of faculty members or other professional 26 27 employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, 28 29 librarian and academic administrator; faculty members or other 30 professional employees under each title to be subdivided by type 19940H2792B3948 - 4 -

of assignment: teaching and nonteaching; and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time; and the following aggregates for each such subdivided

6 (i) The number of faculty and other professional employees

9 (ii) The sum of credits assigned to undergraduate classroom 10 courses and the sum of credits assigned to graduate classroom 11 courses taught, divided into lower division, upper division, 12 master's, first professional and doctoral course levels.

13 (iii) The sum of credits assigned to undergraduate 14 individual instruction courses and the sum of credits assigned 15 to graduate individual instruction courses taught, divided into 16 lower division, upper division, master's, first professional and 17 doctoral course levels.

18 (iv) The sum of undergraduate classroom student credit hours 19 and the sum of graduate classroom student credit hours 20 generated, divided into lower division, upper division, 21 master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.

1 (3) For each term of the period covered for each faculty 2 member employed full time identified by two-digit CIP program 3 category and title, the report shall contain an analysis of the 4 average hours per week spent in university-related activities, 5 stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in 6 7 preparation, hours spent in research and hours spent in public 8 service.

9 Section 7. In addition to the requirements in section 6 10 relative to this appropriation, the report covering the 12-month 11 period beginning with the summer term 1994 shall include for all 12 programs of the university:

13 (1) Minimum number of credits required for a baccalaureate14 degree and for a master's degree.

15 (2) Number of bachelor's degrees, master's degrees, first
16 professional degrees and doctoral degrees awarded in 1991, 1992,
17 1993, 1994 and estimated 1995.

8 (4) A STATEMENT OF THE UNIVERSITY'S RETIREMENT POLICIES.

10 FOR EMPLOYEES' FAMILY MEMBERS.

11 (6) A LIST OF PURCHASE OF SERVICE CONTRACTS WHICH EXCEED 12 \$1,000 BY CATEGORY OF SERVICE, INCLUDING, BUT NOT LIMITED TO, 13 LEGAL, INSTRUCTIONAL, MANAGEMENT, ACCOUNTING, ARCHITECTURE, PUBLIC RELATIONS AND MAINTENANCE. THE LIST SHALL CONTAIN THE 14 15 NAME AND ADDRESS OF THE CONTRACTOR, A STATEMENT OF THE NATURE OF 16 THE DUTIES OF THE CONTRACTOR AND THE ACADEMIC AND ADMINISTRATIVE SUPPORT UNIT FOR WHICH THE DUTIES ARE PERFORMED. IF A PURCHASE 17 18 OF SERVICE CONTRACT EXCEEDS 10% OF THE TOTAL AGGREGATE 19 EXPENDITURE OF THE CONTRACT CATEGORY PER ACADEMIC OR 20 ADMINISTRATIVE SUPPORT UNIT, THEN THE CONTRACTED AMOUNT SHALL 21 ALSO BE LISTED.

22 (7) A LIST OF PURCHASE OF GOODS CONTRACTS WHICH EXCEED \$1,000. THE LIST SHALL CONTAIN THE NAME AND ADDRESS OF THE 23 CONTRACTOR AND A LIST OF THE GOODS PURCHASED AND THE ACADEMIC OR 24 25 ADMINISTRATIVE SUPPORT UNIT FOR WHICH SUCH GOODS WERE 26 CONTRACTED. IF A PURCHASE OF GOODS CONTRACT EXCEEDS 10% OF THE 27 TOTAL AGGREGATE EXPENDITURE PER ACADEMIC OR ADMINISTRATIVE 28 SUPPORT UNIT, THEN THE CONTRACTED AMOUNT SHALL ALSO BE LISTED. 29 (8) A LIST BY ACADEMIC OR ADMINISTRATIVE SUPPORT UNIT IN THE 30 AGGREGATE, OF THE EXPENSES OF TRAVEL, SUBSISTENCE AND LODGING, 19940H2792B3948 - 8 -

2 (D) THE UNIVERSITY SHALL SUBMIT A REPORT OF THE INFORMATION 3 UNDER SUBSECTIONS (B) AND (C) TO THE EDUCATION COMMITTEE OF THE 4 SENATE AND THE APPROPRIATIONS COMMITTEE OF THE SENATE AND THE 5 EDUCATION COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE 6 APPROPRIATIONS COMMITTEE OF THE HOUSE OF REPRESENTATIVES. IN 7 ADDITION, THE UNIVERSITY SHALL SUBMIT A COPY OF THE REPORT TO 8 EACH OF THE FOLLOWING:

9 (1) GOVERNOR'S OFFICE.

10 (2) SECRETARY OF EDUCATION.

11 (3) STATE TREASURER.

12 (4) AUDITOR GENERAL.

13 (5) JOINT STATE GOVERNMENT COMMISSION.

14 EACH SUCH INSTITUTION SHALL MAINTAIN A COPY OF THE REPORT IN THE 15 INSTITUTION'S LIBRARY AND SHALL SUBMIT A COPY TO EACH OF THE 16 FOUR STATE REGIONAL LIBRARY RESOURCE CENTERS.

17 (E) A UNIVERSITY'S REPORT REQUIRED TO BE SUBMITTED UNDER
18 THIS SECTION SHALL BE SUBMITTED WITHIN 180 DAYS OF THE CLOSE OF
19 THE UNIVERSITY'S CURRENT FISCAL YEAR.

20 (F) THE JOINT STATE GOVERNMENT COMMISSION SHALL DEVELOP A 21 STATISTICAL COMPARISON ANALYSIS RECOGNIZING DIFFERENCES IN 22 MISSIONS FROM THE REPORTS MADE UNDER THIS SECTION. A MAJORITY OF 23 THE MEMBERS OF THE COMMISSION MAY REQUEST ADDITIONAL 24 DOCUMENTATION, EXCEPT FOR SALARY OR IDENTITY OF INDIVIDUALS, 25 NECESSARY TO COMPLETE THE COMPARATIVE ANALYSIS. THE COMPARISON 26 SHALL BE PROVIDED TO THE EDUCATION COMMITTEE OF THE SENATE AND 27 THE APPROPRIATIONS COMMITTEE OF THE SENATE AND THE EDUCATION 28 COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE APPROPRIATIONS 29 COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE FOUR STATE 30 REGIONAL LIBRARIES.

The University of Pittsburgh shall provide 7 full, complete and accurate information as may be required by 8 the Department of Education or the majority chairman or the 9 minority chairman of the Appropriations Committee of the Senate 10 or the majority chairman or the minority chairman of the 11 Appropriations Committee of the House of Representatives. 12 Section 9 10. The University of Pittsburgh shall report its 13 revenues and expenditures and present its financial statements 14 required under the provisions of this act in accordance with 15 generally accepted accounting principles and procedures for 16 educational institutions as set forth in the "Higher Education 17 Finance Manual, United States Department of Health, Education 18 and Welfare (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-19 20 Related Universities and Non-State-Related Colleges and Universities." 21
