A RESOLUTION

- l Memorializing Congress to enact legislation to address the
 - disparities in Social Security benefits for "Notch Year
- 3 Babies."
- 4 WHEREAS, In 1972 Congress changed the formula to calculate
- 5 Social Security benefits in order to provide for cost-of-living
- 6 increases. The formula used resulted in over-compensation, and
- 7 benefits increased by more than the rate of inflation; and
- 8 WHEREAS, Since this continued over-compensation would have
- 9 drained the Social Security funds, Congress amended the Social
- 10 Security Act benefits formula in 1977. Those who where born
- 11 between 1917 and 1921 were caught in the transition period and
- 12 were termed "Notch Year Babies." Those born after 1921 received
- 13 benefits under the new law; and
- 14 WHEREAS, The result was that those born between 1917 and 1921

- 1 received lower benefits than those born prior to 1917 and
- 2 slightly higher benefits than those born after 1921; and
- 3 WHEREAS, This is an important issue with many senior citizens
- 4 who are "Notch Year Babies"; and
- 5 WHEREAS, This method of compensation is inequitable to those
- 6 born after 1917; and
- WHEREAS, Persons born after 1917 have served this country in
- 8 World War II and have contributed immeasurably to the growth and
- 9 development of America; therefore be it
- 10 RESOLVED, That the House of Representatives memorialize
- 11 Congress to address and correct the inequities of Social
- 12 Security benefit payments for those born before 1917 and those
- 13 born after 1917; and be it further
- 14 RESOLVED, That copies of this resolution be transmitted to
- 15 the presiding officers of each house of Congress and to each
- 16 member of Congress from Pennsylvania.
