## A RESOLUTION

- 1 Memorializing the President and Congress to maintain or increase 2 funding for the Low-Income Home Energy Assistance Program.
- 3 WHEREAS, The Low-Income Home Energy Assistance Program served
- 4 over 500,000 households in this Commonwealth for the 1992-1993
- 5 program year; and
- 6 WHEREAS, This program helps people in rural and urban areas
- 7 alike; and
- 8 WHEREAS, This program helps senior citizens and families with
- 9 small children; and
- 10 WHEREAS, This is one of the few programs available to the
- 11 working poor; and
- 12 WHEREAS, Weatherization-efforts funding through this program
- 13 has helped to reduce energy bills for low-income customers and

- 1 has also helped to conserve energy; and
- 2 WHEREAS, Federal funding for this program has been steadily
- 3 decreasing since 1985; and
- 4 WHEREAS, The demand for this program, however, has been
- 5 steadily increasing; therefore be it
- 6 RESOLVED, That the House of Representatives of the
- 7 Commonwealth of Pennsylvania memorialize Congress and the
- 8 President to fund the Low-Income Home Energy Assistance Program
- 9 at a level greater than the funding level for the 1992-1993
- 10 program year; and be it further
- 11 RESOLVED, That the House of Representatives memorialize
- 12 Congress and the President to further maintain or increase
- 13 funding for weatherization programs which help to conserve
- 14 energy and decrease energy bills of low-income customers; and be
- 15 it further
- 16 RESOLVED, That copies of this resolution be transmitted to
- 17 the President and presiding officers of each house of Congress
- 18 and to each member of Congress from Pennsylvania as an
- 19 indication of the sentiment of this legislative body for
- 20 Congress to reject all proposals to cut funding for the Low-
- 21 Income Home Energy Assistance Program.
