A RESOLUTION

1 Designating October 24 through 30, 1993, as "Consumers Week" in
2 Pennsylvania.

3 WHEREAS, The President of the United States has proclaimed
4 the week of October 24 through 30, 1993, as "National Consumers
5 Week"; and

6 WHEREAS, A major function of our competitive free market
7 system is to satisfy consumer demand; and

8 WHEREAS, All Pennsylvania citizens are consumers of goods and
9 services in trade or commerce within the world, the United
10 States and the Commonwealth; and

11 WHEREAS, Consumers should have access to a wide variety of
12 competitively priced goods and services produced here and abroad
13 and to accurate information on product content and care,
14 contractual obligations, cost of credit and all information

1 necessary to make informed purchase decisions; and

2 WHEREAS, The active cooperation of educators, business,
3 government and consumers working together can fuel our free
4 market economy; and

5 WHEREAS, "National Consumers Week" will promote dissemination
6 of sound consumer information by both public and private
7 sectors, including the media, on subjects such as complaint
8 handling and on public policy issues which affect consumers;
9 will encourage dialogue and cooperation among consumers,
10 business and government; and will broaden the scope of consumer
11 and economic education by heightening consumer awareness that we
12 function in a world market and by acknowledging that our
13 interdependence extends far beyond the boundaries of the United
14 States; therefore be it

15 RESOLVED, That the House of Representatives designate the
16 week of October 24 through 30, 1993, as "Consumers Week" in
17 Pennsylvania.
