16	The General Assembly of the Commonwealth of Pennsylvania	
17	hereby enacts as follows:	
18	Section 1. Section 1 of the act of June 24, 1976 (P.L.424,	<
19	No.101), referred to as the Emergency and Law Enforcement	
20	Personnel Death Benefits Act, amended October 16, 1981 (P.L.295,	
21	No.102), is amended to read:	
22	<u>Section 1. (a) In the event a law enforcement officer,</u>

23	ambulance service or rescue squad member or firefighter is	

killed in the performance of his duties, such political 1 subdivision within 30 days from the date of death shall submit 2 3 certification of such death to the Commonwealth. A volunteer 4 firefighter shall be deemed to be acting in the performance of 5 his duties for the purposes of this act going to or directly returning from a fire which the fire company or fire department 6 attended including travel from and direct return to a 7 firefighter's home, place of business or other place where he or 8 she shall have been when he or she received the call or alarm or 9 10 while participating in instruction fire drills in which the fire 11 department or fire company shall have participated or while 12 repairing or doing other work about or on the fire apparatus or 13 buildings and grounds of the fire company or fire department 14 upon the authorization of the chief of the fire company or fire 15 department or other person in charge or while answering any 16 emergency calls for any purpose or while riding upon the fire 17 apparatus which is owned or used by the fire company or fire 18 department or while performing any other duties of such fire 19 company or fire department as authorized by the municipality or 20 while performing duties imposed by section 15, act of April 27, 21 1927 (P.L.465, No.299), referred to as the Fire and Panic Act. A 22 volunteer ambulance service or rescue squad member shall be 23 deemed to be acting in the performance of his duties for the 24 purposes of this act going to or directly returning from an 25 emergency which the ambulance service or rescue squad attended 26 including travel from and direct return to an ambulance service 27 or rescue squad member's home, place of business or other place 28 where he or she shall have been when he or she received the call 29 or alarm or while participating in drills in which the ambulance 30 service or rescue squad shall have participated or while - 2 -

repairing or doing other work about or on any emergency vehicle 1 or buildings and grounds of the ambulance service or rescue 2 3 squad upon the authorization of the chief of the ambulance 4 service or rescue squad or other person in charge while 5 answering any emergency calls for any purpose or while riding upon any vehicles which are owned or used by the ambulance 6 7 service or rescue squad. Upon receipt of such certification, the Commonwealth shall, from moneys payable out of the General Fund, 8 pay to the political subdivision the sum of [\$25,000] <u>\$100,000</u>. 9 10 Within five days of receipt of said sum from the Commonwealth, 11 the political subdivision shall pay such sum as a benefit to the surviving spouse, or if there is no surviving spouse, to the 12 13 minor children of the firefighter, ambulance service or rescue 14 squad member or law enforcement officer killed in the 15 performance of duty. When no spouse or minor children survive, 16 the benefit shall be paid to the parent or parents of such firefighter, ambulance service or rescue squad member or law 17 18 enforcement officer. 19 (b) The Commonwealth of Pennsylvania shall pay out of the 20 General Fund to the surviving spouse, or, if there is no 21 surviving spouse, the minor children of a State police officer 22 or other law enforcement officer of the Commonwealth killed in 23 the performance of his duties the sum of [\$25,000] <u>\$100,000</u>. 24 When no spouse or minor children survive, the benefit shall be 25 paid to the parent or parents of such State police officer or 26 other law enforcement officer of the Commonwealth. The benefit 27 shall be payable whether or not the officer was killed within 28 the Commonwealth of Pennsylvania. 29 SECTION 1. 10 SECTION 1. <u>(A)</u> IN THE EVENT A LAW ENFORCEMENT OFFICER, 11 AMBULANCE SERVICE OR RESCUE SQUAD MEMBER [OR], FIREFIGHTER OR 12 <u>HAZARDOUS MATERIAL RESPONSE TEAM MEMBER</u> IS KILLED IN THE 13 PERFORMANCE OF HIS DUTIES, SUCH POLITICAL SUBDIVISION WITHIN 30 14 DAYS FROM THE DATE OF DEATH SHALL SUBMIT CERTIFICATION OF SUCH 15 DEATH TO THE COMMONWEALTH.

5 (C) A VOLUNTEER AMBULANCE SERVICE OR RESCUE SOUAD MEMBER SHALL BE DEEMED TO BE ACTING IN THE PERFORMANCE OF HIS DUTIES 6 FOR THE PURPOSES OF THIS ACT GOING TO OR DIRECTLY RETURNING FROM 7 8 AN EMERGENCY WHICH THE AMBULANCE SERVICE OR RESCUE SOUAD 9 ATTENDED INCLUDING TRAVEL FROM AND DIRECT RETURN TO AN AMBULANCE 10 SERVICE OR RESCUE SQUAD MEMBER'S HOME, PLACE OF BUSINESS OR 11 OTHER PLACE WHERE HE OR SHE SHALL HAVE BEEN WHEN HE OR SHE RECEIVED THE CALL OR ALARM OR WHILE PARTICIPATING IN DRILLS IN 12 13 WHICH THE AMBULANCE SERVICE OR RESCUE SQUAD SHALL HAVE 14 PARTICIPATED OR WHILE REPAIRING OR DOING OTHER WORK ABOUT OR ON 15 ANY EMERGENCY VEHICLE OR BUILDINGS AND GROUNDS OF THE AMBULANCE 16 SERVICE OR RESCUE SQUAD UPON THE AUTHORIZATION OF THE CHIEF OF 17 THE AMBULANCE SERVICE OR RESCUE SQUAD OR OTHER PERSON IN CHARGE 18 WHILE ANSWERING ANY EMERGENCY CALLS FOR ANY PURPOSE OR WHILE 19 RIDING UPON ANY VEHICLES WHICH ARE OWNED OR USED BY THE 20 AMBULANCE SERVICE OR RESCUE SQUAD.

10 (D) UPON RECEIPT OF SUCH CERTIFICATION, THE COMMONWEALTH 11 SHALL, FROM MONEYS PAYABLE OUT OF THE GENERAL FUND, PAY TO THE POLITICAL SUBDIVISION THE SUM OF [\$25,000.] <u>\$50,000, ADJUSTED IN</u> 12 13 <u>ACCORDANCE WITH SUBSECTION (F) (E) OF THIS SECTION.</u> WITHIN FIVE <----14 DAYS OF RECEIPT OF SAID SUM FROM THE COMMONWEALTH, THE POLITICAL 15 SUBDIVISION SHALL PAY SUCH SUM AS A BENEFIT TO THE SURVIVING 16 SPOUSE, OR IF THERE IS NO SURVIVING SPOUSE, TO THE MINOR 17 CHILDREN OF THE FIREFIGHTER, AMBULANCE SERVICE OR RESCUE SQUAD 18 MEMBER, HAZARDOUS MATERIAL RESPONSE TEAM MEMBER OR LAW <-----19 ENFORCEMENT OFFICER KILLED IN THE PERFORMANCE OF DUTY.
