30The Philadelphia Municipal Court shall consist of [22] 2519950H0037B0035- 3 -

1 judges.

Section 2. (a) Except as provided in subsections (b), (c) and (d), the vacancies created by the new judgeships added by the amendment of 42 Pa.C.S. §§ 911(a) and 1121 shall be filled by election at the first municipal election occurring after the effective date of this act.

7 (b) The two vacancies created by the new judgeships added to 8 the second, fifth and fifteenth districts respectively by the 9 amendment of 42 Pa.C.S. § 911(a) shall be filled by election as 10 follows: one shall be filled at the first municipal election 11 occurring after the effective date of this act and one shall be 12 filled at the second municipal election occurring after the 13 effective date of this act.

14 (c) The vacancy created by the new judgeship added to the 15 eighth district by the amendment of 42 Pa.C.S. § 911(a) shall be 16 filled at the municipal election occurring in 1997.

(d) The election of newly created judgeships for Montgomery Rounty, the thirty-eighth district shall be for two judges to be elected in 1995 and two judges to be elected in 1997, in each respective municipal election.

21 Section 3. This act shall take effect immediately.
