## AN ACT

Amending Titles 24 (Education) and 71 (State Government) of the Pennsylvania Consolidated Statutes, providing for special 2 3 supplemental postretirement adjustments. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 5 6 Section 1. Title 24 of the Pennsylvania Consolidated 7 Statutes is amended by adding a section to read: § 8348.4. Special supplemental postretirement adjustment. 8 9 (a) Eligibility. -- An annuitant who: (1) retired after October 1, 1975, and before December 10 11 31, 1984; 12 (2) has military service as set forth in section 13 8304(b)(1) or (2) (relating to creditable nonschool service); 14 (3) is receiving or will receive retirement pay under 10 15 U.S.C. Ch. 67 (relating to retired pay for nonregular service) for this military service; and 16 (4) has not purchased nonschool service credit for this 17

- 2 <u>shall be eliqible for this special supplemental postretirement</u>
- 3 <u>adjustment</u>.
- 4 (b) Calculation of adjustment. -- The monthly amount of this
- 5 special supplemental postretirement adjustment shall be equal to
- 6 the final average salary multiplied by 2% multiplied by the
- 7 years of this military service divided by 12 multiplied by any
- 8 applicable early retirement or option factors.
- 9 (c) Adjustment paid.--Upon receipt of a timely request by an
- 10 eligible annuitant, the system shall pay this special
- 11 <u>supplemental postretirement adjustment monthly from the</u>
- 12 <u>effective date of this section.</u>
- 13 (d) Adjustment enacted after death of annuitant. -- No special
- 14 supplemental postretirement adjustment enacted after the death
- 15 of an annuitant shall be payable to the beneficiary or survivor
- 16 <u>annuitant of the deceased annuitant.</u>
- (e) Future supplemental annuities.--This special
- 18 supplemental postretirement adjustment shall be included in the
- 19 total annuity, and this military service shall be included in
- 20 the total credited service in determining all future
- 21 <u>supplemental annuities</u>.
- 22 (f) Time limitations.--An annuitant who is eligible for this
- 23 special supplemental postretirement adjustment shall have two
- 24 years from the effective date of this section within which to
- 25 <u>make a request to the system for the adjustment established in</u>
- 26 this section.
- 27 (q) Court-ordered purchase of nonschool service. -- If a court
- 28 of competent jurisdiction rules that an annuitant who is
- 29 receiving or will receive retirement pay under 10 U.S.C. Ch. 67
- 30 for this military service is eligible under section 8304(b)(1)

- 1 or (2) to purchase nonschool service credit for this military
- 2 <u>service</u>, this <u>special</u> <u>supplemental</u> <u>postretirement</u> <u>adjustment</u>
- 3 shall stop with the annuitant's purchase of nonschool service
- 4 <u>credit for this military service</u>, and the total amount of this
- 5 special supplemental postretirement paid to the annuitant from
- 6 the effective date of this section shall be subtracted from any
- 7 increase in the annuity caused by the court-ordered purchase of
- 8 nonschool service credit for this military service.
- 9 Section 2. Title 71 is amended by adding a section to read:
- 10 § 5708.4. Special supplemental postretirement adjustment.
- 11 (a) Eligibility. -- An annuitant who:
- 12 (1) retired after February 28, 1974, and before December
- 13 <u>31, 1984;</u>
- 14 (2) has military service as set forth in section
- 15 <u>5304(c)(1) or (2) (relating to creditable nonstate service);</u>
- 16 (3) is receiving or will receive retirement pay under 10
- 17 U.S.C. Ch. 67 (relating to retired pay for nonregular
- 18 service) for this military service; and
- 19 (4) has not purchased nonstate service credit for this
- 20 <u>military service;</u>
- 21 <u>shall be eligible for this special supplemental postretirement</u>
- 22 adjustment.
- 23 (b) Calculation of adjustment.--The monthly amount of this
- 24 special supplemental postretirement adjustment shall be equal to
- 25 the final average salary multiplied by 2% multiplied by the
- 26 years of this military service divided by 12 multiplied by any
- 27 applicable early retirement or option factors.
- 28 (c) Adjustment paid. -- Upon receipt of a timely request by an
- 29 <u>eligible annuitant, the system shall pay this special</u>
- 30 supplemental postretirement adjustment monthly from the

- 1 effective date of this section.
- 2 (d) Adjustment enacted after death of annuitant. -- No special
- 3 <u>supplemental postretirement adjustment enacted after the death</u>
- 4 of an annuitant shall be payable to the beneficiary or survivor
- 5 <u>annuitant of the deceased annuitant.</u>
- 6 (e) Future supplemental annuities. -- This special
- 7 <u>supplemental postretirement adjustment shall be included in the</u>
- 8 total annuity, and this military service shall be included in
- 9 the total credited service in determining all future
- 10 <u>supplemental annuities</u>.
- 11 (f) Time limitations. -- An annuitant who is eliqible for this
- 12 special supplemental postretirement adjustment shall have two
- 13 years from the effective date of this section within which to
- 14 make a request to the system for the adjustment established in
- 15 this section.
- 16 (q) Court-ordered purchase of nonstate service.--If a court

- 22 shall stop with the annuitant's purchase of nonstate service
- 23 credit for this military service, and the total amount of this
- 24 special supplemental postretirement adjustment paid to the
- 25 annuitant from the effective date of this section shall be
- 26 <u>subtracted from any increase in the annuity caused by the court</u>
- 27 ordered purchase of nonstate service credit for this military
- 28 service.
- 29 Section 3. This act shall be retroactive to January 1, 1974.
- 30 Section 4. This act shall take effect immediately.
