AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, further providing for counties to
- 3 furnish certified copies of documents without charge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 9201(a) of Title 51 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 9201. Certified copies of documents furnished without charge.
- 9 (a) General rule. -- Whenever application shall be made to the
- 10 proper county officer by or on behalf of any disabled war
- 11 veteran, or member of the armed forces or their reserve
- 12 components or the National Guard, of any war or armed conflict
- 13 in which the United States has been, is now or shall hereafter
- 14 be engaged, or by or on behalf of any dependent of any such
- 15 veteran, or member of the armed forces, for a certified copy of

- 1 any death certificate, birth certificate, marriage certificate
- 2 or decree of divorce, for use in connection with any claim for
- 3 death benefits, compensation allowance, family or dependency
- 4 allotment, it shall be the duty of such county officer to
- 5 furnish such certified copy free of any charge therefor provided
- 6 for by any law of this Commonwealth. No divorce certificate
- 7 shall be issued under this section unless said divorce action
- 8 record shows all costs fully paid.

- 10 Section 2. This act shall take effect in 60 days.
