AN ACT

- Amending the act of May 2, 1945 (P.L.382, No.164), entitled "An 2 act providing for the incorporation as bodies corporate and 3 politic of "Authorities" for municipalities, counties and 4 townships; prescribing the rights, powers and duties of such Authorities heretofore or hereafter incorporated; authorizing such Authorities to acquire, construct, improve, maintain and 6 7 operate projects, and to borrow money and issue bonds 8 therefor; providing for the payment of such bonds, and prescribing the rights of the holders thereof; conferring the 9 right of eminent domain on such Authorities; authorizing such 10 Authorities to enter into contracts with and to accept grants 11 12 from the Federal Government or any agency thereof; and 13 conferring exclusive jurisdiction on certain courts over rates, " further providing for the removal of authority 14 15 members.
- 16 The General Assembly of the Commonwealth of Pennsylvania
- 17 hereby enacts as follows:
- 18 Section 1. Subsection B of section 7 of the act of May 2,
- 19 1945 (P.L.382, No.164), known as the Municipality Authorities
- 20 Act of 1945, amended July 27, 1953 (P.L.639, No.185), is amended
- 21 to read:
- 22 Section 7. Governing Body.--* * *
- 23 B. Members shall hold office until their successors have
- 24 been appointed, and may succeed themselves, and, except members

- 1 of the boards of Authorities organized or created by a school
- 2 district or school districts, shall receive such salaries as may
- 3 be determined by the governing body or bodies of the
- 4 municipality or municipalities, but none of such salaries shall
- 5 be increased or diminished by such governing body or bodies
- 6 during the term for which the member receiving the same shall
- 7 have been appointed. Members of the board of any Authority
- 8 organized or created by a school district or school districts
- 9 shall receive no compensation for their services, but the
- 10 members of such board in office on the effective date of this
- 11 amendment shall continue to receive their salaries during the
- 12 remainder of their existing term. A member may be removed for
- 13 cause by the [court of quarter sessions of the county in which
- 14 the Authority is located after having been provided with a copy
- 15 of the charges against him for at least ten days and full
- 16 hearing by the court] governing body of the appointing
- 17 <u>municipality or municipalities</u>. If a vacancy shall occur by
- 18 reason of the death, disqualification, resignation or removal of
- 19 a member, the municipal authorities shall appoint a successor to
- 20 fill his unexpired term. In joint Authorities such vacancies
- 21 shall be filled by the municipal Authorities of the municipality
- 22 in the representation of which the vacancy occurs. Whenever any
- 23 municipality shall withdraw from a joint Authority the term of
- 24 any member or members appointed from such municipality shall
- 25 immediately terminate.

- 27 Section 2. This act shall take effect in 60 days.
