A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, further providing for oaths of office.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby resolves as follows:
- 5 Section 1. The following amendment to the Constitution of
- 6 Pennsylvania is proposed in accordance with Article XI:
- 7 That section 3 of Article VI be amended to read:
- 8 § 3. Oath of office.
- 9 Senators, Representatives and all judicial, State and county
- 10 officers shall, before entering on the duties of their
- 11 respective offices, take and subscribe the following oath or
- 12 affirmation before a person authorized to administer oaths.
- "I do solemnly swear (or affirm) that I will support, obey
- 14 and defend the Constitution of the United States and the
- 15 Constitution of this Commonwealth and that I will discharge the

- 1 duties of my office with fidelity."
- 2 The oath or affirmation shall be administered to a member of
- 3 the Senate or to a member of the House of Representatives in the
- 4 hall of the House to which he shall have been elected[.] when
- 5 that House is in session. If the House has not returned to
- 6 session since the issuance of a certificate of election for a
- 7 special election and the deadline for filing an election contest
- 8 has expired, a justice or a judge may administer the oath of
- 9 office to a member-elect of the Senate or House anywhere in this
- 10 <u>Commonwealth if the member-elect presents an election</u>
- 11 <u>certificate and an affidavit stating that the special election</u>
- 12 <u>is not the subject of a judicial challenge and stating that the</u>
- 13 <u>member-elect has provided the offices of the presiding officer</u>
- 14 and the minority leader with at least 48 hours' written notice
- 15 of the date and location of the taking of the oath of office and
- 16 the name of the judge or justice administering the oath. The
- 17 member elected in such special election may be sworn and
- 18 qualified outside the presence of the presiding officer, and the
- 19 taking of the oath shall qualify such member as a Senator or
- 20 Representative. Nothing in this section shall preclude each
- 21 House from subsequently judging the election or qualifications
- 22 of such member.
- 23 Any person refusing to take the oath or affirmation shall
- 24 forfeit his office.
