## AN ACT

- 1 Requiring nursing homes to submit information annually to the
- 2 Department of Health; and providing for certain duties of the
- 3 Department of Health and the Department of Aging.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Nursing Home
- 8 Consumer Information Law.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Consumer Information Guide." The Nursing Home Consumer
- 14 Information Guide required to be published under the provisions
- 15 of this act.
- 16 "Elderly persons." Those persons residing within this
- 17 Commonwealth who are 60 years of age or older.
- 18 "Nursing home." A facility that provides either skilled or

- 1 intermediate nursing care or both levels of such care to two or
- 2 more elderly persons, who are unrelated to the licensee, for a
- 3 period exceeding 24 hours. Intermediate care facilities
- 4 exclusively for the mentally retarded, commonly called ICF/MR
- 5 shall not be considered nursing homes for the purpose of this
- 6 act.
- 7 Section 3. Nursing Home Consumer Information Report.
- 8 In addition to the information required by the Department of
- 9 Health on a form provided by the Department of Health pursuant
- 10 to the provisions of the act of July 19, 1979 (P.L.130, No.48),
- 11 known as the Health Care Facilities Act, and regulations
- 12 promulgated pursuant thereto, each nursing home shall provide to
- 13 the Department of Health no later than 90 days after the close
- 14 of each calendar year the following information on the above-
- 15 referenced form:
- 16 (1) Nursing hours worked per patient per day and nursing
- 17 hours required by the Department of Health per patient per
- 18 day. Actual hours worked per patient per day are for the most
- 19 recently concluded fiscal or calendar year.
- 20 (2) Average length of service of professional nursing
- 21 staff and the average length of service of nurse aide
- 22 personnel at the nursing home completing the form.
- 23 (3) Average length of licensure and/or certification of
- 24 professional nursing staff and the average length of
- licensure and/or certification of nurse aide personnel.
- 26 (4) Nursing hours per patient per day of temporary
- agency professional nursing staff and nurse aide personnel.
- 28 (5) Whether a resident council exists and meets on a
- 29 regular basis.
- 30 Section 4. Nursing home consumer information.

- 1 (a) Guide.--
- 2 (1) The Department of Aging shall produce, in a timely
- 3 manner, an annual Nursing Home Consumer Guide. It shall
- 4 include:
- 5 (i) The items listed in section 3.
- 6 (ii) Information obtained from the annual Long-Term
- 7 Care Facilities Questionnaires submitted to the
- 8 Department of Health.
- 9 (iii) Information obtained from the Health Care
- 10 Financing Administration Ownership Disclosure Form.
- 11 (iv) A comparative list of nursing homes developed
- in the manner provided in subsection (b).
- 13 (v) The Nursing Home Consumer Inquiry Hotline
- telephone number required under subsection (c).
- 15 (2) If errors are found in the Nursing Home Consumer
- 16 Guide, all facilities shall be sent a correction sheet within
- 30 days of the Department of Aging's receipt of notification
- of the error. For the purposes of this section, an error
- shall be defined as information incorrectly transcribed from
- 20 the forms provided to the Department of Health to the
- 21 consumer guide.
- 22 (3) The Department of Aging will send final proofs to
- 23 the nursing home of its data profile that will be published
- in the consumer guide prior to publication. The nursing home
- will have five days to notify the Department of Aging of any
- 26 errors to be corrected. If the Department of Aging receives
- 27 no notification of errors, the data profile will be
- considered accurate and will be published.
- 29 (b) Comparative list.--The comparative list of nursing homes
- 30 shall be developed and included in the Consumer Information

- 1 Guide by the Department of Aging. It shall include the following
- 2 information:
- 3 (1) Name of facility.
- 4 (2) Facility address and phone number.
- 5 (3) Bed capacity.
- 6 (4) Owner of facility and managing company, if
- 7 applicable.
- 8 (5) Type of sponsorship, including, but not limited to,
- 9 governmental, nonprofit and for-profit.
- 10 (6) Payment sources accepted, including, but not limited
- 11 to, Medicare, Medicaid, Veterans' Administration, long-term
- 12 care insurance and private pay.
- 13 (7) Current license, deficiency and certification status
- as determined by the Department of Health; whether, within
- the previous five years, the facility has been subject to a
- provisional license, a ban on admissions, penalties imposed
- in connection with the licensure or certification process, a
- 18 license revocation or appointment of a temporary manager to
- 19 operate the facility or Medicare or Medicaid decertification
- and the corresponding dates.
- 21 (8) Nursing hours per patient per day and nursing hours
- 22 required by the Department of Health per patient per day.
- 23 Actual hours worked per patient per day are for the most
- 24 recently concluded fiscal or calendar year.
- 25 (9) Average length of service at the nursing home of
- 26 professional nursing staff and the average length of service
- of nurse aide staff.
- 28 (10) Average length of licensure and/or certification of
- 29 professional nursing staff and the average length of
- 30 licensure and/or certification of nurse aide personnel.

- 1 (11) Nursing hours per patient per day of temporary
- 2 agency professional nursing staff and nurse aide personnel.
- 3 (12) A listing of existence and availability of specific
- 4 therapy services, including, but not limited to, physical
- 5 therapy, occupational therapy, speech therapy and respiratory
- 6 therapy.
- 7 (13) Whether a resident council exists and meets on a
- 8 regular basis.
- 9 (14) Name and telephone number of a local ombudsman.
- 10 (c) Nursing Home Consumer Inquiry Telephone Hotline. -- The
- 11 Department of Aging shall establish a Statewide telephone number
- 12 to serve as the Nursing Home Consumer Inquiry Telephone Hotline.
- 13 This number shall be a toll-free number. The purpose of this
- 14 telephone number is to respond to calls regarding the current
- 15 licensure, deficiency and certification status of nursing homes.
- 16 All data provided by the hotline shall be updated each week
- 17 using information provided by the Department of Health in a
- 18 timely fashion. This telephone number shall be prominently
- 19 displayed in the annual Nursing Home Consumer Guide.
- 20 (d) Disclosure.--The State Long-Term Care Ombudsman in the
- 21 Department of Aging shall mail at least one copy of the Nursing
- 22 Home Consumer Information Guide to the local long-term care
- 23 ombudsman of each area agency on aging, to each nursing home and
- 24 to the Pennsylvania Council on Aging annually.
- 25 (e) Availability.--Each nursing home shall post next to its
- 26 Department of Health license an exact copy of its listing as
- 27 found in the Consumer Information Guide. A nursing home shall
- 28 provide to each prospective resident and family member of such
- 29 prospective resident who visits the facility, or any member of
- 30 the public upon request, during normal business or visiting

- 1 hours, Sunday through Saturday, an exact copy of its listing as
- 2 set forth in the Consumer Information Guide.
- 3 (f) Inspections.--The Department of Health shall verify the
- 4 availability of the listing during annual licensing surveys. The
- 5 Department of Health shall monitor compliance with the
- 6 requirements of this act for regular filing of the Long-Term
- 7 Care Facilities Questionnaire with the Department of Health.
- 8 (g) Update.--The Department of Health shall issue
- 9 modifications to the Long-Term Care Facilities Questionnaire
- 10 resulting from changes in the reimbursement system for nursing
- 11 homes. Such modifications shall provide the same information in
- 12 an updated format.
- 13 (h) Regulations.--The Department of Aging shall promulgate
- 14 regulations setting forth proposed additions, changes, or both,
- 15 if the department does any of the following:
- 16 (1) Expands the scope of the consumer guide beyond those
- topics expressly set forth in subsection (a).
- 18 (2) Expands the scope of the comparative list beyond
- 19 those topics expressly set forth in subsection (b).
- 20 (3) Expands the scope of any topic expressly set forth
- in subsection (a) or (b).
- 22 Section 5. Complaints.
- 23 Complaints of noncompliance with this act shall be filed with
- 24 the Department of Aging. A complainant shall include a local
- 25 ombudsman, a nursing home employee, a nursing home resident, a
- 26 prospective nursing home resident, or any person representing
- 27 the interests of a nursing home resident or prospective nursing
- 28 home resident.
- 29 Section 6. Additional consumer information.
- 30 Each nursing home shall provide to each prospective resident

- 1 or representative thereof at the time of initial inquiry, a
- 2 companion consumer guide which describes how to select a nursing
- 3 home. This information can be either a publication of the
- 4 Department of Aging, a camera-ready copy of a publication
- 5 provided by the Department of Aging or a comparable publication
- 6 that will inform the consumer on how to choose a nursing home.
- 7 Section 7. Penalties.
- 8 The Department of Aging shall have the authority to assess a
- 9 \$1,000 civil penalty for each violation of this act. Any person
- 10 aggrieved by an adjudication by the Department of Aging shall
- 11 have the right to appeal pursuant to 42 Pa.C.S. (relating to
- 12 judiciary and judicial procedure).
- 13 Section 8. Repeals.
- 14 All acts and parts of acts are repealed insofar as they are
- 15 inconsistent with this act.
- 16 Section 9. Effective date.
- 17 This act shall take effect in 90 days.
