AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for use of farm vehicle plates by
- 3 extending the privilege to Christmas tree farmers.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1344 of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 1344. Use of farm vehicle plates.
- 9 (a) General rule.--A truck or truck tractor bearing farm
- 10 vehicle registration plates shall be used exclusively upon a
- 11 farm or farms owned or operated by the registrant of the vehicle
- 12 or upon highways between:
- 13 (1) Parts of one such farm.
- 14 (2) Such farms.
- 15 (3) Such a farm or farms and a place of business for the
- 16 purpose of buying or selling agricultural commodities or

- 1 supplies.
- 2 (4) Such place of business, if transported to the place
- of business pursuant to paragraph (3) and the place of
- 4 delivery of the agricultural commodities, provided that:
- 5 (i) delivery is made pursuant to the sale of the
- 6 commodities by the registrant of the vehicle, by an
- 7 employee of the vehicle registrant or by an auctioneer;
- 8 and
- 9 (ii) if transported to the place of business
- 10 pursuant to paragraph (3), delivery is made by the same
- vehicle of the registrant which transported the
- 12 commodities to the place of business.
- 13 (5) Such farm or farms and a department site for the
- examination of an applicant for a driver's license.
- 15 (6) Such farm or farms and a place of business for the
- inspection, repair or servicing of the vehicle.
- 17 (b) Penalty.--Any person violating this section is guilty of
- 18 a summary offense and shall, upon conviction, be sentenced to
- 19 pay a fine of \$50 and shall, upon conviction for a second or
- 20 subsequent offense, be sentenced to pay a fine of \$200.
- 21 (c) Definition. -- As used in this section, the term "farm"
- 22 shall include, but not be limited to, Christmas tree farms.
- 23 Section 2. This act shall take effect in 60 days.
