AN ACT

- 1 Providing for volunteer health services; limiting liability of a volunteer license holder; and requiring reports.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Volunteer
- 7 Health Services Act.
- 8 Section 2. Purpose.
- 9 It is the purpose of this act to increase the availability of
- 10 primary health care services by establishing a procedure through
- 11 which physicians and other health care practitioners who are
- 12 retired from active practice may provide professional services
- 13 to financially qualified individuals in a clinical setting as a
- 14 volunteer.
- 15 Section 3. Definitions.
- 16 The following words and phrases when used in this act shall
- 17 have the meanings given to them in this section unless the
- 18 context clearly indicates otherwise:

- 1 "Board." The State Board of Medicine, the State Board of
- 2 Osteopathic Medicine, the State Board of Dentistry, the State
- 3 Board of Podiatry, the State Board of Nursing and the State
- 4 Board of Chiropractic.
- 5 "Health care practitioner." An individual licensed to
- 6 practice a component of the healing arts by a licensing board
- 7 within the Department of State.
- 8 "Licensee." An individual who holds a current, active,
- 9 unrestricted license as a health care practitioner issued by the
- 10 appropriate board.
- 11 "Volunteer license." A license issued by the appropriate
- 12 board to a retired individual who documents, to the board's
- 13 satisfaction, that he shall practice solely in organized
- 14 clinical settings approved by the board for the care and
- 15 treatment of needy patients or patients in medically underserved
- 16 regions of this Commonwealth without remuneration.
- 17 Section 4. Volunteer status.
- 18 A licensee in good standing who retires from active practice
- 19 may apply, on forms provided by the appropriate board, to place
- 20 his license on volunteer status.
- 21 Section 5. Regulations.
- 22 Each board shall promulgate regulations governing the
- 23 volunteer license category. The regulations shall include:
- 24 (1) Qualifications for placing a licensee on volunteer
- 25 status.
- 26 (2) Criteria under which a licensee who, having retired
- 27 in good standing and allowed his license to become inactive
- 28 prior to the effective date of this act, may be issued a
- 29 volunteer license.
- 30 (3) Procedures under which a volunteer license holder

- 1 may return to active practice.
- 2 (4) Appropriate clinical settings.
- 3 Section 6. License renewal.
- 4 A volunteer license shall be subject to biennial renewal.
- 5 Section 7. Liability.
- 6 The liability of a volunteer license holder for civil damages
- 7 as a result of acts or omissions during the rendering of health
- 8 care in accordance with the limitations of the volunteer license
- 9 shall be limited to intentional or reckless acts or omissions.
- 10 There shall be no liability for negligent acts or omissions.
- 11 Section 8. Report.
- Beginning 30 days after the effective date of this act and
- 13 every 30 days thereafter until such regulations are in effect,
- 14 the chairmen of the appropriate boards shall report in writing
- 15 to the Commissioner of Professional and Occupational Affairs on
- 16 the status of the volunteer license regulations, who shall
- 17 convey the required reports to the standing committees on
- 18 Consumer Protection and Professional Licensure and Public Health
- 19 and Welfare of the Senate and the standing committees on
- 20 Professional Licensure and Health and Human Services of the
- 21 House of Representatives.
- 22 Section 9. Exemptions.
- 23 For the purposes of this act, licensees subject to the
- 24 provisions of the act of October 15, 1975 (P.L.390, No.111),
- 25 known as the Health Care Services Malpractice Act, shall be
- 26 exempt from the requirements of that act with regard to the
- 27 maintenance of liability insurance coverage. Individuals holding
- 28 a license issued by the State Board of Chiropractic shall be
- 29 exempt from the provisions of section 508 of the act of December
- 30 16, 1986 (P.L.1646, No.188), known as the Chiropractic Practice

- 1 Act.
- 2 Section 10. Effective date.
- 3 This act shall take effect in 60 days.
