AN ACT

- 1 Requiring the Department of Commerce to maintain data regarding
- research and development affecting the housing industry in
- 3 this Commonwealth; recognizing and supporting the
- 4 Pennsylvania Housing Research Center; and making an
- 5 appropriation.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Housing
- 10 Research Act.
- 11 Section 2. Legislative findings.
- 12 The General Assembly finds as follows:
- 13 (1) In July of 1988 the Housing Research Center was
- 14 established to provide training, research, technology
- 15 transfer, consulting and other services to this
- 16 Commonwealth's residential building industry and to ensure
- 17 the best technologically advanced and scientifically sound
- 18 building processes and a more knowledgeable and quality-

2 the center to provide such services to this Commonwealth and

oriented home-building industry. To reflect the commitment of

3 its residents, the name of the center was changed to the

4 Pennsylvania Housing Research Center (PHRC). The PHRC is

5 devoted exclusively to research aimed at improving the

6 quality of housing and the infrastructure needed to support

such housing. To date, this commitment has been strengthened

through partnerships with the home-building industry, the

Pennsylvania Electric Association, the Pennsylvania Energy

Office and the member firms of the Mid-Atlantic Building

- (2) Home building is a major economic force within this Commonwealth, providing tens of thousands of jobs and generating millions of dollars in tax revenues. To ensure such economic contributions remain a strong and viable part of this Commonwealth's economy and to ensure this Commonwealth's residents of continuing employment opportunities, the PHRC provides valuable services and advice to State, national and international aspects of the housing industry and is expanding into newly opening markets in
- (3) The PHRC has gained national recognition for its contributions to the education of young engineers, the training of builders and the establishment and implementation of outstanding research and development for housing consumers and the home-building industry. It studies demographic changes, technological developments, and economic and social trends. The PHRC serves as the focal point of informational exchange through conferences, training courses and research publications.

- 1 (4) To continue to effectively provide for this
- 2 Commonwealth's housing demands and the need for out-of-State
- 3 expansion of the housing industry, this Commonwealth needs
- 4 to:
- 5 (i) Support expansion of housing industry research
- and development activities in this Commonwealth and
- 7 expansion of out-of-State and international export
- 8 opportunities to develop a competitive edge over other
- 9 states' expansion in those areas.
- 10 (ii) Develop and improve the product--a house, its
- 11 component parts and materials, and the employees who
- 12 provide these--to provide a more affordable, better
- quality and technologically advanced product to
- homebuyers and homeowners.
- 15 (iii) Improve housing industry productivity.
- 16 (5) The PHRC conducts research projects that have been
- identified, developed and approved in concert with this
- 18 Commonwealth's building community of builders, private
- 19 companies and utilities.
- 20 Section 3. Definitions.
- 21 The following words and phrases when used in this act shall
- 22 have the meanings given to them in this section unless the
- 23 context clearly indicates otherwise:
- 24 "Department." The Department of Commerce of the
- 25 Commonwealth.
- 26 "PHRC." The Pennsylvania Housing Research Center, originally
- 27 the Housing Research Center, a center which gathers and
- 28 disseminates information, conducts research and development
- 29 projects, and makes other academically based contributions to
- 30 the housing industry of this Commonwealth.

- 1 Section 4. Recognition by department.
- 2 The department shall recognize the essential role PHRC
- 3 occupies in the growth of this Commonwealth's economy. The
- 4 department shall, in cooperation with PHRC, use the fruits of
- 5 PHRC's efforts to further meet the goals of the department.
- 6 Section 5. Information sharing.
- 7 The department and PHRC shall share any information which is
- 8 acquired by either and which affects the housing industry's role
- 9 in the economic growth of this Commonwealth. The goal of
- 10 information sharing shall be to ensure that this Commonwealth
- 11 develops and maintains global leadership status in the housing
- 12 industry.
- 13 Section 6. Data.
- 14 A copy of any data relevant to the provisions of this act and
- 15 acquired by either the department or PHRC shall be maintained by
- 16 the department.
- 17 Section 7. Annual report.
- 18 The department shall report annually to the appropriate
- 19 committee in the Senate and in the House of Representatives
- 20 regarding both economic and technological advancements made
- 21 during the immediately preceding year by this Commonwealth's
- 22 housing industry.
- 23 Section 8. Appropriation.
- 24 The sum of \$250,000, or as much thereof as shall be
- 25 necessary, is hereby appropriated to the Department of Commerce
- 26 to support PHRC in its endeavors to stimulate the economic
- 27 growth of this Commonwealth through its housing industry
- 28 projects and programs.
- 29 Section 9. Effective date.
- This act shall take effect in 60 days or July 1, 1996,

1 whichever occurs sooner.
