14	§ 301. ORGANIZATION OF COMMISSION.

16	(C) [COMPENSATION] TERMS OF OFFICE AND COMPENSATIONTHE	
17	MEMBERS SHALL HOLD OFFICE FOR TERMS OF EIGHT YEARS AND MAY	
18	CONTINUE TO HOLD OFFICE FOR A PERIOD OF TIME NOT TO EXCEED SIX	

- 1 MONTHS OR UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIED,
- 2 WHICHEVER OCCURS FIRST. A MEMBER APPOINTED TO FILL A VACANCY FOR
- 3 A PERIOD OF FOUR YEARS OR LESS MAY BE ELIGIBLE FOR APPOINTMENT
- 4 TO A FULL EIGHT-YEAR TERM. A MEMBER WHO SERVES A FULL EIGHT-YEAR
- 5 TERM OR FILLS A VACANCY FOR A PERIOD OF MORE THAN FOUR YEARS
- 6 SHALL NOT BE ELIGIBLE FOR REAPPOINTMENT TO THE COMMISSION UNTIL
- 7 A PERIOD OF EIGHT YEARS EXPIRES. THE MEMBERS SHALL RECEIVE NO
- 8 COMPENSATION FOR THEIR SERVICES BUT MAY BE REIMBURSED FOR TRAVEL

- 11 SECTION 2. TITLE 30 IS AMENDED BY ADDING SECTIONS TO READ:
- 12 § 325. USE OF CREDIT AND DEBIT CARDS.
- 13 (A) SALES OF LICENSES AND OTHER ITEMS. -- THE EXECUTIVE
- 14 DIRECTOR WITH THE APPROVAL OF THE COMMISSION MAY ESTABLISH
- 15 POLICIES AND PROCEDURES FOR THE USE OF CREDIT CARDS AND DEBIT
- 16 CARDS FOR THE PURCHASE OF LICENSES, PERMITS, PUBLICATIONS,
- 17 PROMOTIONAL ITEMS AND OTHER ITEMS OFFERED FOR SALE BY THE
- 18 COMMISSION.
- 19 (B) FINES AND SETTLEMENTS. -- THE EXECUTIVE DIRECTOR WITH THE
- 20 APPROVAL OF THE COMMISSION MAY ESTABLISH POLICIES AND PROCEDURES
- 21 FOR USE OF DEBIT CARDS FOR PERSONS TO PAY FINES, SETTLEMENTS OR
- 22 OTHER AMOUNTS COLLECTED UNDER THIS TITLE.
- 23 § 326. LIMITATION ON REGULATORY JURISDICTION.
- 24 THE COMMISSION SHALL HAVE NO REGULATORY JURISDICTION OVER THE
- 25 PROGRAM WHEREBY THE DEPARTMENT OF ENVIRONMENTAL PROTECTION
- 26 SPRAYS BACILLUS THURINGIENSIS ISRAELIENSIS (BTI) ON COMMONWEALTH
- 27 WATERS FOR CONTROL OF BLACKFLY.
- 28 § 909. Interference with lawful fishing and boating prohibited.
- 29 <u>(a) General rule.--Except as otherwise provided in this</u>
- 30 title, it is unlawful for a person at the location where lawful

- 1 fishing or boating is taking place to intentionally obstruct or
- 2 physically interfere with the lawful fishing or boating.
- 3 (b) Activities that violate section. -- A person violates this
- 4 section if that person intentionally or knowingly commits any of
- 5 the following:
- 6 (1) Disturbs fish in their habitat for the purpose of
- 7 <u>disrupting the lawful taking of fish where another person is</u>
- 8 <u>engaged in the process of lawful fishing.</u>
- 9 (2) Blocks or impedes another person who is engaged in
- the process of lawful fishing or boating.
- 11 (3) Uses natural or artificial visual, aural, olfactory
- or physical stimuli to affect fish behavior in order to
- hinder or prevent the lawful taking of fish.
- 14 (4) Creates or erects barriers with the intent to deny
- ingress or egress to areas where the lawful fishing or
- 16 <u>boating is permitted.</u>
- 17 (5) Places obstructions or objects in the waters of this
- 18 Commonwealth for the purpose of hindering lawful fishing or
- 19 boating.
- 20 (6) Fails to obey the order of any officer authorized to
- 21 <u>enforce this title to cease and desist from conduct in</u>
- 22 violation of this section.
- 23 (c) Exception. -- The conduct declared unlawful in this
- 24 section does not include any lawful activities arising from
- 25 ownership and occupancy of private lands, farming, mining,
- 26 forestry practices, activities associated with oil and gas
- 27 drilling and production, recreation and similar activities or
- 28 <u>exercise of defendant's rights of free speech under the</u>
- 29 Constitution of the United States or the Constitution of
- 30 Pennsylvania. Nothing contained in this section shall be

- 1 construed to authorize any interference with or disruption of
- 2 <u>activities associated with oil and gas drilling, production site</u>
- 3 restoration or other conduct necessary for compliance with the
- 4 act of June 22, 1937 (P.L.1987, No.394), known as The Clean
- 5 Streams Law, the act of December 19, 1984 (P.L.1140, No.223),
- 6 known as the Oil and Gas Act, or other laws or regulations of
- 7 the Commonwealth by the operator of the oil and gas site. In
- 8 addition, nothing contained in this section shall be construed
- 9 to authorize any interference with or disruption of activities
- 10 conducted pursuant to a permit or other authorization of a
- 11 Federal, State or local government agency or any other
- 12 government agency.
- (d) Enforcement and recovery of damages. -- The commission or
- 14 any person who is lawfully engaged in fishing or boating who is
- 15 <u>directly affected by a violation of this section may bring an</u>
- 16 action to restrain conduct declared unlawful in this section and
- 17 to recover damages.
- 18 (e) Penalties.--A violation of this section is a summary
- 19 offense of the first degree.

- 23 § 2707. DISABLED VETERANS.
- 24 (A) GENERAL RULE. -- ANY DISABLED VETERAN WHO HAS A DISABILITY
- 25 INCURRED IN ANY WAR OR ARMED CONFLICT WHICH CONSISTS OF THE LOSS
- 26 OF ONE OR MORE LIMBS, OR THE LOSS OF USE OF ONE OR MORE LIMBS,
- 27 OR TOTAL BLINDNESS, OR WHO IS 100% DISABLED AS CERTIFIED BY THE
- 28 UNITED STATES [VETERANS' ADMINISTRATION] <u>DEPARTMENT OF VETERANS</u>
- 29 AFFAIRS, AND WHO MEETS THE QUALIFICATIONS OF SECTION 2701
- 30 (RELATING TO RESIDENT FISHING LICENSES), SHALL BE ISSUED A FREE

- 1 RESIDENT FISHING LICENSE UPON APPLICATION TO THE COMMISSION OR A
- 2 COUNTY TREASURER [OR, IN COUNTIES WHERE THERE IS NO COUNTY
- 3 TREASURER BY VIRTUE OF A HOME RULE CHARTER OR OPTIONAL PLAN OF
- 4 GOVERNMENT, THE COUNTY OFFICIAL WHO PERFORMS THE FUNCTIONS OF A
- 5 COUNTY TREASURER AND WHO HAS BEEN DESIGNATED AS AN ISSUING AGENT
- 6 BY THE COMMISSION]. AN APPLICATION UNDER THIS SECTION SHALL, IN
- 7 ADDITION TO ANY INFORMATION REQUIRED UNDER SECTION 2701, CONTAIN
- 8 A STATEMENT THAT THE APPLICANT IS A WAR OR ARMED CONFLICT
- 9 VETERAN AND THAT [HIS] THE QUALIFYING DISABILITY WAS SERVICE
- 10 INCURRED. THE ISSUING AGENT OR THE COMMISSION MAY REQUIRE THE
- 11 PRODUCTION OF THE DISCHARGE PAPERS OF THE APPLICANT.
- 12 (B) LIFETIME LICENSES. -- IF A DISABLED VETERAN WHO QUALIFIES
- 13 FOR ISSUANCE OF A FREE RESIDENT FISHING LICENSE UNDER SUBSECTION
- 14 (A) PRESENTS DOCUMENTATION TO SHOW THAT THE QUALIFYING
- 15 <u>DISABILITY IS PERMANENT, THE COMMISSION OR COUNTY TREASURER</u>
- 16 SHALL ISSUE A DISABLED VETERAN LIFETIME FISHING LICENSE.
- 17 (C) HOME RULE AND OPTIONAL PLAN COUNTIES. -- IN A COUNTY WHERE
- 18 THERE IS NO COUNTY TREASURER BY VIRTUE OF A HOME RULE CHARTER OR
- 19 OPTIONAL PLAN OF GOVERNMENT, THE COUNTY OFFICIAL WHO PERFORMS
- 20 THE FUNCTIONS OF A COUNTY TREASURER AND WHO HAS BEEN DESIGNATED
- 21 AN ISSUING AGENT BY THE COMMISSION SHALL ISSUE FREE RESIDENT
- 22 FISHING LICENSES TO DISABLED VETERANS UNDER THIS SECTION.
- 23 § 2905. PERMITS FOR <u>SCIENTIFIC AND EDUCATIONAL</u> FISH COLLECTING

- 24 ACTIVITIES.
- THE EXECUTIVE DIRECTOR, WITH THE APPROVAL OF THE COMMISSION,
- 26 MAY GRANT PERMITS TO CATCH FISH IN ANY OF THE WATERS WITHIN OR
- 27 BORDERING ON THIS COMMONWEALTH AT ANY SEASON OF THE YEAR AND
- 28 WITH ANY KIND OF NETS OR OTHER DEVICES WITHOUT REGARD TO SIZE OR
- 29 POSSESSION LIMITS TO A PERSON WHO POSSESSES A VALID PENNSYLVANIA
- 30 FISHING LICENSE AND IS ENGAGED IN SCIENTIFIC OR EDUCATIONAL

- 1 RESEARCH OR OTHER COLLECTING ACTIVITIES APPROVED BY THE
- 2 COMMISSION. THE COMMISSION MAY ESTABLISH A FEE FOR THE ISSUANCE
- 3 OF THE PERMITS. PERMITS ISSUED UNDER THIS SECTION MAY BE
- 4 REVOKED, RECALLED OR SUSPENDED AT ANY TIME AT THE DISCRETION OF
- 5 THE COMMISSION. PERSONS PERMITTED TO TAKE SUCH SPECIES UNDER
- 6 THIS SECTION SHALL MAKE A REPORT IN WRITING TO THE EXECUTIVE
- 7 DIRECTOR WITHIN 30 DAYS AFTER THE EXPIRATION OF THE PERMIT OR
- 8 CONCLUSION OF THE SURVEY OR COLLECTING ACTIVITY. THE COMMISSION
- 9 MAY PROMULGATE REGULATIONS GOVERNING THE ISSUANCE OF PERMITS
- 10 UNDER THIS SECTION AND THE ACTIVITIES OF PERSONS HOLDING SUCH
- 11 PERMITS. IN ISSUING A PERMIT, THE COMMISSION MAY IMPOSE GENERAL
- 12 AND SPECIAL PERMIT CONDITIONS TO GOVERN THE ACTIVITIES OF
- 13 PERSONS HOLDING SUCH A PERMIT. NOTWITHSTANDING THE PROVISIONS OF
- 14 SECTION 2907 (RELATING TO EXPIRATION OF LICENSES AND PERMITS),
- 15 PERMITS ISSUED UNDER THIS SECTION SHALL EXPIRE ON THE DATE
- 16 SPECIFIED IN THE PERMIT CONDITIONS OR ON DECEMBER 31 OF THE YEAR
- 17 <u>IN WHICH THE PERMIT IS ISSUED, WHICHEVER COMES FIRST.</u>
- 18 NOTWITHSTANDING THE PROVISIONS OF SECTION 2908 (RELATING TO
- 19 PENALTIES), ANY PERSON WHO ENGAGES IN FISH COLLECTING ACTIVITIES
- 20 FOR WHICH A PERMIT IS REQUIRED UNDER THIS SECTION WITHOUT FIRST
- 21 ACQUIRING THE NECESSARY PERMIT COMMITS A SUMMARY OFFENSE OF THE
- 22 FIRST DEGREE AND, ANY PERSON WHO VIOLATES ANY REGULATION
- 23 PROMULGATED UNDER THIS SECTION OR ANY PERMIT CONDITION IMPOSED
- 24 UNDER THIS SECTION COMMITS A SUMMARY OFFENSE OF THE THIRD
- 25 <u>DEGREE</u>.
- 26 Section 4. The amendment of 30 Pa.C.S. § 301(c) shall not
- 27 apply to a current member of the Pennsylvania Fish and Boat
- 28 Commission until the member completes the term being served on
- 29 the effective date of this act.
- 30 Section 2.5. This act shall take effect in 60 days.
