L1	The General Assembly of the Commonwealth of Pennsylvania
L2	hereby enacts as follows:
L3	Section 1. The lands described in section 2 are hereby
L4	released from restrictions imposed under the provisions of the
L5	act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the
L6	Project 70 Land Acquisition and Borrowing Act, in exchange for
L7	the imposition of restrictions under the Project 70 Land
L8	Acquisition and Borrowing Act on the lands described in section
19	3.

Section 2. The lands authorized to be released from
