- 7 WHEREAS, In the Free School Act of 1834, the General Assembly
- 8 established school boards to ensure that responsibility for the
- 9 daily operation of public schools was vested in local elected
- 10 officials who are accountable to the communities they serve; and
- 11 WHEREAS, In 1895, school directors from across this
- 12 Commonwealth organized the first association of school boards in

- 2 WHEREAS, The Pennsylvania School Boards Association has
- 3 provided distinguished service to school directors for 100 years
- 4 through its advocacy on behalf of public education, as well as
- 5 through its many programs, services and publications for members
- 6 and the general public; therefore be it
- 7 RESOLVED, That the House of Representatives offer its
- 8 commendation to the Pennsylvania School Boards Association on
- 9 the occasion of its 100th anniversary and extend its best wishes
