19	The General Assembly of the Commonwealth of Pennsylvania	
20	hereby enacts as follows:	
21	Section 1. The sum of \$42,643,000, or as much thereof as may	<
21	beceion 1. The bam of \$12,013,000, of ab mach energy as may	`
22	be necessary, is hereby appropriated from the Workmen's	
23	Compensation Administration Fund to the Department of Labor and	
24	Industry for the payment of all salaries, wages and other

- 2 other expenses necessary for the administration of the act of
- 3 June 2, 1915 (P.L.736, No.338), known as the Workers'
- 4 Compensation Act, and the act of June 21, 1939 (P.L.566,
- 5 No.284), known as The Pennsylvania Occupational Disease Act, for
- 6 the fiscal year beginning July 1, 1995, and for the payment of
- 7 bills incurred and remaining unpaid at the close of the fiscal
- 8 year ending June 30, 1995.
- 9 Section 2. The sum of \$265,000 is hereby appropriated from
- 10 the restricted revenue account within the Workmen's Compensation
- 11 Administration Fund to the Office of Small Business Advocate in
- 12 the Department of Commerce as provided in the act of June 2,
- 13 1915 (P.L.736, No.338), known as the Workers' Compensation Act,
- 14 for the operation of the Office of Small Business Advocate.
- 15 Section 3. This act shall take effect July 1, 1995, or
- 16 immediately, whichever is later.

- 26 AMENDED TO READ:
- 27 SECTION 1. THE SUM OF [\$42,688,000] \$48,588,000, OR AS MUCH
- 28 THEREOF AS MAY BE NECESSARY, IS HEREBY APPROPRIATED FROM THE
- 29 WORKMEN'S COMPENSATION ADMINISTRATION FUND TO THE DEPARTMENT OF
- 30 LABOR AND INDUSTRY FOR THE PAYMENT OF ALL SALARIES, WAGES AND

- 1 OTHER COMPENSATION AND TRAVEL EXPENSES, FOR CONTRACTUAL SERVICES
- 2 AND OTHER EXPENSES NECESSARY FOR THE ADMINISTRATION OF THE ACT
- 3 OF JUNE 2, 1915 (P.L.736, NO.338), KNOWN AS THE WORKERS'
- 4 COMPENSATION ACT, AND THE ACT OF JUNE 21, 1939 (P.L.566,
- 5 NO.284), KNOWN AS THE PENNSYLVANIA OCCUPATIONAL DISEASE ACT, FOR
- 6 THE FISCAL YEAR BEGINNING JULY 1, 1996, AND FOR THE PAYMENT OF
- 7 BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE OF THE FISCAL
- 8 YEAR ENDING JUNE 30, 1996.
- 9 SECTION 2. THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
