- 6 TREATMENT UNDER THIS ACT OR WHO HAS BEEN INVOLUNTARILY TREATED
- 7 AS DESCRIBED UNDER 18 PA.C.S § 6105(C)(4) (RELATING TO PERSONS
- 8 NOT TO POSSESS, USE, MANUFACTURE, CONTROL, SELL OR TRANSFER
- 9 FIREARMS). THE NOTIFICATION SHALL BE TRANSMITTED BY THE JUDGE,
- 10 MENTAL HEALTH REVIEW OFFICER OR COUNTY MENTAL HEALTH AND MENTAL
- 11 RETARDATION ADMINISTRATOR WITHIN SEVEN DAYS OF THE ADJUDICATION,
- 12 COMMITMENT OR TREATMENT. NOTWITHSTANDING ANY STATUTE TO THE
- 13 CONTRARY, COUNTY MENTAL HEALTH AND MENTAL RETARDATION
- 14 ADMINISTRATORS SHALL NOTIFY THE PENNSYLVANIA STATE POLICE ON A
- 15 FORM DEVELOPED BY THE PENNSYLVANIA STATE POLICE OF THE IDENTITY
- 16 OF ANY INDIVIDUAL WHO, BEFORE THE EFFECTIVE DATE OF THIS ACT,

- 18 COMMITTED TO A MENTAL INSTITUTION FOR INPATIENT CARE TREATMENT

- 21 SECTION 2. SECTIONS 111, 402(D) AND 403(A) OF THE ACT ARE
- 22 AMENDED TO READ:
- 23 SECTION 111. CONFIDENTIALITY OF RECORDS.--(A) ALL DOCUMENTS
- 24 CONCERNING PERSONS IN TREATMENT SHALL BE KEPT CONFIDENTIAL AND,
- 25 WITHOUT THE PERSON'S WRITTEN CONSENT, MAY NOT BE RELEASED OR
- 26 THEIR CONTENTS DISCLOSED TO ANYONE EXCEPT:
- 27 (1) THOSE ENGAGED IN PROVIDING TREATMENT FOR THE PERSON;
- 28 (2) THE COUNTY ADMINISTRATOR, PURSUANT TO SECTION 110;
- 29 (3) A COURT IN THE COURSE OF LEGAL PROCEEDINGS AUTHORIZED BY
- 30 THIS ACT; AND

- 1 (4) PURSUANT TO FEDERAL RULES, STATUTES AND REGULATIONS
- 2 GOVERNING DISCLOSURE OF PATIENT INFORMATION WHERE TREATMENT IS
- 3 UNDERTAKEN IN A FEDERAL AGENCY.
- 4 IN NO EVENT, HOWEVER, SHALL PRIVILEGED COMMUNICATIONS, WHETHER
- 5 WRITTEN OR ORAL, BE DISCLOSED TO ANYONE WITHOUT SUCH WRITTEN
- 6 CONSENT. THIS SHALL NOT RESTRICT THE COLLECTION AND ANALYSIS OF
- 7 CLINICAL OR STATISTICAL DATA BY THE DEPARTMENT, THE COUNTY
- 8 ADMINISTRATOR OR THE FACILITY SO LONG AS THE USE AND
- 9 DISSEMINATION OF SUCH DATA DOES NOT IDENTIFY INDIVIDUAL
- 10 PATIENTS. NOTHING HEREIN SHALL BE CONSTRUED TO CONFLICT WITH
- 11 SECTION 8 OF THE ACT OF APRIL 14, 1972 (P.L.221, NO.63), KNOWN
- 12 AS THE "PENNSYLVANIA DRUG AND ALCOHOL ABUSE CONTROL ACT."
- 13 (B) THIS SECTION SHALL NOT RESTRICT JUDGES OF THE COURTS OF
- 14 COMMON PLEAS, MENTAL HEALTH REVIEW OFFICERS AND COUNTY MENTAL
- 15 HEALTH AND MENTAL RETARDATION ADMINISTRATORS FROM DISCLOSING
- 16 INFORMATION TO THE PENNSYLVANIA STATE POLICE OR THE PENNSYLVANIA
- 17 STATE POLICE FROM DISCLOSING INFORMATION TO ANY PERSON, IN
- 18 ACCORDANCE WITH THE PROVISIONS OF 18 PA.C.S. § 6105(C)(4)
- 19 (RELATING TO PERSONS NOT TO POSSESS, USE, MANUFACTURE, CONTROL,
- 20 <u>SELL OR TRANSFER FIREARMS</u>).
- 21 SECTION 402. INCOMPETENCE TO PROCEED ON CRIMINAL CHARGES AND
- 22 LACK OF CRIMINAL RESPONSIBILITY AS DEFENSE. --* * *
- 23 (D) HEARING; WHEN REQUIRED.--THE COURT, EITHER ON
- 24 APPLICATION OR ON ITS OWN MOTION, MAY ORDER AN INCOMPETENCY
- 25 EXAMINATION AT ANY STAGE IN THE PROCEEDINGS AND MAY DO SO
- 26 WITHOUT A HEARING UNLESS THE EXAMINATION IS OBJECTED TO BY THE
- 27 PERSON CHARGED WITH A CRIME OR BY HIS COUNSEL. IN SUCH EVENT, AN
- 28 EXAMINATION SHALL BE ORDERED ONLY AFTER DETERMINATION UPON A
- 29 HEARING THAT THERE IS A PRIMA FACIE QUESTION OF INCOMPETENCY.
- 30 UPON COMPLETION OF THE EXAMINATION, A DETERMINATION OF

- 1 INCOMPETENCY SHALL BE MADE BY THE COURT WHERE INCOMPETENCY IS
- 2 ESTABLISHED BY A PREPONDERANCE OF THE EVIDENCE.

- 4 Section 403. Hearing and Determination of Incompetency to
- 5 Proceed; Stay of Proceedings; Dismissal of Charges.--(a)
- 6 Competency Determination and Burden of Proof. -- [The moving party <--

- 11 AS PROVIDED FOR IN SECTION 402(D), THE INDIVIDUAL MAKING AN
- 12 APPLICATION TO THE COURT FOR AN ORDER DIRECTING AN INCOMPETENCY
- 13 EXAMINATION SHALL HAVE THE BURDEN OF ESTABLISHING INCOMPETENCY
- 14 TO PROCEED BY A PREPONDERANCE OF THE EVIDENCE. THE DETERMINATION
- 15 SHALL BE MADE BY THE COURT.
