AN ACT

- 1 Amending Title 34 (Game) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the organization of the
- 3 Pennsylvania Game Commission.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 301(b) of Title 34 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 301. Organization of commission.
- 9 * * *
- 10 (b) Qualifications. -- An individual who has been or is an
- 11 employee of the commission may not serve as a member of the
- 12 commission. The members of the commission shall be appointed
- 13 from the various geographical sections of this Commonwealth so
- 14 that one and only one shall be a resident of each of the
- 15 following districts:
- 16 (1) The counties of Erie, Crawford, Mercer, Lawrence,
- 17 Venango, Butler, Warren, Forest and Clarion, constituting the

- 1 first district.
- 2 (2) The counties of Beaver, Allegheny, Washington,
- 3 Greene, Armstrong, Indiana, Westmoreland and Fayette,
- 4 constituting the second district.
- 5 (3) The counties of McKean, Elk, Jefferson, Potter,
- 6 Cameron, Clearfield, Clinton and Centre, constituting the
- 7 third district.
- 8 (4) The counties of Cambria, Somerset, Blair, Bedford,
- 9 Huntingdon and Fulton, constituting the fourth district.
- 10 (5) The counties of Tioga, Lycoming, Union, Bradford,
- 11 Sullivan, Columbia, Montour and Northumberland, constituting
- 12 the fifth district.
- 13 (6) The counties of Snyder, Mifflin, Juniata, Franklin,
- 14 Perry, Cumberland, Adams, Dauphin, York, Lebanon and
- 15 Lancaster, constituting the sixth district.
- 16 (7) The counties of Susquehanna, Wyoming, Luzerne,
- 17 Lackawanna, Carbon, Wayne, Pike and Monroe, constituting the
- 18 seventh district.
- 19 (8) The counties of Schuylkill, Berks, Chester,
- Northampton, Lehigh, Bucks, Montgomery, Philadelphia and
- 21 Delaware, constituting the eighth district.
- 22 * * *
- 23 Section 2. The amendment of 34 Pa.C.S. § 301(b) shall apply
- 24 to members of the Pennsylvania Game Commission who take office
- 25 on or after the effective date of this act.
- 26 Section 3. This act shall take effect in 60 days.
