INTRODUCED BY BARLEY, MARCH 12, 1997

AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES, APRIL 2, 1997

AN ACT

1 To provide from the General Fund for the expenses of the
2 Executive, Legislative and Judicial Departments of the
3 Commonwealth, the public debt and for the public schools for
4 the fiscal year July 1, 1997, to June 30, 1998, for certain
5 institutions and organizations, and for the payment of bills
6 incurred and remaining unpaid at the close of the fiscal year
7 ending June 30, 1997; to provide appropriations from the
8 State Lottery Fund, the Energy Conservation and Assistance
9 Fund, the Hazardous Material Response Fund, The State Stores
10 Fund, the Milk Marketing Fund, the Home Investment Trust
11 Fund, the Emergency Medical Services Operating Fund, the Ben
12 Franklin/IRC Partnership Fund, the Tuition Payment Fund, the
13 Banking Department Fund and the Firearm Ownership Fund to the
14 Executive Department; to provide appropriations from the
15 Judicial Computer System Augmentation Account to the Judicial
16 Department; to provide appropriations from the Motor License
17 Fund for the fiscal year July 1, 1997, to June 30, 1998, for
18 the proper operation of the several departments of the
19 Commonwealth and the Pennsylvania State Police authorized to
20 spend Motor License Fund moneys; to provide for the
21 appropriation of Federal funds to the Executive and Judicial
22 Departments of the Commonwealth and for the establishment of
23 restricted receipt accounts for the fiscal year July 1, 1997,
24 to June 30, 1998, and for the payment of bills remaining
25 unpaid at the close of the fiscal year ending June 30, 1997.

2 The General Assembly of the Commonwealth of Pennsylvania
3 hereby enacts as follows:

4 PART I

5 GENERAL PROVISIONS

6 Section 101. Short title.--This act shall be known and may
7 be cited as the General Appropriation Act of 1997.

8 Section 102. Definitions.--The following words and phrases
9 when used in this act shall have the meanings given to them in
10 this section unless the context clearly indicates otherwise:

11 "Employees." Includes all directors, superintendents, bureau
12 or division chiefs, assistant directors, assistant
13 superintendents, assistant chiefs, experts, scientists,
14 engineers, surveyors, draftsmen, accountants, secretaries,
15 auditors, inspectors, examiners, analysts, statisticians,
16 marshals, clerks, stenographers, bookkeepers, messengers and
17 other assistants in any department, board or commission.

18 "Expenses" and "maintenance." Includes all printing, binding
19 and stationery, food and forage, materials and supplies,
20 traveling expenses, training, motor vehicle supplies and
21 repairs, freight, express and cartage, postage, telephones and
22 telegraph rentals and toll charges, newspaper advertising and
23 notices, public advertising by or through any medium, fuel,
24 light, heat, power and water, minor construction and renovation,
25 repairs or reconstruction of equipment, buildings and
26 facilities, rent of real estate and equipment, premiums on
27 workers' compensation, insurance premiums on policies of
28 liability insurance, insurance premiums on medical payment
29 insurance and surety bonds for volunteer workers, premiums on
30 employee group life insurance and employee and retired employee

1 group hospital and medical insurance, payment of Commonwealth
2 share of Social Security taxes and unemployment compensation
3 costs for State employees, the purchase of replacement or
4 additional equipment and machinery and all other incidental
5 costs and expenses, including payment to the Department of
6 General Services of mileage and other charges for the use of
7 automobiles and rental payments for permanently assigned
8 automobiles and of expenses or costs of services incurred
9 through the Purchasing Fund. The term "expenses" also shall
10 include the medical costs for the treatment of inmates of State
11 institutions when the inmate must be transferred to an outside
12 hospital: Provided, That in no case shall the State institution
13 pay more for patient care than that provided under the State
14 medical assistance program.

30 Section 104. State appropriations.--(a) General Fund.--The

1 following sums set forth in this act, or as much thereof as may
2 be necessary, are hereby specifically appropriated from the
3 General Fund to the several hereinafter named agencies of the
4 Executive, Legislative and Judicial Departments of the
5 Commonwealth for the payment of salaries, wages or other
6 compensation and travel expenses of the duly elected or
7 appointed officers and employees of the Commonwealth, for the
8 payment of fees for contractual services rendered, for the
9 purchase or rental of goods and services, printing, public
10 advertising by or through any medium, equipment, land and
11 buildings and for payment of any other expenses, as provided by
12 law or by this act, necessary for the proper conduct of the
13 duties, functions and activities and for the purposes
14 hereinafter set forth for the fiscal year beginning July 1,
15 1997, and for the payment of bills incurred and remaining unpaid
16 at the close of the fiscal year ending June 30, 1997.

17 (b) State Lottery Fund.--The following sums set forth in
18 this act, or as much thereof as may be necessary, are hereby
19 specifically appropriated from the State Lottery Fund to the
20 several hereinafter named agencies of the Executive Department
21 of the Commonwealth for the payment of salaries, wages or other
22 compensation and travel expenses of the duly appointed officers
23 and employees of the Commonwealth, for the payment of fees for
24 contractual services rendered, for the purchase or rental of
25 goods and services and for payment of any other expenses, as
26 provided by law or by this act, necessary for the proper conduct
27 of the duties, functions and activities and for the purposes
28 hereinafter set forth for the fiscal year beginning July 1,
29 1997, and for the payment of bills incurred and remaining unpaid
30 at the close of the fiscal year ending June 30, 1997.

1 (c) Energy Conservation and Assistance Fund.--The following
2 sums set forth in this act, or as much thereof as may be
3 necessary, are hereby specifically appropriated from the Energy
4 Conservation and Assistance Fund to the several hereinafter
5 named agencies of the Executive Department of the Commonwealth
6 for the payment of fees for contractual services rendered, for
7 the purchase or rental of goods and services and for the payment
8 of any other expenses, as provided by law or by this act,
9 necessary for the proper conduct of the duties, functions and
10 activities and for the purposes hereinafter set forth for the
11 fiscal year beginning July 1, 1997, and for the payment of bills
12 incurred and remaining unpaid at the close of the fiscal year
13 ending June 30, 1997.

14 (d) Judicial Computer System Augmentation Account.--The
15 following sums set forth in this act, or as much thereof as may
16 be necessary, are hereby specifically appropriated from the
17 restricted receipt account established within the General Fund,
18 known as the Judicial Computer System Augmentation Account, to
19 the Judicial Department of the Commonwealth for the payment of
20 fees for contractual services rendered, for the purchase or
21 rental of goods and services and for the payment of any other
22 expenses, as provided by law or by this act, necessary for the
23 proper conduct of the duties, functions and activities and for
24 the purposes hereinafter set forth for the fiscal year beginning
25 July 1, 1997, and for the payment of bills incurred and
26 remaining unpaid at the close of the fiscal year ending June 30,
27 1997.

28 (e) Emergency Medical Services Operating Fund.--The
29 following sums set forth in this act, or as much thereof as may
30 be necessary, are hereby specifically appropriated from the

1 Emergency Medical Services Operating Fund to the several
2 hereinafter named agencies of the Executive Department of the
3 Commonwealth for the payment of fees for contractual services
4 rendered, for the purchase or rental of goods and services and
5 for the payment of any other expenses, as provided by law or by
6 this act, necessary for the proper conduct of the duties,
7 functions and activities and for the purposes hereinafter set
8 forth for the fiscal year beginning July 1, 1997, and for the
9 payment of bills incurred and remaining unpaid at the close of
10 the fiscal year ending June 30, 1997.

11 (f) The State Stores Fund.--The following sums set forth in
12 this act, or as much thereof as may be necessary, are hereby
13 specifically appropriated from The State Stores Fund to the
14 hereinafter named agency of the Executive Department of the
15 Commonwealth for the payment of salaries, wages or other
16 compensation and travel expenses of the duly appointed officers
17 and employees of the Commonwealth, for the payment of fees for
18 contractual services rendered, for the purchase or rental of
19 goods and services and for the payment of any other expenses, as
20 provided by law or by this act, necessary for the proper conduct
21 of the duties, functions and activities and for the purposes
22 hereinafter set forth for the fiscal year beginning July 1,
23 1997, and for the payment of bills incurred and remaining unpaid
24 at the close of the fiscal year ending June 30, 1997.

25 (g) Motor License Fund.--The following sums, or as much
26 thereof as may be necessary, are hereby appropriated from the
27 Motor License Fund to the hereinafter named agencies of the
28 Commonwealth for the payment of salaries, wages and other
29 compensation and travel expenses of the duly elected or
30 appointed officers and employees of the Commonwealth, for

1 contractual services and other expenses necessary for the proper
2 conduct of the duties, functions and activities for the purposes
3 hereinafter set forth for the fiscal year beginning July 1,
4 1997, and for the payment of bills incurred and remaining unpaid
5 at the close of the fiscal year ending June 30, 1997.

6 (h) Aviation Restricted Revenue Account.--The following
7 sums, or as much thereof as may be necessary, are hereby
8 appropriated from the Aviation Restricted Revenue Account in the
9 Motor License Fund to the hereinafter named agencies of the
10 Commonwealth for the purposes set forth herein for the fiscal
11 year beginning July 1, 1997, and for the payment of bills
12 incurred and remaining unpaid at the close of the fiscal year
13 ending June 30, 1997.

14 (i) Hazardous Material Response Fund.--The following sums
15 set forth in this act, or as much thereof as may be necessary,
16 are hereby specifically appropriated from the Hazardous Material
17 Response Fund to the several hereinafter named agencies of the
18 Executive Department of the Commonwealth for the payment of fees
19 for contractual services rendered, for the purchase or rental of
20 goods and services and for the payment of any other expenses, as
21 provided by law or by this act, necessary for the proper conduct
22 of the duties, functions and activities and for the purposes
23 hereinafter set forth for the fiscal year beginning July 1,
24 1997, and for the payment of bills incurred and remaining unpaid
25 at the close of the fiscal year ending June 30, 1997.

26 (j) Milk Marketing Fund.--The following sums set forth in
27 this act, or as much thereof as may be necessary, are hereby
28 specifically appropriated from the Milk Marketing Fund to the
29 several hereinafter named agencies of the Executive Department
30 of the Commonwealth for the payment of salaries, wages or other

1 compensation and travel expenses of the duly appointed officers
2 and employees of the Commonwealth, for the payment of fees for
3 contractual services rendered, for the purchase or rental of
4 goods and services and for the payment of any other expenses, as
5 provided by law or by this act, necessary for the proper conduct
6 of the duties, functions and activities and for the purposes
7 hereinafter set forth for the fiscal year beginning July 1,
8 1997, and for the payment of bills incurred and remaining unpaid
9 at the close of the fiscal year ending June 30, 1997.

10 (k) Home Investment Trust Fund.--The following sums set
11 forth in this act, or as much thereof as may be necessary, are
12 hereby specifically appropriated from the Home Investment Trust
13 Fund to the hereinafter named agencies of the Executive
14 Department of the Commonwealth for the payment of salaries,
15 wages or other compensation and travel expenses of the duly
16 appointed officers and employees of the Commonwealth, for the
17 payment of fees for contractual services rendered, for the
18 purchase or rental of goods and services and for the payment of
19 any other expenses, as provided by law or by this act, necessary
20 for the proper conduct of the duties, functions and activities
21 and for the purposes hereinafter set forth for the fiscal year
22 beginning July 1, 1997, and for the payment of bills incurred
23 and remaining unpaid at the close of the fiscal year ending June
24 30, 1997.

25 (l) Ben Franklin/IRC Partnership Fund.--The following sums
26 set forth in this act, or as much thereof as may be necessary,
27 are hereby appropriated from the Ben Franklin/IRC Partnership
28 Fund to the hereinafter named agencies of the Executive
29 Department of the Commonwealth for the payment of salaries,
30 wages or other compensation and travel expenses of the duly

1 appointed officers and employees of the Commonwealth, for the
2 payment of fees for contractual services rendered, for the
3 purchase or rental of goods and services and for the payment of
4 any other expenses, as provided by law or by this act, necessary
5 for the proper conduct of the duties, functions and activities
6 and for the purposes hereinafter set forth for the fiscal year
7 beginning July 1, 1997, and for the payment of bills incurred
8 and remaining unpaid at the close of the fiscal year ending June
9 30, 1997.

10 (m) Tuition Payment Fund.--The following sums set forth in
11 this act, or as much thereof as may be necessary, are hereby
12 appropriated from the Tuition Payment Fund to the hereinafter
13 named agencies of the Executive Department of the Commonwealth
14 for the payment of salaries, wages or other compensation and
15 travel expenses of the duly appointed officers and employees of
16 the Commonwealth, for the payment of fees for contractual
17 services rendered, for the purchase or rental of goods and
18 services and for the payment of any other expenses, as provided
19 by law or by this act, necessary for the proper conduct of the
20 duties, functions and activities and for the purposes
21 hereinafter set forth for the fiscal year beginning July 1,
22 1997, and for the payment of bills incurred and remaining unpaid
23 at the close of the fiscal year ending June 30, 1997.

24 (n) Banking Department Fund.--The following sums set forth
25 in this act, or as much thereof as may be necessary, are hereby
26 specifically appropriated from the Banking Department Fund to
27 the hereinafter named agencies of the Executive Department of
28 the Commonwealth for the payment of salaries, wages or other
29 compensation and travel expenses of the duly appointed officers
30 and employees of the Commonwealth, for the payment of fees for

1 contractual services rendered, for the purchase or rental of
2 goods and services and for the payment of any other expenses, as
3 provided by law or by this act, necessary for the proper conduct
4 of the duties, functions and activities and for the purposes
5 hereinafter set forth for the fiscal year beginning July 1,
6 1997, and for the payment of bills incurred and remaining unpaid
7 at the close of the fiscal year ending June 30, 1997.

8 (o) Firearm Ownership Fund.--The following sums set forth in
9 this act, or as much thereof as may be necessary, are hereby
10 specifically appropriated from the Firearm Ownership Fund to the
11 hereinafter named agencies of the Executive Department of the
12 Commonwealth for the payment of salaries, wages or other
13 compensation and travel expenses of the duly appointed officers
14 and employees of the Commonwealth, for the payment of fees for
15 contractual services rendered, for the purchase or rental of
16 goods and services and for the payment of any other expenses, as
17 provided by law or by this act, necessary for the proper conduct
18 of the duties, functions and activities and for the purposes
19 hereinafter set forth for the fiscal year beginning July 1,
20 1997, and for the payment of bills incurred and remaining unpaid
21 at the close of the fiscal year ending June 30, 1997.

22 Section 105. Federal augmentation appropriations.--The
23 following Federal augmentation appropriations set forth in this
24 act, or as much thereof as may be necessary, are hereby
25 specifically appropriated from the Federal augmentation funds to
26 the several hereinafter named agencies of the Executive and
27 Judicial Departments of the Commonwealth for the payment of the
28 expenses of implementing and carrying out the programs stated
29 herein for the fiscal year beginning July 1, 1997, and for the
30 payment of bills incurred and remaining unpaid at the close of

1 the fiscal year ending June 30, 1997. Unless otherwise stated,
2 the appropriations include any carryovers from the prior fiscal
3 year.

4 Section 106. Job Training Partnership Act appropriations.--
5 The following sums set forth in this act, or as much thereof as
6 may be necessary, are hereby appropriated from the Job Training
7 Partnership Act (JTPA) funds to the several hereinafter named
8 agencies of the Executive Department of the Commonwealth for the
9 payment of the expenses of implementing and carrying out the
10 program stated herein for the fiscal year beginning July 1,
11 1997.

12 Section 107. Block grants.--(a) Appropriation.--The
13 following sums set forth in this act, or as much thereof as may
14 be necessary, are hereby specifically appropriated from the
15 block grant (BG) funds to the several hereinafter named agencies
16 of the Executive Department of the Commonwealth for the
17 purposes, and under the restrictions, for which the funds are
18 provided for the fiscal year beginning July 1, 1997.

19 (b) Small Communities Development Block Grant.--The Small
20 Communities Development Block Grant (SCDBG) is to assist small
21 cities and communities that have a high concentration of
22 impoverished citizens and substandard housing to expand their
23 low-income and moderate-income housing opportunities and to meet
24 community development needs.

17 Section 1609. Pennsylvania Historical and Museum
18 Commission.--The following restricted receipt account may be
19 established for the Pennsylvania Historical and Museum
20 Commission:

21 (1) "Federal Grant - Historical Preservation Act of 1966."

22 PART XVII

23 SPECIAL PROVISIONS FOR FEDERAL FUNDS

24 FOR 1997-1998

25 Section 1701. General Fund repository for Federal funds.--
26 All moneys received from the Federal Government as contributions
27 or supplements to the departments or agencies of the
28 Commonwealth or the programs herein provided shall be paid into
29 the General Fund.

30 Section 1702. Limitation on encumbering or spending Federal

1 funds.--Federal funds shall be encumbered or spent only to the
2 extent that such funds are estimated as being available during
3 the fiscal year of the Commonwealth.

4 Section 1703. Appropriation of prior unspent Federal
5 funds.--Any Federal money which has been previously appropriated
6 by the General Assembly and authorized or allocated by the
7 Federal Government but remains unspent from prior fiscal years
8 and will not be renewed for fiscal year 1997-1998 is hereby
9 appropriated.

10 Section 1704. Subgrants between Federal fund
11 appropriations.--With the exception of Federal money received
12 under JTPA and SSBG, subgrants may be made between
13 appropriations without further approval of the General Assembly.
14 The Secretary of the Budget shall submit a list of subgrants to
15 the Chairmen of the House and Senate Appropriations Committees
16 quarterly. No subgrant to a State agency, however, may be made
17 from a restricted receipt account without a specific
18 appropriation by the General Assembly.

19 Section 1705. Utilization of emergency Federal funds.--(a)
20 Federal funds available for costs and damages resulting from
21 natural disasters or civil disobedience may be added to an
22 appropriation contained in this act or to funds appropriated or
23 may be used for the purposes prescribed by the Federal
24 Government.

25 (b) In addition to the moneys appropriated by this act, all
26 moneys received from the Federal Government for the purpose of
27 disaster assistance or relief shall be paid into the General
28 Fund and are hereby appropriated out of the General Fund to the
29 departments, boards, commissions or agencies designated by the
30 Governor.

1 (c) In the event of any emergency situation in which the
2 General Assembly cannot act in sufficient time, the Governor is
3 authorized through executive authorization to provide up to
4 \$10,000,000 in Federal funds to alleviate the emergency
5 situation. For the purposes of this section, "emergency" is
6 defined as any situation in which there is a chance of or which
7 may result in substantial human suffering.

8 Section 1706. Transfer of funds from TANFBG to CCDFBG.--In
9 accordance with Federal law which permits the transfer of up to
10 30% of the TANFBG to the CCDFBG and the transfer of up to one-
11 third of such transferred funds to the SSBG, the Department of
12 Public Welfare, upon approval of the Secretary of the Budget,
13 may make such transfers of funds provided that any such transfer
14 will not result in a deficit in any appropriation from which
15 funds are transferred. The Secretary of the Budget shall provide
16 notification of any such transfers to the majority chairman and
17 the minority chairman of the Appropriations Committee of the
18 Senate and the majority chairman and minority chairman of the
19 Appropriations Committee of the House of Representatives ten
20 days prior to any transfer which shall also include
21 certification that such transfer will not result in a deficit in
22 any appropriation.

24 MISCELLANEOUS PROVISIONS FOR 1997-1998

25 Section 1801. Prior laws unaffected.--Except as provided in
26 section 253, this act is not intended to be inconsistent with or
27 to repeal any provision of any act enacted at this or any prior
28 session of the General Assembly regulating the purchase of
29 supplies, the ordering of printing and binding, the purchase,
30 maintenance and use of automobiles, the method of making

1 payments from the State Treasury for any purpose or the
2 functioning of any administrative department, board or
3 commission.

4 Section 1802. Compliance with other law before funds
5 available.--No appropriation made by this act to any department,
6 board, commission or agency of the Executive Department shall be
7 available unless and until the department, board, commission or
8 agency has complied with sections 615 and 616 of the act of
9 April 9, 1929 (P.L.177, No.175), known as The Administrative
10 Code of 1929.

11 Section 1803. Contracts prerequisite to encumbering or
12 committing funds.--Funds for the purchase of supplies, materials
13 and equipment shall not be deemed to be committed or encumbered
14 until contracts covering the purchase have been entered into
15 with the vendors.

16 Section 1804. Minority business set-asides.--(a) Each
17 department or other instrumentality of the Commonwealth listed
18 in Subpart A of Part II authorized to contract for buildings,
19 highways, commodities, equipment, supplies or services shall
20 report to the General Assembly all information pertinent to
21 anticipated procurement needs at the beginning of each fiscal
22 year and each fiscal quarter thereafter.

23 (b) As used in this section, the term "minority business"
24 means a minority business enterprise as defined in the act of
25 July 22, 1974 (P.L.598, No.206), known as the Pennsylvania
26 Minority Business Development Authority Act.

27 Section 1805. Appropriation of funds from miscellaneous
28 sources.--(a) In addition to the amounts appropriated by this
29 act, moneys received in payment for food and household supplies
30 furnished to employees and other persons, except inmates, by an

1 institution, and moneys received from the proceeds from the sale
2 of any products of the soil, meats, livestock, timber or other
3 materials sold by the department shall be paid into the General
4 Fund and are hereby appropriated out of the General Fund to the
5 several respective institutions for the operation and
6 maintenance of the institutions.

7 (b) In addition to the amounts appropriated by this act, all
8 moneys received from any other source, except the Federal
9 Government, as contributions for the programs provided herein or
10 as payment for services or materials furnished by one
11 institution to another, except those collections designated as
12 revenues, shall be paid into the General Fund and are hereby
13 appropriated out of the General Fund for the purposes of the
14 respective appropriations.

15 (c) In addition to any funds specifically appropriated by
16 this act, all moneys received by a department or agency of the
17 Commonwealth from any other sources, except the Federal
18 Government, as contributions or supplements to the department or
19 agency for a program or administration of an act included in
20 this act shall be paid into the General Fund and credited to the
21 appropriation for that program or administration of the act.

22 Section 1806. Lapsing of unused funds.--(a) Except as
23 otherwise provided by law or by this section, that part of all
24 appropriations in Parts II, III, IV, V, VI, VII, VIII, IX, X,
25 XI, XII, XIII, XIV and XV unexpended, uncommitted or
26 unencumbered as of June 30, 1998, shall automatically lapse as
27 of that date.

30 (B) THE APPROPRIATION IN SECTION 208 FOR FARM SAFETY <—

2 Section 1807. Appellate courts appropriation contingency.--
3 The funds appropriated in Part II to the Supreme, Superior and
4 Commonwealth Courts for justice expenses are contingent upon a
5 vouchered expense account plan being continued by the Supreme
6 Court.

7 Section 1808. Transfer of excess funds.--The Governor may
8 transfer any excess money in those funds receiving proceeds of
9 Commonwealth of Pennsylvania general obligation bonds in excess
10 of the amount necessary for the purposes for which the bonds
11 were issued to the appropriate sinking fund for payment of debt
12 service due on outstanding bonds. If such excess funds, together
13 with any available balance, exceed the amount of debt service
14 remaining to be paid, the funds shall be transferred to the
15 General Fund or to the appropriate special fund responsible for
16 such debt service.

17 Section 1809. Transfer of funds by the Supreme Court.--The
18 Supreme Court may transfer any excess funds appropriated to the
19 Judicial Department in Part II to the Judicial Computer
20 Augmentation Account during the month of June 1998. No transfer
21 may create or increase a deficiency in the appropriation from
22 which the transfer is made.

23 Section 1810. Transfer from Hazardous Sites Cleanup Fund.--
24 The sum of \$12,000,000 is transferred from the Hazardous Sites
25 Cleanup Fund to the Industrial Sites Cleanup Fund.

27 EFFECTIVE DATE

28 Section 1901. Effective date.--This act shall take effect
29 July 1, 1997, or immediately, whichever is later.
