AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as 2 reenacted, "An act relating to alcoholic liquors, alcohol and malt and brewed beverages; amending, revising, consolidating 3 4 and changing the laws relating thereto; regulating and 5 restricting the manufacture, purchase, sale, possession, 6 consumption, importation, transportation, furnishing, holding 7 in bond, holding in storage, traffic in and use of alcoholic 8 liquors, alcohol and malt and brewed beverages and the 9 persons engaged or employed therein; defining the powers and 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 12 for the payment of certain license fees to the respective 13 municipalities and townships, for the abatement of certain 14 nuisances and, in certain cases, for search and seizure 15 without warrant; prescribing penalties and forfeitures; providing for local option, and repealing existing laws," 16 17 prohibiting certain licensees from advertising on billboards within 1,000 feet of any real property on which a public, 18 private or parochial school is located. 19
- 20 The General Assembly of the Commonwealth of Pennsylvania
- 21 hereby enacts as follows:
- 22 Section 1. Section 493 of the act of April 12, 1951 (P.L.90,
- 23 No.21), known as the Liquor Code, reenacted and amended June 29,
- 24 1987 (P.L.32, No.14), is amended by adding a clause to read:

- 1 Section 493. Unlawful Acts Relative to Liquor, Malt and
- 2 Brewed Beverages and Licensees. -- The term "licensee, " when used
- 3 in this section, shall mean those persons licensed under the
- 4 provisions of Article IV, unless the context clearly indicates
- 5 otherwise.
- 6 It shall be unlawful--

- 8 (29) Advertising on Billboards. For any retail liquor
- 9 <u>licensee</u>, retail dispenser, distributor, importing distributor,
- 10 manufacturer, employe or one of their agents to advertise on
- 11 billboards within one thousand feet of real property on which a
- 12 public, private or parochial school is located.
- 13 Section 2. This act shall take effect in 60 days.
