L2	§ 703. Brandywine Battlefield.	
L3	(a) Park [commission] advisory council; membership; term of	
L4	office. The Brandywine Battlefield Park [Commission] Advisory	
L5	Council shall [be an independent administrative commission and	
L6	shall] consist of ten residents of this Commonwealth recommended	
L7	by the Pennsylvania Historical and Museum Commission and	
L8	appointed by the Governor [with the advice and consent of a	
L9	majority of the members elected to the Senate. The chairman of

- 2 an ex officio member of the park commission and may designate

- 13 (b) Organization of [park commission] advisory council.
- 14 Each year on the anniversary of the Battle of Brandywine,
- 15 September 11, 1777, or as near thereto as convenient, the [park
- 16 commission] advisory council shall elect from among its members
- 17 a chairman, [vice chairman,] secretary and [treasurer] other
- 18 officers as deemed necessary by the advisory council. The [park
- 19 commission] advisory council may adopt any rules of organization
- 20 and procedure as it may deem appropriate and may determine the
- 21 duties of its officers. Six members shall constitute a quorum.
- 22 Members of the [park commission] advisory council shall not
- 23 receive compensation [but shall receive reimbursement for their
- 24 actual expenses incurred in serving on the park commission].
- 25 (c) [Powers and duties of park commission] <u>Duties of</u>
- 26 <u>advisory council</u>. Notwithstanding the provisions of sections
- 27 303(1) and (3) (relating to sites) and 702 (relating to powers
- 28 over certain historic property), the [park commission] advisory
- 29 <u>council</u> shall [preserve the park as a patriotic and historic
- 30 place and shall have custody, control, management and

- 1 supervision of the park. The park commission shall have the 2 powers and duties to:
- (1) Submit to the Pennsylvania Historical and Museum

 Commission, by September 1 of each year, a report which shall

 include a summary of the park commission's activities during

 the preceding fiscal year.
 - (2) Submit to the Pennsylvania Historical and Museum

 Commission, by October 1 of each year, a preliminary plan,

 including a preliminary budget, for the park commission's

 activities during the next fiscal year.
 - (3) Submit to the Pennsylvania Historical and Museum

 Commission, by May 1 of each year, a final plan, including a

 final budget, for the park commission's activities during the

 next fiscal year.
- 15 (4) Provide for local input and foster local public
 16 support for programs and activities at the park.
- 17 (5) Encourage an appreciation of the historical

 18 significance of the park for the people of this Commonwealth.
- 19 (6) Cooperate with the Pennsylvania Historical and
 20 Museum Commission or any other Federal, State or local
 21 agency, or any private historical organization or foundation,
 22 in conducting programs or providing services to further
 23 improve or develop the park.
- 24 (7) Promulgate rules and regulations necessary for the 25 implementation of its power and duties.
- 26 (d) Agreement between commissions. By August 1 of each
 27 year, the Pennsylvania Historical and Museum Commission shall
 28 enter into an agreement with the park commission specifying the
 29 funding that will be made available to the park commission for
 30 the fiscal year which began on July 1 of that year. The

- 24 (a) Park [commission] advisory council; membership; term of
- 25 office. The Washington Crossing Park [Commission] Advisory
- 26 <u>Council</u> shall [be an independent administrative commission and
- 27 shall] consist of [ten] seven residents of this Commonwealth
- 28 recommended by the Pennsylvania Historical and Museum Commission
- 29 <u>and</u> appointed by the Governor [with the advice and consent of a
- 30 majority of the members elected to the Senate. The chairman of

- 1 the Pennsylvania Historical and Museum Commission shall serve as
- 2 an ex officio member of the park commission and may designate
- 3 another member of the Pennsylvania Historical and Museum
- 4 Commission or the Executive Director of the Pennsylvania
- 5 Historical and Museum Commission to represent the chairman at
- 6 meetings of the park commission]. Each member of the [park

- 17 (5) Encourage an appreciation of the historical

28	SECTION 2 3. ALL OF THE POWERS, DUTIES, FUNCTIONS, FUNDS, <
29	ASSETS, BOOKS, RECORDS AND ANY OTHER DOCUMENTS AND REAL AND
30	PERSONAL PROPERTY OF THE BRANDYWINE BATTLEFIELD PARK COMMISSION
