INTRODUCED BY MASLAND, OCTOBER 21, 1997

AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES, FEBRUARY 10, 1998

## AN ACT

Authorizing the Borough of Carlisle, Cumberland County, to sell certain Project 70 lands free of Project 70 restrictions in 3 return for use of the sale proceeds to assist the Central Pennsylvania Conservancy purchase a tract of land; AND 5 AUTHORIZING THE DEPARTMENT OF GENERAL SERVICES TO CONVEY A 6 TRACT OF LAND LOCATED IN SOMERSET TOWNSHIP, SOMERSET COUNTY. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Authorization. 10 SECTION 1. (A) AUTHORIZATION. -- Under the requirements of 11 section 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land Acquisition and Borrowing 12 13 Act, the General Assembly hereby authorizes the release of Project 70 restrictions from the two tracts of land described in 14 15 section 2 and owned by the Borough of Carlisle, Cumberland 16 County, in exchange for use of the sale proceeds to assist the Central Pennsylvania Conservancy purchase 15.03 acres of land 17 known as the Seven Gables Tract located in Carlisle Borough and 18 19 South Middleton Township.

- 1 Section 2. Land to be released from Project 70 restrictions.

- 21 (C) USE OF SALE PROCEEDS. -- The net proceeds, selling price

- 22 less expenses, from the sale of the land described in section 2
- shall be used by the Borough of Carlisle to assist the Central 23
- Pennsylvania Conservancy with purchase of the Seven Gables 24
- 25 Tract. Any of the net proceeds which are not provided to the
- 26 Central Pennsylvania Conservancy for the purchase of the Seven
- 27 Gables Tract shall be deposited into a special account
- 28 established by the Borough of Carlisle for acquisition or
- 29 development of other park lands.
- Section 4. Deed clause.

- 1 (D) DEED CLAUSE. -- The Central Pennsylvania Conservancy deed <-
- 2 to the Seven Gables Tract shall include the following clause:
- 3 "This land was acquired for recreation, conservation and
- 4 historical purposes as said purposes are defined in the
- 5 act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as
- 6 the Project 70 Land Acquisition and Borrowing Act."
- 7 SECTION 2. (A) AUTHORIZATION. -- THE DEPARTMENT OF GENERAL
- 8 SERVICES, WITH THE APPROVAL OF THE GOVERNOR, IS HEREBY
- 9 AUTHORIZED AND DIRECTED, ON BEHALF OF THE COMMONWEALTH OF
- 10 PENNSYLVANIA, TO GRANT AND CONVEY, SOMERSET CHRISTIAN
- 11 FELLOWSHIP, THE DESCRIBED TRACT OF LAND IN SUBSECTION (B) FOR
- 12 FAIR MARKET VALUE AS DETERMINED BY AN INDEPENDENT APPRAISAL.
- 13 (B) DESCRIPTION.--BEGINNING AT AN EXISTING IRON PIN/CAP AND
- 14 ON THE JURISDICTIONAL DIVISION LINE BETWEEN LANDS OF THE
- 15 SOMERSET CHRISTIAN FELLOWSHIP AND LANDS OF THE COMMONWEALTH OF
- 16 PENNSYLVANIA. THENCE ALONG LANDS OF THE COMMONWEALTH OF
- 17 PENNSYLVANIA AND THE SOMERSET CHRISTIAN FELLOWSHIP THE FOLLOWING
- 18 COURSES AND DISTANCES;

- 8 INCLUDING BUT NOT CONFINED TO, STREETS, ROADWAYS AND RIGHTS OF
- TELEPHONE, TELEGRAPH, WATER, ELECTRIC, SEWER, GAS OR PIPELINE
- 10 COMPANIES, AS WELL AS UNDER AND SUBJECT TO ANY INTEREST, ESTATES
- 11 OR TENANCIES VESTED IN THIRD PERSONS, WHETHER OR NOT APPEARING
- OF RECORD, FOR ANY PORTION OF THE LAND OR IMPROVEMENTS ERECTED 12
- 13 THEREON.
- 14 (D) DEED.--THE DEED OF CONVEYANCE SHALL BE APPROVED AS
- 15 PROVIDED BY LAW AND SHALL BE EXECUTED BY THE SECRETARY OF
- 16 GENERAL SERVICES IN THE NAME OF THE COMMONWEALTH OF
- 17 PENNSYLVANIA.
- 18 (E) COSTS.--THE COSTS AND FEES INCIDENTAL TO THIS CONVEYANCE
