- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for contempt for
- 3 violation of protection order or agreement and for civil
- 4 contempt.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 6114(b) and 6114.1(c) of Title 23 of the
- 8 Pennsylvania Consolidated Statutes are amended to read:
- 9 § 6114. Contempt for violation of order or agreement.
- 10 * * *
- 11 (b) Trial and punishment. -- A sentence for contempt under
- 12 this chapter may include imprisonment up to [six months] one
- 13 year or a fine of not less than [\$100] \$500 nor more than
- 14 [\$1,000] \$5,000, or both, and may include other relief set forth
- 15 in this chapter. All moneys received under this section shall be
- 16 forwarded to the Commonwealth and shall be used by the
- 17 Pennsylvania State Police to establish and maintain the

- 1 Statewide registry of protection orders provided for in section
- 2 6105 (relating to responsibilities of law enforcement agencies).
- 3 The defendant shall not have a right to a jury trial on such a
- 4 charge; however, the defendant shall be entitled to counsel.

- 6 § 6114.1. Civil contempt or modification for violation of an
- 7 order or agreement.

- 9 (c) Sentencing. -- A sentence for civil contempt under this
- 10 chapter may include imprisonment until the defendant complies
- 11 with provisions in the order or consent agreement or
- 12 demonstrates the intent to do so, but in no case shall a term of
- 13 imprisonment under this section exceed a period of [six months]
