- 3 (C) APPROVAL OF EQUIPMENT.--THE DEPARTMENT MAY APPROVE OR
- 4 DISAPPROVE PROTECTIVE HEADGEAR AND EYE-PROTECTIVE DEVICES
- 5 REQUIRED UNDER THIS SECTION AND MAY ISSUE AND ENFORCE
- 6 REGULATIONS ESTABLISHING STANDARDS AND SPECIFICATIONS FOR THE
- 7 APPROVAL OF THE HEADGEAR AND DEVICES. THE DEPARTMENT SHALL
- 8 PUBLISH LISTS OF ALL PROTECTIVE HEADGEAR AND EYE-PROTECTIVE

- 17 <u>(3) A PERSON 21 YEARS OF AGE OR OLDER WHO HAS COMPLETED</u>
- 18 A MOTORCYCLE RIDER SAFETY COURSE APPROVED BY THE DEPARTMENT
- 19 OR THE MOTORCYCLE SAFETY FOUNDATION.
- 20 (4) THE PASSENGER OF A PERSON EXEMPT UNDER THIS
- 21 SUBSECTION, IF THE PASSENGER IS 21 YEARS OF AGE OR OLDER.
- 22 (E) REPORT TO GENERAL ASSEMBLY. -- ONE YEAR AFTER THE
- 23 EFFECTIVE DATE OF THIS SECTION THE LEGISLATIVE BUDGET AND
- 24 FINANCE COMMITTEE SHALL COMMENCE A STUDY TO DETERMINE:
- 25 (1) WHAT, IF ANY, INCREASED INJURIES AND FATALITIES MAY
- 26 <u>BE ATTRIBUTED TO THE EXCEPTIONS HEREUNDER PROVIDED;</u>
- 27 (2) THE EXTENT TO WHICH PERSONS INCURRING SUCH INJURIES
- 28 OR FATALITIES HAVE MAINTAINED INSURANCE COVERAGE FOR MEDICAL
- 29 <u>COSTS ASSOCIATED WITH SUCH INJURIES OR FATALITIES; AND</u>
- 30 (3) THE RESULTING NEED, IF ANY, FOR THE IMPOSITION OF

- 1 MANDATES ON INSURERS TO PROVIDE AFFORDABLE MEDICAL INSURANCE
- 2 <u>COVERAGE FOR SUCH PERSONS FOR MEDICAL EXPENSES THAT MAY BE</u>
- 3 ATTRIBUTED TO THE EXCEPTIONS HEREUNDER PROVIDED AND ON SUCH
- 4 PERSONS TO MAINTAIN COVERAGE TO THE EXTENT THAT IT IS
- 5 AVAILABLE AND REASONABLY AFFORDABLE. THIS STUDY SHALL BE
- 6 FILED WITH THE TRANSPORTATION COMMITTEE OF THE SENATE AND THE
