AN ACT

Making an appropriation from a restricted revenue account within the General Fund to the Office of Small Business Advocate in 2 the Department of Community and Economic Development. AMENDING THE ACT OF OCTOBER 16, 1998 (P.L., NO.44A), ENTITLED, "A SUPPLEMENT TO THE ACT OF JULY 7, 1972 (P.L.743, 6 NO.176), ENTITLED 'AN ACT PROVIDING FOR THE ESTABLISHMENT AND 7 OPERATION OF LINCOLN UNIVERSITY AS AN INSTRUMENTALITY OF THE 8 COMMONWEALTH TO SERVE AS A STATE-RELATED INSTITUTION IN THE HIGHER EDUCATION SYSTEM OF THE COMMONWEALTH; PROVIDING FOR 9 CHANGE OF NAME; PROVIDING FOR THE COMPOSITION OF THE BOARD OF 10 11 TRUSTEES; TERMS OF TRUSTEES, AND THE POWER AND DUTIES OF SUCH 12 TRUSTEES; PROVIDING FOR PREFERENCE TO PENNSYLVANIA RESIDENTS 13 IN TUITION; AUTHORIZING APPROPRIATIONS IN AMOUNTS TO BE FIXED ANNUALLY BY THE GENERAL ASSEMBLY; PROVIDING FOR THE AUDITING 14 15 OF ACCOUNTS OF EXPENDITURES FROM SAID APPROPRIATIONS; 16 PROVIDING FOR PUBLIC SUPPORT AND CAPITAL IMPROVEMENTS; 17 AUTHORIZING THE ISSUANCE OF BONDS EXEMPT FROM TAXATION WITHIN 18 THE COMMONWEALTH; REQUIRING THE PRESIDENT TO MAKE AN ANNUAL 19 REPORT OF THE OPERATIONS OF LINCOLN UNIVERSITY, ' MAKING 20 APPROPRIATIONS FOR CARRYING THE SAME INTO EFFECT; PROVIDING FOR A BASIS FOR PAYMENTS OF SUCH APPROPRIATIONS; AND 21 22 PROVIDING A METHOD OF ACCOUNTING FOR THE FUNDS APPROPRIATED 23 AND FOR CERTAIN FISCAL INFORMATION DISCLOSURE, PROVIDING AN 24 ADDITIONAL APPROPRIATION FOR THE PERIOD JANUARY 1, 1999 TO 25 JUNE 30, 1999. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- 28 Section 1. The sum of \$905,000 is hereby appropriated from

- 1 the restricted revenue account within the General Fund to the
- 2 Office of Small Business Advocate in the Department of Community
- 3 and Economic Development to provide for the operation of that
- 4 office for the fiscal year July 1, 1997, to June 30, 1998.
- 5 Section 2. This act shall take effect July 1, 1997, or
- 6 immediately, whichever is later.

- 20 ISSUANCE OF BONDS EXEMPT FROM TAXATION WITHIN THE COMMONWEALTH;
- 21 REQUIRING THE PRESIDENT TO MAKE AN ANNUAL REPORT OF THE
- 22 OPERATIONS OF LINCOLN UNIVERSITY, 'MAKING APPROPRIATIONS FOR
- 23 CARRYING THE SAME INTO EFFECT; PROVIDING FOR A BASIS FOR
- 24 PAYMENTS OF SUCH APPROPRIATIONS; AND PROVIDING A METHOD OF
- 25 ACCOUNTING FOR THE FUNDS APPROPRIATED AND FOR CERTAIN FISCAL

- 28 NECESSARY, IS HEREBY APPROPRIATED TO THE TRUSTEES OF LINCOLN
- 29 UNIVERSITY, CHESTER COUNTY, FOR THE PERIOD JANUARY 1, 1999, TO
- 30 JUNE 30, 1999, FOR THE PURPOSES AND IN THE AMOUNTS AS SHOWN:

- 8 SECTION 6.1. (A) PAYMENTS TO LINCOLN UNIVERSITY OF THE
- APPROPRIATION PROVIDED IN SECTION 2.1 SHALL BE MADE MONTHLY
- DURING THE PERIOD JANUARY 1, 1999, TO JUNE 30, 1999. 10
- 11 (B) SUCH MONTHLY PAYMENTS SHALL BE MADE IN ACCORDANCE WITH
- 12 THE PROVISIONS OF SECTION 5.1 ON THE BASIS OF ESTIMATED COSTS.
- 13 THE ESTIMATE OF COSTS SHALL BE SUBMITTED BY LINCOLN UNIVERSITY
- 14 TO THE SECRETARY OF EDUCATION, THE GENERAL ASSEMBLY AND THE
- 15 STATE TREASURER NOT LATER THAN 30 DAYS PRIOR TO THE DATE ON
