14	Section 1. (a) Authorization Under the requirements of	
15	section 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131,	
16	No.8), known as the Project 70 Land Acquisition and Borrowing	
17	Act, the General Assembly hereby authorizes the release of	
18	Project 70 restrictions from the two tracts of land described in	
19	subsection (b) and owned by the Borough of Carlisle, Cumberland	
20	County, in exchange for use of the sale proceeds to assist the	
21	Central Pennsylvania Conservancy purchase 15.03 15.16 acres of	<
22	land known as the Seven Gables Tract located in Carlisle Borough

- 22 TOWNSHIP, BOUNDED AND DESCRIBED AS FOLLOWS:
- 23 BEGINNING AT A POINT AT THE DIVISION LINE BETWEEN LOTS 3A AND 3B
- 24 OF THE HEREINAFTER REFERENCED PLAN OF LOTS; THENCE NORTH 12

- 12 MINUTES 40 SECONDS WEST A DISTANCE OF 779.72 FEET; THENCE ALONG
- 13 LANDS NOW OR FORMERLY OF JEFFREY S. SMITH NORTH 37 DEGREES 36
- 14 MINUTES 20 WEST A DISTANCE OF 147.53 FEET TO A REBAR; THENCE
- 15 ALONG THE SAME NORTH 75 DEGREES 54 MINUTES 20 SECONDS WEST A
- 16 DISTANCE OF 437.37 FEET TO A CONCRETE MONUMENT, BEING THE PLACE
- 17 OF BEGINNING.
- 18 CONSISTING OF 15.16 ACRES.
- 19 BEING LOT 3B OF THE SUBDIVISION PLAN OF SEVEN GABLES TRACT TO BE
- 20 RECORDED IN THE CUMBERLAND COUNTY RECORDER OF DEEDS OFFICE.
- 21 BEING A PORTION OF THE LAND CONVEYED TO SEVEN GABLES ESTATE AS
- 22 NOTED IN DEED 23 P, PAGE 730 AS RECORDED IN THE CUMBERLAND
- 23 COUNTY RECORDER OF DEEDS OFFICE.
- 24 (c) (D) Use of sale proceeds.--The net proceeds, selling
- 25 price less expenses, from the sale of the land described in
- 26 subsection (b) shall be used by the Borough of Carlisle to
- 27 assist the Central Pennsylvania Conservancy with purchase of the

- 28 Seven Gables Tract. Any of the net proceeds which are not
- 29 provided to the Central Pennsylvania Conservancy for the
- 30 purchase of the Seven Gables Tract shall be deposited into a

- 1 special account established by the Borough of Carlisle for
- 2 acquisition or development of other park lands.
- 3 (d) (E) Deed clause. -- The Central Pennsylvania Conservancy

- 4 deed to the Seven Gables Tract shall include the following
- 5 clause:
- 6 "This land was acquired for recreation, conservation and
- 7 historical purposes as said purposes are defined in the
- 8 act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as
- 9 the Project 70 Land Acquisition and Borrowing Act."
- 10 Section 2. (a) Authorization.--Pursuant to the requirements
- 11 of section 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131,
- 12 No.8), known as the Project 70 Land Acquisition and Borrowing
- 13 Act, the General Assembly hereby authorizes the release of the
- 14 restrictions imposed by section 20 of the Project 70 Land
- 15 Acquisition and Borrowing Act, from the lands owned by the
- 16 Township of Hempfield, Westmoreland County, and more
- 17 particularly described in subsection (c) in exchange for the
- 18 imposition of the section 20 restrictions on lands to be
- 19 conveyed to the Township of Hempfield from Robert E. and Ella J.
- 20 Griffith and more particularly described in subsection (d).
- 21 (b) Freedom of restrictions.--The lands described in
- 22 subsection (c) and owned by the Township of Hempfield,
- 23 Westmoreland County, shall be free of the restrictions on use
- 24 and alienation imposed by section 20 of the act of June 22, 1964
- 25 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land
- 26 Acquisition and Borrowing Act, upon the imposition of and
- 27 recording of the Project 70 deed restrictions set forth in
- 28 subsection (e) on the parcel of replacement land described in
- 29 subsection (d) to be conveyed to the Township of Hempfield from
- 30 Robert E. and Ella J. Griffith contemporaneously with the

- 1 conveyance of land described in subsection (c).
- 2 (c) Land to be free from restrictions. -- The parcel of land
- 3 authorized to be released from restrictions is more particularly
- 4 described as follows:
- 5 All that parcel of land located in Hempfield Township,
- 6 Westmoreland County, Pennsylvania, described as follows:
- 7 Beginning at a point at the southwest corner of the parcel of
- 8 land of Robert E. and Ella J. Griffith described in subsection
- 9 (d), which point is at or near the center of S.R. 1032; thence
- 10 along the approximate center of S.R. 1032 south 19 degrees 00
- 11 minutes 19 seconds west 61.00 feet to a point in the approximate
- 12 center of S.R. 1032; thence, along other land of Hempfield
- 13 Township, north 74 degrees 17 minutes 40 seconds west 488.232
- 14 feet to a point at land now or formerly of William E. and Pamela
- 15 M. Pershing; thence along the land of William E. and Pamela M.
- 16 Pershing north 76 degrees 48 minutes east 125.989 feet to an oak
- 17 tree; thence along other land of Robert E. and Ella J. Griffith
- 18 south 74 degrees 17 minutes 40 seconds east 381.45 feet to the
- 19 place of beginning.
- 20 Containing 0.6079 acres of land.
- 21 (d) Land on which restrictions are to be imposed. -- The
- 22 replacement parcel to be subject to restrictions in exchange for
- 23 the parcel described in subsection (c) is more particularly
- 24 described as follows:
- 25 All that certain tract or parcel of land situate in the
- 26 Township of Hempfield, County of Westmoreland, Commonwealth of
- 27 Pennsylvania, bounded and described as follows:
- 28 Beginning at a point at the northeast corner of the parcel of
- 29 land of Hempfield Township described in subsection (c), which
- 30 point is at or near the center of S.R. 1032; thence north 14

- 1 degrees 15 minutes east 100.00 feet to a telephone line on land
- 2 of Robert E. and Ella J. Griffith; thence north 83 degrees 09
- 3 minutes 30 seconds east 112.44 feet to the approximate center
- 4 line of S.R. 1032; thence south 40 degrees 00 minutes 00 seconds
- 5 east 240.40 feet to a point at land of Hempfield Township;
- 6 thence along the land of Hempfield Township north 75 degrees 45
- 7 minutes west 300.00 feet to the place of beginning.
- 8 Containing 0.604 acres of land.
- 9 (e) Description of deed restrictions. -- The deed restrictions
- 10 to be transferred to the parcel described in subsection (d)
- 11 shall read as follows:
- 12 This indenture is given to provide land for recreation,
- 13 conservation and historical purposes as said purposes are
- 14 defined in the act of June 22, 1964 (Sp.Sess., P.L.131, No.8),
- 15 known as the Project 70 Land Acquisition and Borrowing Act.
- 16 (f) Conveyance to Robert E. and Ella J. Griffith.--The
- 17 Township of Hempfield, Westmoreland County, is hereby authorized
- 18 to convey the premises described in subsection (c) to Robert E.
- 19 and Ella J. Griffith in exchange for the premises described in
- 20 subsection (d).
- 21 Section 3. This act shall take effect immediately.
