## AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania 1 2 Consolidated Statutes, further providing for advisory 3 councils for veterans' homes and for pay of members on special duty; AND PROVIDING FOR THE CHARITABLE STATUS OF 4

5 CERTAIN VETERANS' ORGANIZATIONS.

- 8 Section 1. Sections 704(a) and 3101 of Title 51 of the
- Pennsylvania Consolidated Statutes are amended to read:
- 10 § 704. Advisory councils for veterans' homes.
- Establishment of advisory council. -- There is hereby 11
- 12 established an advisory council for each veterans' home operated
- by the Commonwealth. Each advisory council shall consist of [11]
- 15 members and the Adjutant General, who shall serve ex officio. 14
- 15 [Eight] Twelve of the members shall be appointed by the Governor
- from a list of nominations submitted to the Adjutant General by 16
- the Pennsylvania War Veterans' Council. The Speaker of the House 17
- 18 of Representatives and the President pro tempore of the Senate

- 1 shall each appoint one member from their respective bodies to
- 2 serve on each council. The remaining member on the advisory
- 3 council shall be selected by the residents of the veterans'
- 4 homes.

- 6 § 3101. Pay of officers and enlisted personnel on special duty.
- 7 [Commissioned officers] Members of the Pennsylvania National
- 8 Guard or Pennsylvania Guard may be ordered upon special duty at
- 9 the discretion of the Governor and shall receive the pay and
- 10 allowances of their respective grades during the time they may
- 11 continue upon duty under such order.

- 13 § 9303. CHARITABLE STATUS OF CERTAIN VETERANS' ORGANIZATIONS.

This act shall take effect as follows: 5 (1) The amendment of 51 Pa.C.S. § 704 shall take effect 6 7 in 60 days. (2) The amendment of 51 Pa.C.S. § 3101 shall take effect < 8 9 immediately.
