## AN ACT

- 1 Providing for a program to promote economic development in
- downtown areas; establishing the Discover Pennsylvania's
- 3 Downtowns program; further providing for duties of the
- 4 Department of Community and Economic Development; and making
- 5 an appropriation.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Discover
- 10 Pennsylvania's Downtowns Act.
- 11 Section 2. Legislative findings and declaration.
- 12 The General Assembly finds and declares that downtown areas
- 13 throughout Pennsylvania offer unique cultural, business and
- 14 historic attractions. Each county should be afforded the
- 15 opportunity to market and promote a downtown area and to
- 16 highlight the area's attractions. Improving the infrastructure
- 17 and encouraging economic development in downtown areas could
- 18 decrease crime, reduce unemployment and stabilize shrinking tax
- 19 bases. It is in the best interest of the Commonwealth to

- 1 facilitate the revitalization of downtown areas within our
- 2 communities.
- 3 Section 3. Definitions.
- 4 The following words and phrases when used in this act shall
- 5 have the meanings given to them in this section unless the
- 6 context clearly indicates otherwise:
- 7 "Applicant." The mayor for first class counties. The county
- 8 commissioners for all other counties.
- 9 "Department." The Department of Community and Economic
- 10 Development of the Commonwealth.
- 11 "Downtown area." The central business district of a city,
- 12 borough or township which has traditionally served as a retail,
- 13 service, cultural and communal focal point within a community of
- 14 this Commonwealth.
- 15 Section 4. Establishment of program.
- 16 There is hereby established within the department the
- 17 Discover Pennsylvania's Downtowns program for the purpose of
- 18 making available to each county the opportunity to market and
- 19 promote a downtown area.
- 20 Section 5. Powers and duties.
- 21 The department shall develop written guidelines and
- 22 promulgate regulations necessary to implement the Discover
- 23 Pennsylvania's Downtowns program. These guidelines and
- 24 regulations shall include, but not be limited to, a formal
- 25 notification procedure designed to advise each applicant how to
- 26 apply for funds. The regulations shall also include a \$100,000
- 27 maximum per county per fiscal year.
- 28 Section 6. Appropriation.
- The sum of \$6,750,000, or as much thereof as may be
- 30 necessary, is appropriated to the Department of Community and

- 1 Economic Development for the Discover Pennsylvania's Downtowns
- 2 program.
- 3 Section 7. Effective date.
- 4 This act shall take effect immediately.
