AN ACT

- Amending the act of June 28, 1935 (P.L.477, No.193), entitled, 2 as amended, "An act providing for the payment of the salary, 3 medical and hospital expenses of members of the State Police 4 Force, of the enforcement officers and investigators employed 5 by the Pennsylvania Liquor Control Board, and the parole 6 agents, enforcement officers and investigators of the 7 Pennsylvania Board of Probation and Parole, Capitol Police 8 officers, correction officers employed by the Department of 9 Corrections whose principal duty is the care, custody and 10 control of inmates, psychiatric security aides employed by the Department of Public Welfare and the Department of 11 Corrections whose principal duty is the care, custody, and 12 13 control of the criminally insane, and drug enforcement agents of the Office of Attorney General whose principal duty is the 14 15 enforcement of the drug laws of the Commonwealth, members of 16 the Delaware River Port Authority Police and of policemen, 17 firemen and park guards by the Commonwealth of Pennsylvania, the Delaware River Port Authority, counties, cities, 18 19 boroughs, towns and townships, who are injured or contract 20 certain diseases in the performance of their duty; and 21 providing that absence during such injury shall not reduce any usual sick leave period, " extending benefits to certain 22 23 county sheriffs and deputy sheriffs.
- 24 The General Assembly of the Commonwealth of Pennsylvania
- 25 hereby enacts as follows:
- 26 Section 1. The title and section 1 of the act of June 28,

- 2 Disability Benefits Law, amended December 19, 1996 (P.L.1438,
- 3 No.183), are amended to read:
- 4 AN ACT
- 5 Providing for the payment of the salary, medical and hospital
- 6 expenses of members of the State Police Force, of the
- 7 enforcement officers and investigators employed by the
- 8 Pennsylvania Liquor Control Board, and the parole agents,
- 9 enforcement officers and investigators of the Pennsylvania
- 10 Board of Probation and Parole, Capitol Police officers,
- 11 correction officers employed by the Department of Corrections
- 12 whose principal duty is the care, custody and control of
- inmates, psychiatric security aides employed by the
- 14 Department of Public Welfare and the Department of
- 15 Corrections whose principal duty is the care, custody, and
- 16 control of the criminally insane, drug enforcement agents of
- 17 the Office of Attorney General whose principal duty is the
- 18 enforcement of the drug laws of the Commonwealth, special
- 19 agents of the Office of Attorney General whose principal duty
- is the enforcement of the criminal laws of the Commonwealth,
- 21 members of the Delaware River Port Authority Police and of
- 22 policemen, <u>county sheriff or deputy sheriff</u>, firemen and park
- 23 guards by the Commonwealth of Pennsylvania, the Delaware
- 24 River Port Authority, counties, cities, boroughs, towns and
- townships, who are injured or contract certain diseases in
- the performance of their duty; and providing that absence
- 27 during such injury shall not reduce any usual sick leave
- 28 period.
- 29 Section 1. (a) Be it enacted, &c., That any member of the
- 30 State Police Force, any enforcement officer or investigator

- 1 employed by the Pennsylvania Liquor Control Board, and the
- 2 parole agents, enforcement officers and investigators of the
- 3 Pennsylvania Board of Probation and Parole, Capitol Police
- 4 officers, correction officers employed by the Department of
- 5 Corrections, whose principal duty is the care, custody and
- 6 control of inmates, psychiatric security aides employed by the
- 7 Department of Public Welfare and the Department of Corrections,
- 8 whose principal duty is the care, custody, and control of the
- 9 criminally insane, drug enforcement agents of the Office of
- 10 Attorney General whose principal duty is the enforcement of the
- 11 drug laws of the Commonwealth, special agents of the Office of
- 12 Attorney General whose principal duty is the enforcement of the
- 13 criminal laws of the Commonwealth, any member of the Delaware
- 14 River Port Authority Police or any policeman, fireman or park
- 15 guard of any county, city, borough, town or township, who is
- 16 injured in the performance of his duties including, in the case
- 17 of firemen, duty as special fire police, and by reason thereof
- 18 is temporarily incapacitated from performing his duties, shall
- 19 be paid by the Commonwealth of Pennsylvania if a member of the
- 20 State Police Force or an enforcement officer or investigator
- 21 employed by the Pennsylvania Liquor Control Board or the parole
- 22 agents, enforcement officers and investigators of the
- 23 Pennsylvania Board of Probation and Parole, Capitol Police
- 24 officers, correction officers employed by the Department of
- 25 Corrections, whose principal duty is the care, custody and
- 26 control of inmates, psychiatric security aides employed by the
- 27 Department of Public Welfare and the Department of Corrections,
- 28 whose principal duty is the care, custody, and control of the
- 29 criminally insane, drug enforcement agents of the Office of
- 30 Attorney General whose principal duty is the enforcement of the

- 1 drug laws of the Commonwealth, special agents of the Office of
- 2 Attorney General whose principal duty is the enforcement of the
- 3 criminal laws of the Commonwealth, or by the Delaware River Port
- 4 Authority if a member of the Delaware River Port Authority
- 5 Police or by the county, township or municipality, by which he
- 6 is employed, his full rate of salary, as fixed by ordinance or
- 7 resolution, until the disability arising therefrom has ceased.
- 8 All medical and hospital bills, incurred in connection with any
- 9 such injury, shall be paid by the Commonwealth of Pennsylvania
- 10 or by the Delaware River Port Authority or by such county,
- 11 township or municipality. During the time salary for temporary
- 12 incapacity shall be paid by the Commonwealth of Pennsylvania or
- 13 by the Delaware River Port Authority or by the county, city,
- 14 borough, town or township, any workmen's compensation, received
- 15 or collected by any such employe for such period, shall be
- 16 turned over to the Commonwealth of Pennsylvania or to the
- 17 Delaware River Port Authority or to such county, city, borough,
- 18 town or township, and paid into the treasury thereof, and if
- 19 such payment shall not be so made by the employe the amount so
- 20 due the Commonwealth of Pennsylvania, the Delaware River Port
- 21 Authority or the county, city, borough, town or township shall
- 22 be deducted from any salary then or thereafter becoming due and
- 23 owing.
- 24 (b) In the case of the State Police Force, enforcement
- 25 officers and investigators employed by the Pennsylvania Liquor
- 26 Control Board and the parole agents, enforcement officers and
- 27 investigators of the Pennsylvania Board of Probation and Parole,
- 28 Capitol Police officers, correction officers employed by the
- 29 Department of Corrections, whose principal duty is the care,
- 30 custody and control of inmates, psychiatric security aides

- 1 employed by the Department of Public Welfare and the Department
- 2 of Corrections whose principal duty is the care, custody, and
- 3 control of the criminally insane, drug enforcement agents of the
- 4 Office of Attorney General whose principal duty is the
- 5 enforcement of the drug laws of the Commonwealth, special agents
- 6 of the Office of Attorney General whose principal duty is the
- 7 enforcement of the criminal laws of the Commonwealth, members of
- 8 the Delaware River Port Authority Police and salaried policemen,
- 9 <u>county sheriffs and deputy sheriffs</u> and firemen who have served
- 10 for four consecutive years or longer, diseases of the heart and
- 11 tuberculosis of the respiratory system, contracted or incurred
- 12 by any of them after four years of continuous service as such,
- 13 and caused by extreme overexertion in times of stress or danger
- 14 or by exposure to heat, smoke, fumes or gases, arising directly
- 15 out of the employment of any such member of the State Police
- 16 Force, enforcement officer, investigator employed by the
- 17 Pennsylvania Liquor Control Board, guard or enforcement officer
- 18 employed by the Department of Corrections or parole agent,
- 19 enforcement officer or investigator of the Pennsylvania Board of
- 20 Probation and Parole, Capitol Police officers, correction
- 21 officers employed by the Department of Corrections whose
- 22 principal duty is the care, custody and control of inmates,
- 23 psychiatric security aides employed by the Department of Public
- 24 Welfare and the Department of Corrections whose principal duty
- 25 is the care, custody, and control of the criminally insane, drug
- 26 enforcement agents of the Office of Attorney General whose
- 27 principal duty is the enforcement of the drug laws of the
- 28 Commonwealth, special agents of the Office of Attorney General
- 29 whose principal duty is the enforcement of the criminal laws of
- 30 the Commonwealth, member of the Delaware River Port Authority

- 1 Police, or policeman, county sheriff and deputy sheriff or
- 2 fireman, shall be compensable in accordance with the terms
- 3 hereof; and unless any such disability shall be compensable
- 4 under the compensation laws as having been caused by accidental
- 5 injury, such disability shall be compensable as occupational
- 6 disease disabilities are presently compensable under the
- 7 compensation laws of this Commonwealth. It shall be presumed
- 8 that tuberculosis of the respiratory system contracted or
- 9 incurred after four consecutive years of service was contracted
- 10 or incurred as a direct result of employment.
- 11 (c) In the case of any person receiving benefits pursuant to
- 12 this act, the statutes of limitations set forth in sections
- 13 306.1, 315, 413, and 434 of the act of June 2, 1915 (P.L.736,
- 14 No.338), known as "The Pennsylvania Workmen's Compensation Act,"
- 15 shall not begin to run until the expiration of the receipt of
- 16 benefits pursuant to this act.
- 17 (d) All payments herein required to be made by the
- 18 Commonwealth of Pennsylvania on account of any member of the
- 19 State Police Force shall be made from moneys appropriated to the
- 20 Pennsylvania State Police, and any payments required to be made
- 21 on account of any enforcement officer or investigator employed
- 22 by the Pennsylvania Liquor Control Board shall be from
- 23 appropriations out of the State Stores Fund, any payments
- 24 required to be made on account of any parole agent, enforcement
- 25 officer or investigator employed by the Pennsylvania Board of
- 26 Probation and Parole shall be from moneys appropriated to the
- 27 Pennsylvania Board of Probation and Parole, any payments
- 28 required to be made on account of Capitol Police officers shall
- 29 be made from moneys appropriated to the Department of General
- 30 Services, any payments required to be made on account of any

- 1 correction officer shall be made from moneys appropriated to the
- 2 Department of Corrections, any payments required to be made on
- 3 account of any psychiatric security aides shall be made from
- 4 moneys appropriated to the Department of Public Welfare or the
- 5 Department of Corrections where appropriate, and any payments
- 6 required to be made on account of any drug enforcement agent or
- 7 special agents shall be made from moneys appropriated to the
- 8 Office of Attorney General.
- 9 Section 2. This act shall take effect immediately.
