AN ACT

- 1 Establishing, on a demonstration basis, a volunteer service
 - credit program; and providing for powers and duties of the
- 3 Department of Aging.

- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Volunteer
- 8 Service Credit Program for Older Adults and Disabled Act.
- 9 Section 2. Legislative intent.
- 10 It is the intent of the General Assembly to establish a
- 11 demonstration program which provides service credits to
- 12 volunteers who provide in-home services to senior citizens or
- 13 adults with disabilities in this Commonwealth and to guarantee
- 14 that volunteers can exchange service credits earned for receipt
- 15 of in-home services at such time when they become elderly or
- 16 disabled and are in need of services.

- 1 Section 3. Definitions.
- 2 The following words and phrases when used in this act shall
- 3 have the meanings given to them in this section unless the
- 4 context clearly indicates otherwise:
- 5 "Adult with disabilities." A person with physical or mental
- 6 disabilities who is 18 years of age or older and who is eligible
- 7 for public disability benefits or a State-supported program for
- 8 persons with disabilities.
- 9 "Department." The Department of Aging of the Commonwealth.
- 10 "In-home services." Health and social services and other
- 11 assistance required to enable older adults or persons with
- 12 disabilities to remain in their homes. The term includes, but is
- 13 not limited to, home health aide services, attendant care
- 14 services, companion services, chore and homemaker services and
- 15 respite care.
- 16 "Older adult." A resident of this Commonwealth who is 65
- 17 years of age or older.
- 18 "Program." The Demonstration Volunteer Service Credit
- 19 Program established by this act.
- 20 "Provider." A public or private nonprofit agency awarded a
- 21 grant under this act.
- 22 Section 4. Establishment of program.
- 23 The Demonstration Volunteer Service Credit Program is
- 24 established to serve older adults and adults with disabilities.
- 25 The program shall be administered by the department in at least
- 26 five sites throughout this Commonwealth.
- 27 Section 5. Program guidelines.
- 28 (a) Standard of operations. -- The department shall develop
- 29 standards for the operation of the program at the sites and
- 30 solicit proposals from and provide grants to providers which

- 1 meet those standards.
- 2 (b) Mandatory services. -- The program shall provide, at a
- 3 minimum, the following services:
- 4 (1) A training program which gives volunteers the skills
- 5 necessary for the safe and efficient provision of in-home
- 6 services.
- 7 (2) Organization, supervision and dispatch of
- 8 volunteers.
- 9 (3) Recruitment of volunteers.
- 10 (4) Determination of eligibility of persons requesting
- 11 services.
- 12 (5) An accounting system to track service credits earned
- and spent by volunteers.
- 14 Section 6. Powers and duties of department.
- 15 (a) Central registry.--The department shall develop and
- 16 maintain a central registry to receive from providers, on a
- 17 monthly basis, service credits earned and spent by volunteers.
- 18 The registry shall consist of individual accounts in which the
- 19 number of service credits earned and spent by each volunteer is
- 20 tabulated as necessary.
- 21 (b) Recruitment of volunteers. -- The department shall develop
- 22 a public awareness campaign designed to recruit volunteers for
- 23 participation in the program.
- 24 (c) Rules and regulations. -- The department shall promulgate
- 25 the rules and regulations necessary for the implementation of
- 26 this act. Regulations shall include a ratio for the exchange of
- 27 service credits to in-home services provided.
- 28 (d) Report to General Assembly. -- The department shall make a
- 29 report to the General Assembly on the level of participation in
- 30 the program once each fiscal year.

- 1 Section 7. Eligibility.
- 2 Any older adult or adult with disabilities who is a resident
- 3 of this Commonwealth and who needs in-home services is eligible
- 4 for the services provided through this act.
- 5 Section 8. Contingency plan.
- 6 The department shall develop a contingency plan for using
- 7 staff and programs to guarantee that in-home services are
- 8 available in return for credit in the event that no appropriate
- 9 volunteer is available.
- 10 Section 9. Confidentiality.
- 11 All documents and records concerning persons receiving in-
- 12 home services shall be kept confidential and, without the
- 13 consent of persons receiving in-home services, may not be
- 14 released or the contents thereof disclosed to anyone except
- 15 persons engaged in the provision of in-home services.
- 16 Section 10. Immunity.
- 17 (a) General rule. -- No person shall be held civilly liable
- 18 for actions performed as a volunteer in the program established
- 19 under this act if that person acted in good faith and not
- 20 falsely, corruptly, maliciously or without reasonable cause.
- 21 (b) Limitation.--A cause of action based upon gross
- 22 negligence or incompetence shall not be affected by the
- 23 immunities granted by this section.
- 24 Section 11. Funding.
- 25 The Department of Aging shall apply for and use all Federal
- 26 funds which may be available for volunteer service credit
- 27 programs.
- 28 Section 12. Effective date.
- 29 This act shall take effect January 1, 2000, or immediately,
- 30 whichever is later.
