AN ACT

- 1 Providing incentives and assistance for rural students to attend 2 college; and making an appropriation.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Rural
- 7 Education Opportunity Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Board." The State Rural Education Opportunity Board.
- 13 "Department." The Department of Education of the
- 14 Commonwealth.
- 15 "Program." The Rural Education Opportunity Program.
- 16 "Rural school district." A school district with fewer than

- 1 300 persons per square mile and postsecondary participation
- 2 rates below the State average in at least one of the preceding
- 3 five years prior to the year of application.
- 4 "System." The Pennsylvania State System of Higher Education.
- 5 Section 3. Board membership.
- 6 The board shall consist of the following members:
- 7 (1) Chancellor of the system or his designee, who shall
- 8 be chairperson.
- 9 (2) The Secretary of Education or his designee.
- 10 (3) The chairperson of the Education Committee of the
- 11 Senate.
- 12 (4) The minority chairperson of the Education Committee
- of the Senate.
- 14 (5) The chairperson of the Education Committee of the
- 15 House of Representatives.
- 16 (6) The minority chairperson of the Education Committee
- of the House of Representatives.
- 18 (7) Two first-generation college graduates of State
- 19 universities who reside in rural Pennsylvania.
- 20 (8) A representative of the Center for Rural
- 21 Pennsylvania.
- 22 Section 4. Authorization and purpose.
- 23 (a) Grant program. -- The system, in consultation with the
- 24 board, shall establish a program of grants to universities
- 25 within the system and rural school districts that qualify under
- 26 this act.
- 27 (b) Purpose.--Grants awarded under this act may be used for
- 28 any of the following purposes:
- 29 (1) To establish and maintain programs designed to serve
- those primary and secondary students who are college able but

- 1 may not have considered college as an option.
- 2 (2) To serve nontraditional students presently in junior
- 3 and senior high school.
- 4 (3) To implement three-way partnerships among the
- 5 universities, school districts and parents.
- 6 (4) To work with students to assure adequate preparation
- 7 for college through program scheduling in high school for
- 8 admissions and financial aid presentations, for practice
- 9 tests and for other supportive activities to help
- 10 nontraditional students prepare for college life.
- 11 (5) To provide opportunities for students to visit
- campuses and become comfortable with the college environment.
- 13 (6) To provide instruction in study skills to ensure
- 14 success in college.
- 15 (c) Guidelines.--The system, in consultation with the board,
- 16 shall establish guidelines to award grants for the purpose set
- 17 forth in subsection (b) and other purposes deemed appropriate by
- 18 the system and approved by the board.
- 19 Section 5. Applications.
- 20 (a) General rule.--A State system university or rural school
- 21 district may make application at the time, in the manner and
- 22 containing the information as required by the system. The system
- 23 shall determine from the information provided whether the
- 24 applicant is eligible for consideration by the board.
- 25 (b) Annual meeting. -- Representatives of the system shall
- 26 meet annually to award grants to qualifying rural school
- 27 districts and system universities.
- 28 (c) Other meetings.--The board shall meet at the call of the
- 29 chairperson to conduct business related to the award of grants.
- 30 Section 6. Grants awarded by department.

- 1 The department shall award grants to qualifying organizations
- 2 upon the recommendation of the board.
- 3 Section 7. Regulations.
- 4 The system shall administer this act and may, with the
- 5 approval of the board, prescribe and adopt program policy
- 6 guidelines or regulations relating to the administration and
- 7 enforcement of this act.
- 8 Section 8. Appropriation.
- 9 An annual appropriation of not less than \$500,000 shall be
- 10 appropriated to the State System of Higher Education for the
- 11 purposes of carrying out this act.
- 12 Section 9. Effective date.
- 13 This act shall take effect immediately.
