- Amending Title 53 (Municipalities Generally) of the Pennsylvania
- 2 Consolidated Statutes, further providing for administration
- 3 of the homestead property exclusion.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 8583(a) and 8584(b) of Title 53 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 8583. Exclusion for homestead property.
- 9 (a) General rule.--
- 10 (1) The governing body of a political subdivision may
- 11 exclude from taxation a fixed dollar amount of the assessed
- value of each homestead property in the political subdivision
- consistent with section 8586 (relating to limitations).
- 14 (2) Upon making a determination under paragraph (1), the
- 15 governing body shall transmit to the Department of Community

- 1 and Economic Development a notice of exclusion. The
- 2 <u>department shall transmit the notice under this paragraph to</u>
- 3 <u>the Legislative Reference Bureau for publication in the</u>
- 4 <u>Pennsylvania Bulletin.</u>

- 8 (b) Filing deadlines; renewal of application.--[Applications
- 9 shall]
- 10 (1) Except as provided in paragraph (2), applications
- 11 <u>must</u> be filed with the assessor not later than March 1 of
- 12 each year.
- 13 (2) The first time the exclusion is authorized by the
- 14 governing body, applications must be filed with the assessor
- not later than 90 days after publication of the notice under
- section 8583(a)(2) (relating to exclusion for homestead
- 17 property).
- 18 (3) The governing body of a county may adopt a schedule
- for review or reapplication for real property previously
- approved as homestead property or farmstead property.

- 22 Section 2. The amendment of 53 Pa.C.S. § 8584(b) shall apply
