## AN ACT

- Amending Titles 18 (Crimes and Offenses), 23 (Domestic Relations) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for willful failure to pay support orders.

  The General Assembly of the Commonwealth of Pennsylvania

- 13 § 4321. Failure to pay support order.
- 14 (a) Offense defined. -- An individual commits an offense if
- 15 the individual intentionally fails to comply with a support
- 16 order of a court of this Commonwealth when the individual has
- 17 the financial ability to comply with the support order.
- 18 (b) Application. -- This section applies to all support cases,

- 1 whether civil or criminal and whether the defendant is married,
- 2 unmarried, separated or divorced.
- 3 (c) Grading. -- An offense under this section constitutes a
- 4 misdemeanor of the third degree.
- 5 (d) Jurisdiction.--Jurisdiction of an action under this
- 6 section shall be in accordance with 23 Pa.C.S. § 4354(c)
- 7 (relating to willful failure to pay support order).
