## AN ACT

- Providing for reimbursements to municipalities for expenses incurred in assisting State correctional personnel in attempting to ensure the safety of residents of areas surrounding the prison and to recapture escaped prisoners; AND PROVIDING FOR AN ANNUAL AUDIT BY THE AUDITOR GENERAL.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Community
- 10 Services Responder Reimbursement Act.
- 11 Section 2. Legislative findings and declarations.
- 12 (a) Findings.--The General Assembly finds as follows:
- 13 (1) From time to time, the Commonwealth experiences
- escapes from or other disruptions at its correctional
- 15 institutions.
- 16 (2) Personnel from surrounding communities are required

- 1 to provide assistance to State correctional personnel to
- 2 ensure the safety of residents of surrounding areas and to
- 3 assist in the timely recapture of prisoners.
- 4 (3) Municipalities can no longer realistically afford or
- 5 be expected to provide assistance to State correctional
- 6 personnel at a financial loss.
- 7 (b) Declaration.--The General Assembly declares as follows:
- 8 It is imperative to establish for our municipalities a mechanism
- 9 and process whereby they can be reimbursed financially for
- 10 reasonable expenses related to responding to escapes and
- 11 attempted escapes or riots at State correctional institutions.
- 12 Section 3. Definitions.
- 13 The following words and phrases when used in this act shall
- 14 have the meanings given to them in this section unless the
- 15 context clearly indicates otherwise:
- 16 "Department." The Department of Corrections of the
- 17 Commonwealth.
- 18 "Municipal emergency services department." A police or fire
- 19 department, ambulance service or rescue squad established,
- 20 operated and funded by a municipality.
- 21 "Municipality." A county, city, borough, incorporated town
- 22 or township.
- 23 "State correctional institution." A correctional facility,
- 24 jail or prison owned or operated by the Department of
- 25 Corrections.
- 26 Section 4. Commonwealth reimbursement required.
- 27 In the event a municipal emergency services department
- 28 responds to an escape, attempted escape or riot at a State
- 29 correctional institution, the Commonwealth shall reimburse the
- 30 municipality for the full cost of personnel, equipment,

- 1 materials and other costs associated with the response.
- 2 Section 5. Reimbursement procedures.
- 3 (a) Documentation. -- Each municipality which has a municipal
- 4 services department that responds to an incident or event at a
- 5 State correctional institution shall separately document the
- 6 personnel, equipment, materials and other costs associated with
- 7 the response. The documentation shall be filed with the
- 8 department on application forms supplied by the department.
- 9 (b) Reimbursement.--The department shall reimburse the
- 10 municipality within 60 days of receipt of the municipality's
- 11 application.
- 12 (c) Disputed costs. -- In the event of a dispute between the
- 13 department and a municipality over the amount of reimbursement
- 14 applied for by a municipality, the disputed costs shall be
- 15 forwarded to the Board of Finance and Revenue for review and
- 16 decision. Decisions of the board may be appealed to the
- 17 Commonwealth Court.
- 18 SECTION 6. ANNUAL AUDIT.
- 19 NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY,

- 20 THE AUDITOR GENERAL SHALL CONDUCT AN ANNUAL AUDIT OF THE
- 21 DOCUMENTATION OF PERSONNEL, EQUIPMENT, MATERIALS AND OTHER COSTS
- 22 ASSOCIATED WITH THE RESPONSES FOR WHICH MUNICIPAL SERVICES
- 23 DEPARTMENTS SUBMIT REIMBURSEMENT REQUESTS.
- 24 Section 6 7. Retroactivity.
- 25 This act shall be retroactive to July 1, 1999.
- 26 Section 7 8. Effective date.
- 27 This act shall take effect immediately.
