## AN ACT

- Amending the act of May 17, 1929 (P.L.1798, No.591), entitled "An act providing a fixed charge, payable by the 3 Commonwealth, on lands acquired by the State and the Federal Government for forest reserves, or for the purpose of preserving and perpetuating a portion of the original forests of Pennsylvania, and preserving and maintaining the same as 7 public places and parks; and the distribution of the same for county, school, township, and road purposes in the counties, 9 school districts, and townships where such forests are located; and making an appropriation, "further providing for 10 amount of payment to counties, school districts and 11 12 townships.
- 13 The General Assembly of the Commonwealth of Pennsylvania
- 14 hereby enacts as follows:
- 15 Section 1. Section 1 of the act of May 17, 1929 (P.L.1798,
- 16 No.591), referred to as the Forest Reserves Municipal Financial
- 17 Relief Law, amended July 6, 1995 (P.L.320, No.49), is amended to
- 18 read:
- 19 Section 1. Be it enacted, &c., That (a) from and after the
- 20 passage of this act, all lands heretofore or hereafter acquired

- 1 by the Commonwealth, or by the Government of the United States,
- 2 for forest reserves or for the purpose of preserving and
- 3 perpetuating any portion of the original forests of Pennsylvania
- 4 and preserving and maintaining the same as public places and
- 5 parks, and which, by existing laws, are now exempt from
- 6 taxation, and all lands and property heretofore or hereafter
- 7 acquired for the purpose of conservation of water, or to prevent
- 8 flood conditions, upon which a tax is imposed by existing laws
- 9 payable by the Commonwealth, shall hereafter be subject to an
- 10 annual charge of [forty] eighty cents per acre, for the benefit
- 11 of the county in which said lands are located, [forty] eighty
- 12 cents per acre for the benefit of the schools in the respective
- 13 school districts in which such lands are located, and [forty]
- 14 eighty cents per acre for the benefit of the township where such
- 15 lands are located, which charge shall be payable by the
- 16 Commonwealth. (b) Except as hereinafter provided, the annual
- 17 charge payable by the Commonwealth on land acquired by the
- 18 Government of the United States for forest reserves is to
- 19 continue only until the receipts of money by treasurers and
- 20 township supervisors of the said counties and school districts
- 21 and townships in which national forest reserves are located,
- 22 provided for in act of April twenty-seventh, one thousand nine
- 23 hundred twenty-five, Pamphlet Laws, three hundred twenty-four,
- 24 shall equal or exceed the amount paid by the Commonwealth in
- 25 lieu of taxes. This subsection shall not apply to the annual
- 26 charge per acre for the benefit of the county in which the land
- 27 acquired by the Government of the United States for forest
- 28 reserves is located for the years one thousand nine hundred
- 29 fifty-three, one thousand nine hundred fifty-four, one thousand
- 30 nine hundred fifty-five, one thousand nine hundred fifty-six,

- 1 and this subsection shall not apply to two and one-half cents of
- 2 the annual charge per acre for the benefit of the county in
- 3 which the land acquired by the Government of the United States
- 4 for forest reserves is located for any year thereafter. The
- 5 charges for the benefit of the county for these years shall be
- 6 paid by the Commonwealth. All charges payable by the
- 7 Commonwealth under the provisions of this act shall be paid on
- 8 or before the first day of September of each year.
- 9 Section 2. This act shall take effect in 60 days.
