## A RESOLUTION

- 1 Recognizing the naming of the Thomas Detre Hall at the
- 2 University of Pittsburgh.
- 3 WHEREAS, In November 1998, Dr. Thomas Detre ended his service
- 4 as Senior Vice Chancellor for Health Sciences of the University
- 5 of Pittsburgh, having served the university with distinction in
- 6 leadership positions for 25 years; and
- 7 WHEREAS, Dr. Detre left his imprint on the university's
- 8 Health Sciences Schools, the Western Psychiatric Institute and
- 9 Clinic and the medical community in Pittsburgh and southwestern
- 10 Pennsylvania; and
- 11 WHEREAS, Dr. Detre's tenure was instrumental in the growth
- 12 and development of the university as one of the nation's
- 13 foremost leaders in academic medicine, research and teaching;
- 14 and

- 1 WHEREAS, Much of the growth and expansion in the health
- 2 sciences at the university came under his administration; and
- 3 WHEREAS, During his long and dedicated service, the
- 4 university and its medical partners gained national and
- 5 international prominence; and
- 6 WHEREAS, Chairperson J.W. Connolly and Chancellor Mark A.
- 7 Nordenberg, in recognition of Dr. Detre's service to the
- 8 university, have recommended that the building housing most of
- 9 the programs of the Western Psychiatric Institute and Clinic be
- 10 named for Dr. Detre; and
- 11 WHEREAS, It has been deemed appropriate that an exception be
- 12 made to general university policy against naming buildings for
- 13 living persons in order to honor Dr. Thomas Detre; therefore be
- 14 it

- 16 naming of the Thomas Detre Hall of the University of Pittsburgh.
